Children for whom we receive Pupil Premium for are referred to as 'disadvantaged' by the government and this funding is provided to close the achievement gap between this group and other children. At Abbey Wood Nursery School, we work hard to ensure that no children are 'left behind' because of their home circumstances. The Government allows us to decide how we spend the money. This means that we are able to target it where we feel it will make the most difference.

The Pupil Premium allocation is derived from a snap shot of pupils listed in the January census. However, the payment is for the forthcoming financial year April-March and so covers the children on the census and those who join the school at Easter and September (although these children are not contributing, at this time, to the funding). Then school is given £100 per term for each pupil which can be up to £300 a year for children who remain with the school.

We allocated the funding to support the following areas:

- Contribution to the cost of a Social Communication Worker.
- Interactive Music Making targeted intervention.
- Investing in a new tracking system so that we can ensure children are appropriately targeted.
- Contribution towards training for a 'Forest School' leader.

The figures can never be accurately projected as children who are two when they start with us are not entitled to the EYPP, however as they turn 3 the following term if their circumstances warrant it then we will revive the funding for them. However it must be remembered that circumstances change and unlike when children go to Primary school and if they have ever received Pupil Premium then they will continue to receive it for the following 6 years. In the early years eligibility is based on the January census this means that there may be changes each year.
