1. Update on Biomass Boilers

Visit to see Biomass boilers last week. It is noteworthy that one of a pair was broken at this time.

Have talked further with Solinium;

- Asked if we could buy rather than rent boilers but we have to have a lease arrangement.
- Similar maintenance cost to our current situation
- They are looking at costings for 2 smaller boilers rather than 1 bigger one.
- Estimate pellets would be delivered every 3-4 weeks

It was agreed:

- We need firm quotes from Solinium
- Will also follow up with Salix for their costings which have no interest added (IB)
- Consider 3rd option of biomass with Bouygues.

PE will arrange a meeting with Ron De Souza next week.

Governors asked if there will be a cost to this? Don't know

As this is a LA backed scheme there will be a significant reduction of risk for Highfield.

Bring to FGB on 22 March.

Water tanks are corroding - CPS are going to quote

Water pressure issues & some lack of hot water is down to the boiler problems. Staff had raised some concerns with hygiene as a H&S issue.
