Dear Parents and Carers,

As you may be aware, Relationship and Sex Education (RSE) and Health Education became a compulsory part of the National Curriculum from September 2020. All students are currently taught Personal, Social, Health and Economic (PSHE) within their regular timetable, which aims to promote personal wellbeing and development and equip them with the knowledge, understanding and skills to live healthy, safe, and successful lives, both now and in the future. We are offering all students in Year 12 discrete sex education sessions, delivered by our specialist provider Talk the Talk. These will take place on Tuesdays starting, Tuesday 17th September, in small, friendship groups outside of the regular timetable. Each student will attend a 2 hour session throughout the term along with a small group of their peers, they will then have the opportunity to attend drop in sessions if they have a specific wish to do so. Sessions for Year 12 students will build on the content around body image, puberty and sexual health previously delivered in KS3 and 4, and also explore in more depth sexual health and wellbeing, sexual relationships, alongside sex and the law. All of this content is underpinned with the golden thread of building self-esteem, confidence and resilience.

This year we will also be discussing the C-Card Scheme, which allows access for sexual health advice, support and guidance, they can also access free contraception from youth organisations, pharmacies, GP and our Talk the Talk expert. During the sessions, pupils will be able to ask questions, which will be answered factually and in an age-appropriate manner. Each pupil's privacy will be respected, and no one will be asked to reveal personal information. We have worked in partnership with Talk the Talk for a number of years, and the support, advice and guidance they offer our students is outstanding. The small group sessions are age-appropriate, and our Talk the Talk provider establishes an excellent rapport with our young people, ensuring a safe and comfortable environment for all students to learn.

As parents and carers, you maintain the right to withdraw your child from the sex education sessions, although as a school we would advise that it is important education for the personal development of young people. We believe that the presentation of sexual images in social and other media make it important that all young people have a place to discuss pressures, check facts and dispel myths. Even if a child is withdrawn, many pupils will discuss such issues with each other outside of the classroom - so, rather than hear about the content second-hand, we hope all young people will have the opportunity to take part in these sessions.
