## **Provision Policy**

#### **Commitment to AGT**

At Armfield Academy we recognise that our Able, Gifted and Talented students need access to broad, balanced and challenging curriculum opportunities to enable them to reach their true potential. We achieve this by offering a curriculum and activities that extend and enrich their learning and promote high aspirations, attainment and good progress. Opportunities offered by the Trust's sponsor, Blackpool 6th Form College, will be utilised to help further raise aspirations and meet the needs of our most able and talented students.

### Supporting our students

To support our Able, Gifted and Talents (AGT) students:

#### Identification of Able, Gifted and Talented students

We will analyse results throughout school to identify able students. We will also ask subject teachers to identify Gifted and Talented students and nominate them to be registered. Teachers nominate students as Gifted or Talented in individual subjects. The G&T register specifically indicates the curriculum area in which the student has been identified as having strengths. Subject teachers and tutors are informed so that progress can be monitored closely.

#### Monitoring

We complete many layers of monitoring across the academy. Faculty and Phase Reviews inform many aspects of provision and future planning. The Able, Gifted & Talented Action Plan will be created and subsequently reviewed and updated regularly by the senior leaders at the school. The Academy Improvement Plan includes A, G&T provision.

#### **Targets to Improve**

All students have targets that are shared with them that they need in order to improve. These are set and reviewed regularly. Underachievement is identified and support put into place.

#### **Staff Training**

Staff awareness and understanding of A,G&T is developed through the staff CPD, alongside whole school INSET Day training when appropriate. A, G&T is a part of the induction process into the school.

#### **Extra Curricular Activities**

We will offer a range of extra curricular activities that enrich the curriculum for our A, G&T students. Provision is focussed on raising aspirations beyond compulsory education. We monitor the ambitions of our students in order to target the activities offered and ensure they get involved with appropriate activities.
