#### GBM 65/22 Welcome

Mr Service welcomed governors and Mr Thompson to the virtual board meeting, which was being held to receive the audited accounts from Mr Thompson.

The meeting was quorate with 13 governors present.

#### GBM 68/22 To receive the audited accounts from Ian Thompson of Saint & Co Auditors

The draft report has been shared with governors prior to the meeting.

The figures remain the same as issued with no changes.

The tangible assets are the land and buildings approximately £2,000,000

The long-term liabilities are the pensions for all teaching and non-teaching staff.

The net current assets were 57k and have reduced to 47k.

The bank balance still has outgoings, which is an acceptable position to be in.

GAG funding has increased this year. Expenditure of £792,000 leaves a deficit of £55,000 Depreciation = £39,000 Costs in pension scheme = £5,000 Cash deficit = £11,000

Over the long term the only concern would be if the deficit continues to increase. School can pay bills and are able to do so for the next 12 months. The 3-year budget indicates that school remains viable and is in a strong position as a standalone academy. With the current asset's vs current liabilities, school have £50,000 to carry forward.

The auditor stated that school will be able to continue operating for the foreseeable future.

#### GBM 69/22 To receive the management report

The management report demonstrates regularity and probity of school, with the report sent to the ESFA. There are no high points, all are low with one medium point highlighted.

# 1) Related Party Disclosure Forms (Medium point)

All governors have completed the Related Party Forms and where appropriate staff members have disclosed their employment with the academy. However, there was no disclosure relating to the employment status of other governors stating for whom they work. It is therefore difficult to confirm from these whether any related party transactions have occurred.

# Action point:

Ensure that the auditors related party forms include details of employment/self-employment for all governors both working and retired.

#### 2) Accounting Officer File (Low point)

The EFSA's Accounts Direction states an accounting officer file should be kept. The retention of a working papers file would also assist the academy trust if there was a change in the accounting officer during a reporting period.

#### Action point:

A file will be kept with a checklist at the front confirming completed monthly by the headteacher.

#### 3) Lunch Shop Proceeds (Low point)

The proceeds from Lunch Shop were not correctly allocated for one month between catering, Arnies and breakfast Club.

#### Action point:

Ensure Lunch shop proceeds are correctly allocated every month.
