Dear Parent/Carer,

The NHS School Vaccination Service have confirmed that they have scheduled to attend our school on Tuesday 8th February 2022, to offer students aged 12-15 the second dose of the Covid-19 vaccination or the first if your child missed out or was ineligible last time.

Consent to receive the vaccine is completely optional and parents and students should take time to read the information leaflets below to assist in making their decision:

- <u>Covid-19 Vaccination Guidance for Parents</u>

Please ensure that you complete the form in full, indicating your and your child's decision and submit it **before 12 noon on Friday 4th February 2022**.

Covid-19 Vaccination Consent Form

For those students / parents who are unable to access the online consent form spare paper copies of the consent forms are available for collection from Room 7. If completing the paper consent form, it should be handed into Miss Richards via Room 7 by your child.

The consent forms will be collected from the school by the NHS School's Vaccination Service on Friday lunchtime and they will process these forms.

Only students who have provided parental consent will be given their vaccination on Tuesday 8th February 2022.

Vaccinations will take place in the Sports Hall during the school day and they will be administered and delivered by the NHS School Vaccination Service staff. Following vaccination, after a 15 minute wait in the waiting area, students will be able to continue with their day as normal. On the day of the vaccination, students who are taking part will need to allow access to their upper arm. They should therefore either wear a short sleeve shirt or a t-shirt under their school shirt/blouse, so that their shirt/blouse can be removed whilst they have their injection.
