Overview

It should be read in conjunction with the Risk Assessments dated 4 September 2020 and 22 January 2021 and 2 March 2021. All control measures set out therein will continue.

All staff and students will continue to follow the system of controls which include continuing to observe good hand and respiratory hygiene including wearing face-mask in corridors, communal areas and classrooms; minimising contact between individuals and maintaining social distancing whenever possible ('Hands, Face, Space'), Anyone with symptoms (even if they recently had a negative LFD test result) should still self-isolate immediately according to government guidelines. Those with symptoms are also expected to visit a test site to take a lab-based polymerase chain reaction (PCR) test to check if they have the virus.

Coronavirus Asymptomatic Testing Programme

The College has distributed LFDs to all staff and students who administer these tests at home twice weekly in line with government guidance: https://www.gov.uk/government/publications/coronavirus-covid-19-asymptomatic-testing-in-schools-and-colleges The College will continue to maintain an in-house testing programme for any visitors on site or to support staff or students who need an on-site test for any reason.

All staff and students attending College in the Summer Term will continue to abide by all measures set out in this Risk Assessment and those of September 2020, January 2021 and March 2021

The College has cancelled the proposed Open House Event on 24 June 2021 in line with Government Guidance.

The College will run the Registration Days on 28th, 29th and 30th June 2021 under carefully controlled and fully Covid-compliant restrictions.

The Risk Assessment is a 'living document' that is kept under continual review with a hierarchy of controls to reduce the risk of coronavirus to the lowest reasonably practicable level.

Social Distancing	 Social distancing will be facilitated by reducing mixing within the College by: Corridors Corridor traffic will operate on a way one system wherever possible. Signage will remind staff and students about 2m social distancing. Signage will direct that toilets do not become crowded by limiting the number of students who use the toilet facilities at one time. Classrooms for Registration Days will be re-arranged so that desks are laid out to allow at least a 2m distance between each student (measured from where they are seated) and the location of staff desk. Chairs/desks surplus to requirements to be removed where possible to assist social distancing and reduce physical touch points. 	All staff
