Dear Parent / Carer

You will undoubtedly be shocked to read the judgement from our Ofsted on 10th / 11th May 2016. Please be aware that this is due to a single issue which we were able to address immediately.

The result, however, has been to put us in Special Measures. We are now working tirelessly to have this lifted as soon as possible.

For your information, Day 1 of the Inspection was called a Section 8. It had two Inspectors. The day went exceptionally well. At the end of this inspection, because there was evidence that suggested that the school was outstanding, the Inspection was turned into a Section 5. This meant that seven Inspectors, and a Senior HMI observing the Inspectors, would return the next day.

Day Two went exceptionally well. At 1:55pm with five minutes to the conclusion of the inspection, I felt that we had a real chance of Outstanding. It was at that point, however, that the Lead Inspector came to discuss the issue of Sixth Formers not signing in and out during the day. This has been our practice for the last twenty years, it was not considered acceptable by Ofsted - although it was not identified as a concern in our 2015 Safeguarding Ofsted Inspection. As a consequence we were put in Special Measures.

Our response has been to address their concerns and we are in the process of inviting Ofsted back to re-inspect in the expectation that Special Measures will be lifted.

I would like to offer Parents / Carers the opportunity to attend meetings to clarify the situation.
