The Role

- As a classroom teacher, to provide outstanding teaching and learning opportunities to allow our students to achieve the highest academic standards.
- To design an engaging and challenging curriculum that inspires our students to develop a love for the subject and its wider application.

Key responsibilities

- To plan, resource and deliver lessons and sequences of lessons to the highest standard that ensure real learning takes place and students make progress
- To provide a nurturing classroom environment that helps our students to develop as learners
- To help to establish and maintain effective behaviours for learning in the classroom
- To contribute to the effective working of our school.

Teaching and Learning responsibilities

- Use regular assessment to monitor student progress and establish appropriate interventions when necessary
- To produce and contribute towards assessments and reports relating to individual students
- Maintain regular and productive communication with students, parents and carers
- Where relevant direct and supervise support staff assigned to lessons, e.g. Teaching Assistants

Welcome

I would like to thank you for your interest in applying for the above post. You now have the opportunity to join a thriving and very successful Social Science Department built upon relationships of mutual respect between students and staff alike. Having had the chance to read our recruitment pack and find out a little bit more about our school and our department, I very much look forward to receiving your application.

Staffing

The Social Science Department is made up of the A level subjects Law, Sociology and Psychology. It consists of a team of 3 specialist and extremely supportive colleagues.

Social Sciences at Bishop Challoner

A level Law is an extremely popular subject in the 6th form at Bishop Challoner. In September 2021 we will have 2 A level Law classes in Year 13 and 2 A level Law classes in Year 12. A level Law is taught in a spacious classroom with an interactive whiteboard and access to ICT facilities.

From September 2022 we are looking at the feasibility of introducing a BTEC in Applied Law and an A level in Government and Politics. Although not an essential requirement of this role, an ability to support this planned provision would be welcome.

In September 2021 we will also have 2 A level Psychology classes in Year 13 and 2 A level Psychology classes in Year 12. As with A level Law, Psychology is taught in a spacious classroom with an interactive whiteboard and access to ICT facilities. We also have one A level Sociology class in Year 13 and one A level Sociology class in Year 13

Results

A level results in Law have been consistently high year on year with a 100% success rate in 2017, 2018 and 2019. In 2019 over 60% of our students achieved grades A* - C

Aims, Philosophy and Ethos

At the core of our A level teaching is the drive to inspire, motivate and support students in their learning and also to inspire an understanding of the wider applications of their subject. We believe that through an engaging curriculum we can encourage our students to reflect on the world in a meaningful and critical way and increase their cultural capital through the exploration of their learning.

Throughout the major curriculum reforms of GCSE's and A-levels, this philosophy has been central to our ethos. Despite our successes, the Department is always reflecting on practice and looking at opportunities to improve the experience of our students.

Through this philosophy, we will aim to:

- Ensure that teaching and learning in Law lessons is of a high quality and meets the needs of our students
- Provide high challenge and expectations for all abilities and allow students opportunities to celebrate their success and recognise individual achievement.
- Instil a life-long love of the law and develop resilience when faced with challenging legal scenarios.

• Give students the opportunity to experience the workings of the Law Courts and how the judicial process operates in the UK.

• Develop and refine our students' use of the correct application of legal terminology

• Ensure that the study of A level Law provides our students with opportunities for personal growth, developing moral and social awareness.

• Contribute fully to the life and work of the School.

• Enhance students' creativity and enjoyment of the subject

• Where possible provide enrichment activities, e.g. debating, inviting into school legal professionals and visiting the Law Courts

• Utilise the latest pedagogical research, in order to inform teaching strategies and lesson design.

At Key Stage 5 we follow the OCR A level Law specification.
