## AIMS

To provide a curriculum which:

- Promotes fullness of life. •
- Is enriched by our understanding of Christianity. •
- Has dignity, hope and aspiration at its core. •
- Reflects the Christian ethos of the school. •
- Is relevant and appropriate that both engages and motivates students. •
- Offers breadth, balance, coherence, relevance, differentiation and progression. •

### **Principles of curriculum delivery**

- It will meet the statutory requirements for the curriculum of children of school age. •
- The time allocated to subjects meets the statutory requirements and is designed to allow all • students to meet their potential.
- The placing of students in sets at KS3 and KS4 takes place where it is deemed appropriate. ٠
- Sufficient resources are provided to ensure challenge and engagement. •
- All students will study the core subjects of Maths, Science and English at KS4. •
- All students will have entitlement to study a Modern Foreign Language and Humanities subject at • Key Stage 4 as part of our commitment to the English Baccalaureate.
- All students will study Religious Education at KS3 and KS4. Aspects of Religious Education will also ٠ be delivered through school assemblies.
- The option process aims to offer students a wide range of subject choices. A tailored pathways • system ensures that students follow an appropriate quantity and range of subjects. The school will endeavour to meet the requests of all students; however, at times this may not be feasible, due to constraints of the timetable.
- There will be a programme of extra-curricular activities which extend and complement the • curriculum.
- There will be a programme of careers education at KS4.
- At KS3 and KS4 students will also follow a programme of Personal and Social and Health Education. ٠
