#### Amnesty International - TikTok Study

Now and again I'm asked whether these types of report are relevant to Primary schools and the answer is yes, definitely. Don't forget, to use most social platforms you have to state that you are 13 or older. Even if you're a Year 4 aged child, to that platform you are at least 13 years of age.

There have been countless concerns over recent years in relation to algorithms and the type of content that is fed to children and young people across the various platforms they use. This latest study from Amnesty International delves deeply into the very significant concerns around the algorithms used within TikTok specifically in relation to self-harm, where children who signal an interest into mental health are quickly led down rabbit holes of some very disturbing content which can heighten risk, exacerbate an existing vulnerability or act as a trigger. Quote - When you 'heart' a sad video that you could relate to, suddenly my whole 'For You' page is sad and I'm in a sadtok. It affects how I'm feeling - unquote.

The report is quite big but you will find a lot of useful information in the executive summary which can also be used to help with conversation starters with students. The full report is **HERE** and there is an accompanying report about the massive amount of personal/private information collected by TikTok called 'I feel Exposed' **HERE**.

#### **Resource for 9-13 Year Olds - Tell Someone You Trust**

This is a short, animated video which was released at the end of 2015 in 21 languages to inform children aged 9-13 about sexual violence committed in the circle of trust and how to speak against it. Although the resource isn't specifically online safety, it can be used as part of a wider talk with children including online aspects. You can find the video in all 21 languages HERE.

#### WhatsApp - Locked Chats

Did you know that you can hide conversations and lock them away in WhatsApp? This was a feature introduced in May 2023 and was easy to spot (if you knew how), but WhatsApp have updated the feature which makes it much more difficult to find.

In the original update you had to swipe down in the 'Chats' window to see locked chats, then input a code, fingerprint or Face ID to unlock (see **THIS** 1 minute video on YouTube). However, this meant that other people (parents, teachers, partners) would be able to see that you have got locked chats, even if you can't see the content. WhatsApp have just updated this (being rolled out worldwide from the beginning of December) and

locked chats can now only be viewed by entering a secret code into the search bar, meaning that you will not be able to tell if there are any locked chats without knowing the code which WhatsApp briefly explains HERE.

## For Parents - Why do Children use Anonymous Apps?

Note: the article refers to Omegle which no longer exists but it explores the wider use of anonymous apps. Also, the article refers to teens. In my experience many younger children use anonymous apps.

#### **Online Safety Subscription Service**

## **Online Safety Training (staff, parents and students)**

As well as physical in-school training (staff, students, parents) and virtual (Zoom/Teams) I also offer costeffective pre-recorded video training as follows (each purchase includes a 12 month licence to use as many times as you wish within your setting):

#### **STAFF**

There is a primary version plus a secondary/college version, the most recent videos were updated and rerecorded at the end of August 2023 to make sure they're right up to date. They take staff through the risk basics (content, contact, conduct and commerce), the spaces that children occupy online (games, YouTube and social media) plus the latest risks and issues with supporting advice and guidance. The video can be streamed or downloaded to the school network.

## PARENTS
