## Daily Coronavirus Update

I would like to thank you for your understanding and patience over the last week. These are extremely uncertain times that collectively we are going through. I am sorry that, at times, I have not been able to provide more information to some of the many questions which you have had and some still have, simply because the information is not yet available. Please rest assured that I will update all parents and carers as regularly and as quickly as possible when new information and its impact on our community and your children is available.

Overnight new information has been published by the government on which pupils are able to access school. This guidance sets out the expectations of parents/carers and schools. Links to this information are [here](#) and on our website. The guidance states that "**...the government has asked parents to keep their children at home, wherever possible, and asked schools to remain open only for those children who absolutely need to attend.**"

The key principles stated in the guidance are:

1. If it is at all possible for children to be at home, then they should be.
2. If a child needs specialist support, is vulnerable or has a parent who is a critical worker, then educational provision will be available for them.
3. Parents should not rely for childcare upon those who are advised to be in the stringent social distancing category such as grandparents, friends, or family members with underlying conditions.
4. Parents should also do everything they can to ensure children are not mixing socially in a way which can continue to spread the virus. They should observe the same social distancing principles as adults.

Please check the definitive list of **critical workers** as published on the government website and complete the survey on our school website if you feel you fit into any of the categories and require childcare. We will contact those to look at eligibility.

**Vulnerable children** are defined as "children who are supported by social care, those with safeguarding and welfare needs, including child in need plans, on child protection plans, 'looked after' children, young carers, disabled children and those with education, health and care (EHC) plans." We **expect** to see pupils who fit into this category and will continue to communicate with all parents/carers to ensure that these children are looked after. We have already had detailed discussions yesterday with some parents/carers of **vulnerable students**. Those parents/carers **do not need** to contact us again unless you wish to change your mind about accessing our provision.

For pupils who are **in receipt of a free school meal**, we have purchased vouchers. **These have been posted out today to the relevant families.** Current advice from the government is that they are
