Parent Update - Rapid Asymptomatic Testing Programme

Following our recent letter and online updates, we are delighted to let you know that the testing process that took place on Monday 8th March was smooth and efficient and as ever, our students were first class.

We were able to test 99% of students on Monday which meant that the full reopening of school on Tuesday was calm and focused. Thank you for all of your support to help us make this happen.

The school will be supporting students to self-administer **three** Lateral Flow Device (LFD) tests over the two weeks commencing 8th March. This is in order for them to be trained on how to carry out these tests so that they can successfully self-administer at home after this period. With the first LFD test now completed, we have been preparing the schedule for the second and third tests that are due to take place over the following school days this week and next:

The process will involve individual classes leaving their lesson for around fifteen minutes to visit the test centre and complete their LFD test. Students will be supervised at all times and will return to their lesson following completion of the test. Students and their parents will be informed if there is a positive test result.
