Why are we here?

- By working together we can identify when a situation may be dangerous or cause us harm.
- Sign Post – knowing who to turn to or talk to if something goes wrong.

What is **SEXTING** ?

- Sexting is when people send and or receive indecent pictures via social media.
- The pictures do not always have to be of naked shots.
- They can also be rude text messages or videos.

GPMS MARKING

Step 1

Sarah, 14, allows her boyfriend James, 15, to take pictures of her in just her underwear.

James is guilty of **making** indecent images of a child, and also possessing indecent images of a child.

GPMS MARKING

Step 2

Sarah, 14, takes a picture of herself naked on her camera phone and sends it to her boyfriend James, 15.

*Sarah has committed the offence of **making** and **distributing** indecent images of a child.*

*James is committing the offence of **possession** of indecent images of a child.*

GPMS MARKING

Step 3

Sarah dumps James. Out of revenge James sends the pictures to his friends at school.

*James is now guilty of **distributing** indecent images, his friends are guilty of **possession**.*

Step 4

James's friend Paul uploads the image to a social networking site where images are visible to the public.

*Paul is in breach of the websites terms and conditions and guilty of **distributing** indecent images of a child.*

Consequences

If found guilty of the offence, not only will you go on the sex offenders register but you may also receive

- Prison sentence
- Community Service
- Sexual harm prevention order



Child Sexual Exploitation Definition

It occurs where an individual or group takes advantage of an imbalance of power to coerce, manipulate or deceive a child or young person into sexual activity:

- (a) in exchange for something the victim needs or wants

And/or


- for the financial advantage or increased status of the perpetrator or facilitator
- **The victim may have been sexually exploited even if the sexual activity appears consensual**
- **Child sexual exploitation does not always involve physical contact; it can also occur through the use of technology**
- **The age is up to 18 years old**

Victims

- They have no idea that they are a victim
- They think that they are having the time of their life initially
- They will hate you for interfering
- They will change in so many ways, their dress, their attitude, their personality, their opinions.

Signs & Symptoms

- going missing for periods of time or regularly returning home late
- regularly missing school or not taking part in education
- appearing with unexplained gifts or new possessions
- associating with other young people involved in exploitation
- having older boyfriends or girlfriends
- suffering from sexually transmitted infections
- being taken to clubs and hotels by adults and engaging in sexual activity
- mood swings or changes in emotional wellbeing
- drug and alcohol misuse
- displaying inappropriate sexualised behaviour
- volatile criminal behaviour
- Multiple miscarriages or terminations
- child under 16 meeting different adults and exchanging or selling sexual activity
- receiving rewards of money or goods for recruiting peers into CSE or just introducing peers to known adults
