Burtonwood Community Primary School: Pupil premium strategy statement 2020-21

Pupil Premium (PP) funding is money allocated by the government to schools, and is based on the number of children who are:

- eligible for free school meals (FSM) or who have been eligible in the past 6 years,
- in service families
- in care, or have previously been in care and are now adopted.

Nationally, pupils in these categories have not achieved as well as those not in them; Pupil Premium funding is intended to narrow and close this attainment gap. At Burtonwood CP School, we are committed to raising the attainment of pupils who are eligible for PP funding and we recognise that many of these pupils will need to make accelerated progress compared to non-eligible pupils.

Schools are able to determine how best to use the Pupil Premium grant to support and raise educational attainment and, at Burtonwood CP, we build an overall package of support and additional measures aimed to tackle a range of barriers to attainment, as detailed in this plan.

Schools are held accountable for how they have used the additional income to support children from low income families. This information must be published on the school website. Please see below for information regarding how the PP funding was spent in the last financial year, the impact of this funding and the plans for future spending.
