The Pupil Premium Grant is used to support all the above activities, however, the funding does not cover all the costs. They are not solely aimed at pupils eligible for PPG funding as many of our pupils have additional needs, but they are given priority. All actions above are priority needs of the school and are important in ensuring that pupils eligible for pupil PPG funding are given as much opportunity as possible to 'close the gap' relative to their peers.
