Year 3 Tattenhall Residential Visit November 2024

Dear Parent/Carer,

We are excited to confirm details of the year 3 residential visit to the Tattenhall activity centre in Chester. Where possible, we are trying to align residential visits so that the whole year group can attend, however this can depend on numbers of pupils who wish to take part as different centres have different maximum numbers they can accommodate. We have been able to secure a date at Tattenhall activity centre in Delamere for Monday 4th November 2024. The children would stay for one night and leave school in the morning after registration and return the following day for the end of the school. The cost of this trip is estimated to be **£115** which includes transport, insurance, food, drinks, snacks and all activities, including on site activities such as jungle camp, indoor art and team building exercises as well as a visit to the ice-cream farm. We will be able to confirm exact costs when we have a precise number of pupils but do not anticipate the cost being greater than this. Please note that due to variable pricing for residential centres throughout the year, this cost is based on a November visit for the year group. If this date is not viable due to number of pupils interested, we will contact parents with an alternative. At this point, if your child is unable to attend for any reason, we would be able to refund the deposit pad.

The cost of the trip can be paid in instalments and must be paid online via Parentmail (We are a cashless school, however if you have any issues paying online, please contact the school office to discuss alternative arrangements). If you would like your child to attend, please complete the permission slip and pay a non-refundable deposit of £10.00 by Wednesday 17th July 2024. **Please note both of these are required to secure a place. The school cannot accept late slips or deposits after this date – sadly this is without exception.** By returning the slip and deposit, you are committing to accepting a place for your child and making full payment by **Friday 1st November 2024**. This residential is classed as an optional extra, part of which is outside of school hours; therefore, school will require full payment for this trip.

Parent consent for a visit must be received in school before the deadline for any educational visits and residentials. **For the purposes of effective planning, any late submissions cannot be considered after the deadline stated.**
