



## **Martha – The School Dog (Information and risk assessment)**

### **Introduction:**

Current research is suggesting that a 'companion' animal in school can make a difference to the well-being of both staff and pupils. With this in mind, Chew Stoke Church School has become the daytime home for Martha, a golden doodle dog.

In order for Martha to be successfully and safely integrated into the life of the school, a risk assessment has been undertaken and is outlined below. The safety of children and Martha are paramount. We must also ensure that a dog in school can have as natural a life as possible while in the school building.

The following precautions have been undertaken:

1. Research into the most appropriate breed indicates that golden doodles are well suited to working and playing with children.
2. Visits were undertaken to the puppy's home to see how she interacted with the children and family there.
3. The dog is regularly groomed and checked for any infections or illnesses.
4. Visits to the vet take place regularly and she has and will continue to have all necessary inoculations.
5. Martha is wormed regularly.
6. Martha's claws are trimmed to reduce the risk of scratching.
7. She has plenty of exercise. She is exercised before working with children.

Martha has undertaken puppy training classes run by Eye – 2 - Eye training company. Work is also being undertaken to ensure that children know how to approach dogs and how to behave when dogs are around.

Martha lives with Mr Hewett when not at school and he will ensure that Martha is healthy and fit to be in school at all times. She is registered with a vet in Yatton and is up to date (and will be kept up to date) with worming and immunisations.

We appreciate that not all families and children are comfortable with dogs and will respect parental wishes for any child not to come into direct contact with Martha. Please notify the office if this is the case.

Martha will be on a lead when with children except in controlled supervised circumstances. She will not be allowed to toilet anywhere on the playground area and any 'mess' will be cleaned up and safely disposed of.
