- 2.8 Fulfil our role as an ambassadorial school by disseminating good practice as well as mentoring and supporting local partner schools with their International School Award activities.
- 2.9 Understanding how we relate to the environment and to each other as human beings.
- 2.10 Making use of every opportunity for our students to travel and meet people from varied backgrounds and cultures.
- 2.11 Teaching students to face challenges of today, to explore, develop and express their concern towards the problems of other countries; challenging stereotypes and becoming well-rounded global citizens.
