

## SINGLE EQUALITIES POLICY AND ACTION PLAN

#### STATEMENT OF PRINCIPLES

The policy outlines the commitment of the staff, pupils and governors of **Coupe Green Primary School** to ensure that equality of opportunity is available to all members of the school community. For our school this means not simply treating everybody the same but understanding and tackling the different barriers which could lead to unequal outcomes for different groups of pupils in school, whilst celebrating and valuing the achievements and strengths of all members of the school community. These include:

- Pupils
- Staff
- Parents, carers
- The Governing Body
- Multi-agency staff linked to the school
- Visitors to the school
- Students on placement

We believe that equality at our school should permeate all aspects of school life and is the responsibility of every member of the school and wider community. Every member of the school community should feel safe, secure, valued and of equal worth.

At **Coupe Green Primary School**, equality is a key principle for treating all people fairly and creating a society in which everyone has the opportunity to fulfil their potential-irrespective of their gender, ethnicity, disability, religion or belief, sexual orientation, age or any other recognised area of discrimination.

Pupils at **Coupe Green Primary School** feel that they are valued members of the school, they feel safe in and around school and feel that adults treat them fairly (pupil attitude questionnaire)

Parents feel that they are well informed by good communication and that all children are treated as individuals. Parents also feel that all whom enter the school are made to feel welcome. (Lancashire Parents questionnaire)

Ofsted states Parents and pupils alike express great confidence in the school's ability to make sure that the school remains a place of safety and high quality care."

#### **SCHOOL IN CONTEXT**

Currently we have 151 students in our school for children aged 3 -11. 84 of those are boys and 66 are girls. There is one child with an Educational Health Care Plan. There 5 children diagnosed with ASD. 15 children in school have SEND Support Plans for learning needs. We currently have 4 students with a different ethnic group other than White British. (Any other Asian background, white and black African and white/black Caribbean). The school has no looked after/in care students.

We have 21 staff members (11.7% male/88.3% female). Currently all staff at the school are in the same ethnic group (white-British).

Our school is all on one level and has facilities for both pupils and visitors who have a physical disability to access toilets. Main entrances and exits are wheelchair accessible.

We have 11 Governors. (45.5% are male and 54.5% female.)

The PTA has 9 core members, 1 man and 8 women, and a large number of supporters.

## **ETHOS AND ATMOSPHERE**

Coupe Green is predominantly a white British area with few people from ethnic backgrounds. School works hard to address this issue to ensure that our pupils are able to value and understand people from a wide range of backgrounds. We visit other groups from more varied ethnic areas in the county and reflect on visits made by staff to other areas of the world in our assemblies.

- At Coupe Green Primary School, the leadership of the school community will demonstrate mutual respect between all members of the school community.
- There is an openness of atmosphere which welcomes everyone to the school.
- All within the school community will challenge any type of discriminatory and/or bullying behaviour,
   e.g. through unwanted attentions (verbal or physical) and unwelcome or offensive remarks or suggestions.
- All pupils are encouraged to greet visitors to the school with friendliness and respect.
- The displays around the school are of high quality and reflect diversity across all aspects of equality
  of opportunity and are frequently monitored.
- Provision is made to cater for the spiritual needs of all the children through planning of assemblies, classroom based and externally based activities.
- Celebrate and learn about festivals from other faiths and cultures.

Coupe Green Primary School is an inclusive school, working towards greater equality in the whole school community. We use the curriculum and teaching to enhance the self-esteem of all those it serves and to provide a learning environment in which each individual is encouraged to fulfil his or her potential. We also have Nurture provision to work with staff and pupils who need to develop their self-esteem.

#### **POLICY DEVELOPMENT**

This policy applies to the whole school community. It has been drawn up as a result of the outcomes of a transparent process and through consultation with:

- Pupils (School Council and Pupil Attitude Questionnaires)
- Parents/carers (Lancashire Parents Questionnaires)
- Staff (Self Evaluation Toolkit)
- Governors (Governors and Committee Meetings)

## **MONITORING AND REVIEW**

We collect and analyse a range of equality information for our pupils by:

- Chronological age group.
- Male/female
- Children Looked after
- Special need types
- Level of ability cohort
- Free school meals
- Pupil Premium

This information can be found in the LSIP report (Lancashire School Information Profile) which assists in self-evaluation. We make regular assessments of pupil's learning and use this information to track pupil's progress, as they move through the school. (Lancashire trackers) As part of this process, we regularly monitor the performance of different groups, to ensure that all groups of pupils are making the best possible progress. We use this information to adjust future teaching and learning plans, as necessary.

Resources are available to support groups of pupils where the information suggests that progress is not as good as it should be. The governing body receives regular updates on pupil performance information. (SEC meetings).

School performance information is compared to national data and local authority data to ensure that all pupils are making appropriate progress when compared to all schools, and to schools in similar circumstances.

As well as monitoring pupil performance information, we regularly monitor a range of other information. This relates to:

- Attendance
- Exclusions and truancy
- Racism
- Disability
- Sexism
- Homophobia and all forms of bullying
- Parental Involvement
- Participation in extended learning opportunities

Our monitoring activities enable us to identify any differences in pupil performance and provide specific support as required, including pastoral support. This allows us to take appropriate action to meet the needs of specific groups in order to make necessary improvements.

# 2020 - 2021 Targets

From monitoring data, we have set the following targets to ensure that all groups of children achieve their very best:

- To narrow the gap between girls and boys attainment, especially in writing.
- To raise the attendance of Pupil Premium children so that they rarely miss a day of school.

**Coupe Green Primary School** is also committed to providing a working environment free from discrimination, bullying harassment and victimisation. We aim to recruit an appropriately qualified workforce and establish a governing body that is representative of all sections of the community in order to respect and respond to the needs of our population.

We already collect and analyse a range of profile information on our staff and governors including:

- Applicants for employment
- Staff profile
- Governing body profile
- Attendance at training events
- Disciplinary and grievance cases
- Staff performance management

This data is of course confidential and is not collected by name.

We have identified the following areas of development from the analysis of data:

- 1. Develop basic skills in a choice of activities that challenge *all* pupils, so that the attainment and progress of pupils from different groups are improved
- 2. Seek children's views about learning; use this feedback, and assessment data, to plan for teaching which promotes a love of learning & improves progress, particularly for boys in writing and girls in Maths.
- 3. Provide SMSC experiences and opportunities to prepare our pupils for life in a diverse society.
- 4. To develop both children's and adults understanding of mental wellbeing so that all member of Coupe Green can reach their full potential.
- 5. To increase parental and community involvement to create wider opportunities to support learning in school

Due regard is given to the promotion of equality in the School Development Plan. The person responsible for the monitoring and evaluation of the policy and action plan is the Headteacher.

### Their role is:

- Lead discussions, organise training, update staff in staff meetings, support discussions.
- Work with the governing body on matters relating to equality
- Support evaluation activities that moderate the impact and success of this policy.

### **DEVELOPING BEST PRACTICE**

# **Learning and Teaching**

We aim to provide all our pupils with the opportunity to succeed, and to reach the highest level of personal achievement. To do this, teaching and learning will:

- Provide equality of access for all pupils and prepare them for life in a diverse society
- Use materials that reflect a range of cultural backgrounds, without stereotyping
- Use materials to promote a positive image of and attitude towards disability and disabled people
- Promote attitudes and values that will challenge discriminatory behaviour
- Provide opportunities for pupils to appreciate their own culture and religions and celebrate the diversity of other cultures.
- Use a wide range of sensitive teaching strategies when teaching about different cultural and religious traditions.
- Develop pupil advocacy skills so that they can detect bias, challenge discrimination, leading to justice and equality.
- Ensure that the whole curriculum covers issues of equality and diversity
- All subject leaders, where appropriate will promote and celebrate the contribution of different cultures to the subject matter.
- Seek to involve all parents in supporting their child's education
- Provide educational visits and extended learning opportunities that involve all pupil groups
- Take account of the performance of all pupils when planning for future learning and setting challenging targets
- Make best use of all available resources to support the learning of all groups of pupils
- Identify resources and training that support staff development

### **Learning Environment**

We have consistently high expectations for all of our pupils regardless of their starting point. This is also regardless of gender, ethnicity, disability, religion of belief, sexual orientation, age or any other recognised area of discrimination. All pupils are encouraged to improve on their own achievements and not to measure themselves against others. Parents are also encouraged to view their own children's achievements in this light.

- Teacher enthusiasm is a vital factor in achieving a high level of motivation and good results from all pupils
- Adults in the school will provide good, positive role models in their approach to all issues relating to
  equality of opportunity.
- The school places a priority on the provision for special educational needs and provides an environment in which all pupils have equal access to all facilities and resources.
- All pupils are encouraged to be actively involved in their own learning
- A range of teaching methods are used throughout the school to engage and encourage pupils
- We ensure that the learning is effective by monitoring lessons
- Displays and signage are appropriate to the users.

#### Curriculum

At Coupe Green Primary School, we aim to ensure that:

- Planning reflects our commitment to equality in all subject areas and cross curricular themes
  promoting positive attitudes to equality and diversity
- Pupils will have opportunities to explore concepts and issues relating to identity and equality
- Steps are taken to ensure that all pupils have access to the broad curriculum by taking into account their cultural, backgrounds, linguistic needs and learning styles

### **Resources and materials**

The provision of good quality resources and materials within **Coupe Green Primary School** is a high priority. These resources should:

- Reflect the reality of an ethnically, culturally and sexually diverse society
- Reflect a variety of viewpoints
- Show positive images of males and females in society
- Include non-stereotypical images of all groups in a global context
- Be accessible to all members of the school community

## Language

We recognise that it is important at **Coupe Green Primary School** that all members of the school community use appropriate language which:

- Does not transmit or confirm stereotypes
- Does not offend
- Creates and enhances positive images of particular groups identified at the beginning of this document
- Creates the conditions for all people to develop their self esteem
- Uses accurate language in referring to particular groups or individuals and challenges in instances where this is not the case

## **Extended Learning Opportunities**

It is the policy of the school to provide equal access to all activities.

All our after school clubs are available to all pupils. These are reviewed termly in line with pupil voice to ensure that there is a diverse range of activities for all age groups.

## **Provision for Bi-lingual Pupils**

We make appropriate provision for all EAL/Bi-lingual pupils to ensure access to the whole curriculum. Any pupils who require this type of provision will access it on arrival. These groups may include:

- Pupils for whom English is an additional language
- Pupils who are new to the UK
- Gypsy, Roma and Traveller Children

# **Personal Development and Pastoral Guidance**

- Staff take account of gender, ethnicity, disability, religion or belief, sexual orientation, age or any other recognised area of discrimination and the experience and needs of particular groups such as Gypsy, Roma and Traveller, refugee and asylum seeker pupils.
- All pupils/staff/carers are given support, as appropriate, when they experience discrimination.
- We recognise that perpetrators may also be victims and require support.
- Positive role models are used throughout the school to ensure that different groups can see themselves reflected in the school community
- Emphasis is placed on the value that diversity brings to the school community rather than the challenges.
- The school promotes the Lancashire Anti bullying policy any all staff and pupils know about their rights and responsibilities.

### Staffing and staff development

We recognise the need for positive role models and distribution of responsibility among staff:

- This must include pupils' access to a balance of male and female staff at all key stages where possible.
- We encourage the career development and aspirations of all school staff
- It is our policy to provide staff with training and development, which will increase awareness of the needs of different groups of pupils.
- Access to opportunities for professional development is monitored on equality grounds.

#### **Staff Recruitment**

- All those involved in recruitment and selection are trained and aware of what they should do to avoid discrimination and ensure equality good practice through the recruitment and selection process
- Equalities policies and practices are covered in all staff inductions
- All temporary staff are made aware of policies and practices.
- Employment policy and procedures are reviewed regularly to check conformity with legislation and impact.

### Partnerships with parents/Carers/families and the wider community

- We will work with parents/carers to help all pupils to achieve their potential.
- All parents/carers are encouraged to participate in the full life of the school
- Setting up, as part of the schools' commitment to equality and diversity, a group made up of all stakeholders of the school community. This will be developed to support the school with matters related to its equality duties.
- Members of the local community are encouraged to join in school activities.
- Exploring the possibility of the school having a role to play in supporting new and settled communities.

## Roles and responsibilities

Our governing body will ensure that the school complies with statutory requirements in respect of this policy and action plan.

- The Headteacher is responsible for the implementation of this policy, and will ensure that staff are aware of their responsibilities, that they are given necessary training and support and report progress to the governing body.
- The Headteacher has day to day responsibility for co-ordinating the implementation of this policy.
- Our staff will promote an inclusive and collaborative ethos in the school, challenge inappropriate language and behaviour, respond appropriately to incidents of discrimination and harassment, ensure appropriate support for pupils with additional needs and maintain a good level of awareness of equalities issues.
- All members of the school community have a responsibility to treat each other and staff with respect, to feel valued, and to speak out if they witness or are subject to any inappropriate language or behaviour.
- We will take steps to ensure that all visitors to the school adhere to our commitment to equality.

# **COMMISSIONING AND PROCUREMENT**

Coupe Green will ensure that we buy services from organisations that comply with equality legislation. This will be a significant factor in any tendering process.

## THE MEASUREMENT OF IMPACT OF THE POLICY

This policy will be evaluated and monitored for its impact on pupils, staff, parents and Carers from the different groups that make up our school. An Action plan will be published to enable an impact assessment to be undertaken at the appropriate time within a given timescale.

#### **PUBLICISING THE POLICY AND PLAN**

This policy will be available on the school website and copies available from the school office if required.

### **ANNUAL REVIEW OF PROGRESS**

Report annually on progress and performance in respect of your policy covering ethnicity, disability and gender and to report annually on your progress to improve access for disabled pupils, including access to the curriculum, physical access and access to info.
