

Formal consultation about our proposal to develop a special educational needs unit within Delph Side Community Primary School, Eskdale, Tanhouse, Skelmersdale, Lancashire, WN8 6ED

Nov 2024

This is a formal consultation about making a prescribed alteration to a school in accordance with The School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013.

Lancashire County Council PO Box 100, County Hall, Preston, PR1 0LD We are seeking your views about our proposal to create a special educational needs (SEN) unit within Delph Side Community Primary School. We want to assure you that we will give careful consideration to all your comments and opinions.

We have used the feedback that was given during the informal consultation, conducted between 4 November and 22 November 2024, to develop our plans in relation to this SEN unit. This formal consultation is a legal requirement that we need to do in order to make a change like this to the school.

What are we planning to do?

The proposal is to create an SEN unit for twelve children with special educational needs in Delph Side Community Primary School. All of these children will have education, health and care plans. Some of these children will transfer from another school to Delph Side Community Primary School so that they can attend the SEN unit.

Children attending the SEN unit will be taught in the unit for some of the time and at other times when appropriate they will be taught with other children in existing classes.

All children already on roll at Delph Side Community Primary School will still be able to attend the school and this change will not affect current admission criteria and numbers.

Why are we doing this?

To give families more choice about the type of school they would like their child to attend.

To make sure there is specialist support and enough special school places for all children with special educational needs.

Existing pupils, whether or not they have special educational needs, will benefit from the specialist knowledge of staff working with children in the SEN unit leading to an overall improvement in the quality of teaching throughout the school.

There is a particular need for SEN units in the Skelmersdale area.

What have we done so far?

We have discussed this proposal with the headteacher and governors of Delph Side Community Primary School.

An informal consultation took place between 4 November and 22 November 2024 when we asked for the views of families of children and young people attending the school, children and young people who may attend the school in the future, school staff and governors and other members of the local community. A public meeting was also held on 19 November 2024, where a representative from Lancashire County Council attended.

The written responses to the informal consultation were considered by the Executive Director for Education and Children's Services, in consultation with the Cabinet Member for Education and Skills after the end of the consultation period.

Of the eight responses received to the informal consultation:

- 5 respondents strongly agreed with the proposal; comments included the increasing need for specialist provision, the positive impact on smaller groups of children with special educational needs, the nurturing environment of SEN units and more options for families of children with special educational needs.
- 1 respondent tended to agree, commenting that all children need to understand that each child is different, and to be given an opportunity to help children with additional needs.
- 2 respondents strongly disagreed; comments included that this is a further example of resources being taken away from existing children, that it will reduce the focus on and distract the attention from the mainstream pupils, and that other suitable provisions are already available nearby.

What will happen next?

Careful consideration will be given to all responses that are received on or before 7 January 2025.

These responses will be used to provide information to Lancashire County Council's Cabinet to help councillors decide whether to agree to the increase in school numbers.
