Activity Survey Summary



The Activity Survey is based on 5,621 Year 11 students who completed their statutory education in June 2021 (51.0% male, 48.6% female and a very small 0.4% other/not confirmed gender). This gender breakdown is identical to last year's figures.

Key Findings

- **93.3% of the cohort are recorded as participating. The majority are undertaking full time education (87.0%) with smaller groups in employment with training (5.1%) and full time training (1.2%).**
- **0.3% of the cohort are undertaking re-engagement activities. The total number participating or working towards participating this year is 5,263 or 93.6%.**
- **0.5% of the cohort are taking a temporary break in learning. This equates to 28 young people and is an increase compared to 0.3% in 2020.**
- **1.6% of the cohort have secured employment without training. This is a significant increase on the 0.9% reported in both 2020 and 2019.**
- **The combined proportion of the cohort recorded as NEET or Current Situation Not Known is 4.2%, which remains the same as 2020.**

Destinations – Gender Comparison

90.7% of females progressed into full time education compared to a smaller proportion of males (84.2%)

A higher proportion of males secure places in full time training or full time employment (8.7% of males compared to 3.8% of females)

2.3% of males secured employment without training in 2021; this compares to only 0.9% of females

3.1% of males were confirmed as NEET in 2021; a smaller 2.7% of females were NEET



Participation in Learning %




Total Education, Employment and Training %




Time Series Comparison

Combined NEET and Current Situation Not Known %




Time Series Comparison
