Making an Informed Decision



A guide for parents and carers

Why is it important for your child to attend school regularly?

- \checkmark It gives your child the best possible start to life
- \checkmark They will be able to keep up with their learning
- ✓ They will have a better future employment
- ✓ They will be at less risk of becoming a victim of crime
- ✓ They will be less likely to become involved in anti-social behavior
- ✓ It is the law.

Why is it important for your child to be punctual?

Persistent lateness can be legally counted as unauthorised absence, which can...

- X Cause disruption to the rest of the class
- X Cause embarrassment to the child
- X Make it harder for the child to settle as they may have missed vital instructions
- Being 15 minutes late each day during an entire school year is the same as missing two whole weeks of school

What is the Law?

Children of compulsory school age (5 to 16 years) must, by law receive a full time education.

It is the compulsory responsibility of the Local Education Authority to ensure that this happens and it is the parent's responsibility to register their child with a school or make other suitable arrangements and inform the Local Authority.

Penalty Notice Proceedings for Poor Attendance - Penalty Notices are issued in accordance with Kent County Council's Education Penalty Notices Code of Conduct effective from January 2016, revised June 2020.

A Penalty Notice can be issued in cases of persistent unauthorized absence. Absence for 10 or more half day sessions (5 school days) without authorization during any 100 possible school sessions - these do not have to be consecutive.

Ensure you avoid booking holidays during term time.

Each person with parental responsibility could be taken to court and fined up to f_{2} ,500, or sentenced to three months in prison, for each

Remember 3 days absence in a month due to illness would still mean your child may be counted as a persistent absentee.

If your child needs a medical appointment try an make it <u>out of</u> <u>school hours</u>.

If your child is ill and you are unsure whether they could be in school ring and talk it through with the staff.

Always notify the school each and every day your child is absent due to illness and follow through with a note explaining the reason for absence.

There is no need to keep your child away from school if they have:

Cold sores, Glandular Fever, Head Lice, Threadworms, Tonsillitis, Cold, Ringworm, Warts, Verrucae, Slapped Cheek.

Make sure you get treatment for the conditions.

Keep your child at home with the following guidelines:

Illness	Return to school		
Sickness and diarrhoea	48 hours from the last bout of vomiting/diarrhoea.		
	Doctor's confirmation needed if symptoms persist		
Whooping cough	48 hours from start of antibiotics.		
	21 days from start if no antibiotics.		
Flu	Medically diagnosed		
Chicken Pox	When all vesicles have crusted over		
German Measles	4 days from onset of rash		
Scabies	After 1st treatment		
Impetigo	48 hours after antibiotics or until lesions are scabbed over.		
Scarlet Fever	24 hours after starting antibiotics		
Covid - 19 (1 or more of the 3 symptoms or a positive lateral flow test)If have a positive Covdi-19 test remain at home for 3 days a may return after 3 days if they no longer have a temperature If not taken a test, remain at home until they no longer have			

Breaking it Down:

If a student has **90%** attendance. What does it look like?

90% attendance is the equivalent of being absent from school half a day **EVERY WEEK.**

The SHOCK Factor

In one school year 90% equals FOUR WHOLE WEEKS of missed lessons. If the same student continues to attend only 90% of the year for the time they are at Eastry Primary School they will miss a total of 28 weeks. That is half a school year lost!

The school year is made up of 190 days

Aim for 100% attendance

100% Attendance	=	0 days off
95% Attendance	=	9 days off
90% Attendance	=	18 days off
85% Attendance	=	27 days off
80% Attendance	=	36 days off
