

## School Admissions Policy 2027/28

This policy outlines the regulations on admissions applied by Werneth School fairly and equally to all those who wish to attend this school. The School Standards and Framework Act 1998 introduced a new framework for school admissions as of September 2000, later revised in the Education Act of 2002. The following is compliant with the Department for Education's School Admissions Codes of Practice 2014 and Appeals Code of Practice 2012. These arrangements are in line with the School Admissions Code 2021 and designed to ensure there is a fair admissions procedure for all applicants.

This policy has been developed and reviewed in accordance with the Equality Act 2010, which protects individuals from discrimination on the basis of any protected characteristics outlined in the Equality Act. In operating its admissions arrangements, the admissions authority (Stockport Local Education Authority) for Werneth School will:

1. **Promote equality of opportunity** for all applicants and their families.
2. **Eliminate unlawful discrimination, harassment, and victimisation** and any other conduct prohibited by the Equality Act 2010.
3. **Ensure decisions are based solely on published admission criteria**, applied consistently and without bias.
4. **Advance equality of opportunity** between people who share a protected characteristic and those who do not.
5. **Foster good relations** by promoting understanding, respect, and inclusion within the school community.
6. **Regularly assess and monitor** the impact of admission practices to ensure they do not directly or indirectly disadvantage any individual or group.

## Admission Arrangements for Year 7

Werneth School has a Published Admission Number (PAN) of 250 for entry in year 7. The school will accordingly admit this number of pupils if there are sufficient applications. Where fewer applicants than the published admission number(s) for the relevant year group are received, places will be offered at the school to all those who have applied.

Werneth School's Academy Governing Board is the Admissions Authority for Werneth School and is responsible for making decisions on applications for admissions. Werneth School has elected to use the Local Authority's admission process; therefore, the co-ordination and administration of admissions is undertaken by Stockport MBC's School Admissions Team.

The Closing date for applications for a year 7 place in September 2027 was 31st October 2026.

Stockport MBC operates a coordinated admissions scheme which means parents only have to complete one application as there is coordination between the council and other admissions authorities such as Manchester.

If you live in Stockport, you must apply using the on-line system. The application form is available at: [Stockport Admissions Portal](#)

You can name up to six preferences on your online application. Parents seeking a place for their child here must include Werneth School in ranked order of preference on your application form.

You are strangely encouraged to use all your preferences and consider carefully using one of your preferences for your catchment school. If you decide not to apply for your catchment school, you will not automatically be allocated a place there should your other school preferences be unsuccessful.

The statutory equal preference system is used to allocate school places. This means that: All your preferences are initially looked at individually, regardless of the order in which you have ranked the schools. The order you have ranked your preferences becomes important when it is possible to allocate a place for your child at more than one of your preferred schools. In this instance you will be offered a place at the available school you have ranked the highest.

You will need to apply using the Local Authority form for the area in which you reside.

National Offer Day for September 2027 year 7 is 1st March 2027.

Every parent who lives in Stockport receives one offer of a school place on national offer day. If you've been offered your first choice you will receive an email with details of the offer.

If you have not been offered your first choice you will receive an email with information about the school place that has been offered and the email will include information about how to accept, tell us you no longer need the school place that has been offered and how to be added to the waiting list or to make an appeal.



## **Late applications**

All applications received by the Local Authority after the deadline will be considered to be late applications. Late applications will be considered after those received on time. If, following consideration of all applicants the school is oversubscribed, parents may request that their child is placed on the school's waiting list.

## **Waiting Lists**

If you are not offered a place for Werneth School on 1st March 2027 you can request that your child's name be added to the waiting list. Your child's name will be kept on the waiting list until 31 December, after which the normal in-year admission process will take over and any parents/ carers wishing to have their child's name remain on the waiting list for the remainder of the academic year will need to re-apply. The waiting list is prioritised based on the school's oversubscription criteria. If you are offered a place it will be due to a place having become available and your child being at the top of the waiting list.

## **Children with special educational needs or a disability (SEND)**

The school will admit all children who have an EHCP where this school is named after consultation with the Local Authority EHCP team.

Children who have special educational needs, but who do not have an EHCP, will be treated equally to all other applicants in the admissions process. This includes children who may need extra support or reasonable adjustments to be made. ## **Siblings**

A sibling for the purpose of allocating a school place means one who is still attending the school at the time the younger child starts. Sibling refers to brother or sister, half brother or sister, adopted brother or sister or the child of the parent/carer's partner, where the child for whom the school place is sought

is living in the same family unit at the same address as that sibling.

This means that step or half brothers and sisters will be treated as siblings if they are living together, but full brothers and sisters living apart will not qualify.

## **In year admissions for all year groups**

The Local Authority processes the in-year applications i.e. outside the normal year 7 admission round. Applications must be made via Stockport MBC's on-line system at [Stockport Admissions Portal](#)

All applications are considered in relation to the normal year group for the child's chronological age. An application can be refused if further admissions would cause prejudice to the provision of efficient education and use of resources, or if the pupil has been permanently excluded from two schools. In the case of multiple applications for a particular year group, places will be allocated or names placed on a waiting list in accordance with the published admissions policy and oversubscription criteria.

## **Admission of children outside their normal age group**

Parents may request that their child is admitted outside their normal age group. Requests should be submitted in writing to the admissions authority responsible for the school preferred by the parent. Requests should be supported by documentary evidence where necessary. When such a request is made, the AGB will decide on the basis of the circumstances of the case and in the best interests of the child concerned, considering the views of the Headteacher, any supporting evidence provided by the parent, and outcome of our preadmission screening process.

## **Oversubscription criteria**

The criteria in this section apply to entry at all phases of the school. When Werneth School is oversubscribed, after the admission of pupils with an Education, Health and Care plan naming the school, places will be allocated in following order, up to the Published Admission Number (PAN) of the school:

A - Looked after children, and all previously looked after children, including those children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted

B - Children considered to have 'highly exceptional medical/social reasons

C - Children in catchment with a sibling at The Werneth School at the time of admission

D - Children in catchment with a sibling at Werneth School at the time of admission

E - Children in catchment

F - Children outside catchment with a sibling at Werneth School.

G - Children of staff who have been employed at the school for two or more years at the time at which application for admission to the school is made and/or the member of staff is directly recruited to fill a vacant post for which there is a demonstrable skill shortage\*

H - Any other applicants, in order of straight- line distance measured between home and the school

I - Applications received after the closing date ordered by criteria above

The admissions authority will not consider supporting information from any other educational setting to determine a place within the oversubscription criteria unless this supports consideration of criteria (i) and (ii) in conjunction with other educational or health care professionals. Staff at Werneth School are not able to write supporting statements for any school admissions processes.

For the purpose of allocating school places, distances will be measured consistently and will be measured to three decimal places as a straight line (as the crow flies) between the Council's Local Land and Property Gazetteer (LLPG) address points for the respective home address and the school, using the Easting and Northing for each address point. The Easting and Northing gives an approximate centre point of a site, and everybody is measured to the same point of the school. Applicants will be ordered starting with those living closer

to the school within each of the appropriate oversubscription criteria.

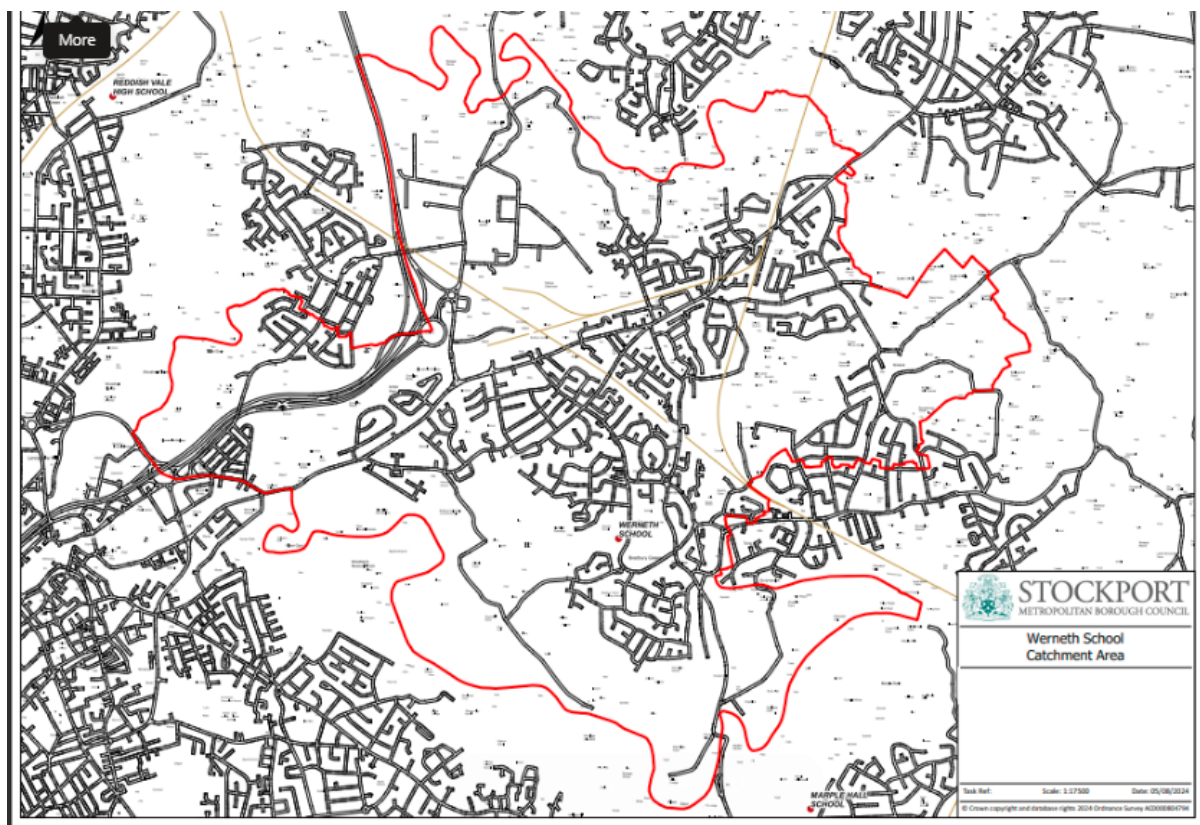


Figure 1: Werneth School Catchment Map

Where applicants wish to be considered under the highly exceptional medical or social reasons criterion, they should indicate this on application and state the nature of the condition and/or circumstances. The applicant must also provide School Admissions Team with written evidence in support of their application. The supporting evidence must relate specifically to the child or family and Werneth School and must clearly demonstrate why this is

the only school that could cater for the child's specific requirements/needs. It should also explain any difficulties that would arise if the child had to attend an alternative school. This evidence must be submitted along with the application.

## Home Address and Principal Parental Address

For the purpose of allocating school places in Stockport, only one address can be used and the address to be used should be the principal parental home address. Parents/ carers cannot, for example, use a grandparent, child minders or the address of anyone else who may provide childcare, or a property they own but do not live in as the principal parental home.

Where parents have shared responsibility for a child, the place of residency will be determined as the address where the child lives for the majority of the week. Full details must be submitted in writing to enable the Council to determine which address will be used for the purpose of admission.

Where care is shared jointly, and it is not possible to determine which parent is the principal carer the LA will consider the following information to decide on a main address for the child:

- Address to which child benefit is claimed
- Address held by child's current School or Nursery
- Child's registered GP address
- Child's registered dentist address
- Any other documentation indicating the child's registered address

In the instance that further information is received regarding a conflict to the principal parental address of a child which has been provided, the Local Authority has the right to request both parents/carers to provide proof of the child's residency at the address.



If you move address after you have applied, you must notify the School Admissions Team as soon as possible as this may have an impact on your application.

## Appeals

Parents/ carers of children who are refused a place at any of their preferred schools have the right to appeal against the decision in accordance with the School Admission Appeals Code. Full details of the appeals procedure and application form are available at [Stockport Admissions Appeals](#)

You are advised to register your appeal as soon as you can. A parent cannot appeal more than once for the same school place in the same academic year, unless significant and material changes in the case have taken place which the previous Independent Appeal Panel could not have been aware of at the time of the hearing.

The deadline to submit an appeal that is guaranteed to be heard before the summer holiday is 28 March 2027. Any appeal application submitted after this date may not be allocated a hearing until September 2027.
