Accessibility Plan 2024- 2026

The school was built in the 1970's with split level access, separating the classrooms from the library and hall with stairs. Over the years a number of building extensions and internal modifications have taken place which have been designed to improve access, notably to the Y3- Y6 entrance and the Nursery and Receptions classes. The car park has a single disabled parking bay which is adjacent to the largest section of the footpath which leads to the office and upper level of the school. At present we have no staff with a physical disability but are aware of some parents with disabilities. The nursery area is zoned within 4 internal low level gates for pupil safety, The building is used by other organisations, including church, voluntary groups and out of hours regular care on a regular basis.

This Accessibility plan has been written in compliance with current legislation relating to the Disability of Equality Act 2010.

The Equality Act 2010 defines a person with a disability as –

Disability

- (1)A person (P) has a disability if—
- (a)P has a physical or mental impairment, and
- (b)the impairment has a substantial and long-term adverse effect on P's ability to carry out normal day-to-day activities.
