However, if you would NOT like your child to be offered any pizza to try, **please** complete and return the slip asap, by Monday 15 January.

We hope that your child enjoys the taster and that you will order dinners going forward. Dinners are free and nutritious. You will also be helping the school, as this is linked to our funding. If you think that your child may be eligible for Free School Meals (FSM)/ Pupil Premium funding (benefits-based), please complete the Swindon Borough Council application, via the link

If your application is approved, you will be eligible to receive free holiday food activity vouchers. Your child will also receive free school meals, from Year 3.

You can apply for FSM funding, if you or your child receive any of these benefits:

- Income support
- Income-based Job Seekers Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of Pension Credit

- Child Tax Credit (provided you are not entitled to Working Tax Credit and your household annual income is less than £16,190)
- Working Tax Credit run-on (paid for the four weeks after you stop qualifying for Working Tax Credit)
- Universal Credit (provided your household annual income is less than £7,400 after tax and not including any benefits you get)
