1. Aims

This policy aims to:

- Set out our approach to requiring a uniform that is of reasonable cost and offers the best value for money for parents and carers
- Explain how we will avoid discrimination in line with our legal duties under the Equality Act 2010
- Clarify our expectations for school uniform

2. Our school's legal duties under the Equality Act 2010

The [Equality Act 2010](#) prohibits discrimination against an individual based on the protected characteristics, which include age, sex, disability, race, religion or belief, pregnancy and maternity, and gender reassignment.

To avoid discrimination, our school will:

- Avoid listing uniform items based on sex, to give all pupils the opportunity to wear the uniform they feel most comfortable in or that most reflects their self-identified gender
- Make sure that our uniform costs the same for all pupils
- Allow all pupils to have long hair (though we reserve the right to ask for this to be tied back)
- Allow all pupils to style their hair in a way that is appropriate for school and makes them feel most comfortable
- Allow pupils to request changes to swimwear for religious reasons or if they are experiencing discomfort related to their sex, gender or gender reassignment
- Allow pupils to wear headscarves and/or other religious garments
- Allow pupils with sensory or physical needs to make reasonable adaptations to their uniform depending on their specific needs
- Allow for reasonable adaptations to our policy on the grounds of equality by asking pupils or their parents to get in touch with the Headteacher, who can answer questions about the policy and respond to any requests. These will be considered on a case-by-case basis

3. Limiting the cost of school uniform

Our school has a duty to make sure that the uniform we require is affordable, in line with statutory [guidance](#) from the Department for Education on the cost of school uniform.

We understand that items with distinctive characteristics (such as branded items, or items that have to have a school logo or a unique fabric/colour/design) cannot be purchased from a wide range of retailers and that requiring many such items limits parents' ability to 'shop around' for a low price.

We will make sure our uniform:

- Is available at a reasonable cost
- Provides the best value for money for parents/carers

We will do this by:

- Carefully considering whether any items with distinctive characteristics are necessary
- Limiting items with distinctive characteristics to low-cost and/or long-lasting items, such as ties
- Avoiding specific requirements for items pupils could wear on non-school days, such as coats and bags
- Keeping the number of optional branded items to a minimum, so that the school's uniform can act as a social leveller
- Avoiding different uniform requirements for extra-curricular activities

- Making sure that arrangements are in place for parents to acquire second-hand uniform items
- Avoiding frequent changes to uniform specifications and minimising the financial impact on parents of any changes
- Consulting with parents and pupils on any proposed significant changes to the uniform policy and carefully considering any complaints about the policy

4. Expectations for school uniform

All of the items listed below are an essential part of our school uniform.

4.1 Our school's uniform

Sky blue shirt (long or short sleeved)
 Tie matching house colours
 Royal blue V-necked sweatshirt- or cardigan
 Grey Trousers/Shorts
 Or Grey skirt/trousers/pinafore dress
 Or Royal blue and white checked gingham dress
 Grey or white socks
 Grey tights
 Black shoes

PE Kit

Royal blue round-necked tee-shirt
 Royal blue shorts
 Black elasticated or Velcro pumps (no laces)
 Trainers may be worn for outdoor games lessons
 A royal blue track / jogging suit may be worn for outdoor games in colder weather
 Black leggings may be worn under shorts
 Children in Year 4 also require a swim suit and towel – one piece for girls and no shorts for boys
 Please see the school brochure for any more details.

Swimming Kit

Girls must wear a one-piece swimsuit.
 Boys must wear trunks or fitted shorts.
 A swimming cap must be worn over long hair.

Jewellery

A pair of small studs or sleepers can be worn in pierced ears. The expectation is that these are removed for PE lessons. Those which are unable to be removed will be taped over for safety reasons during PE.

All jewellery, including studs and sleepers, must be removed when swimming.

Hairstyles

Children with long hair are asked to tie it back. Hairstyles which include 'tramlines' or other such shaving are not permitted.

Hair must also be a natural colour and should not be dyed.

Makeup

Children are not permitted to wear makeup. They are also not permitted to wear nail varnish or fake nails.

4.2 Where to purchase it

- Most of the uniform can be purchased from high street retailers. The exception is the school tie which needs to be purchased from the school office. These come in an elasticated form for children in KS1 and as a clip on for children in KS2.
- Parents and carers who would like to buy a jumper with the school logo on it can buy these directly from the school office, however there is no expectation for them to do so.

- In addition to the purchase of school uniform, we also have a range of second-hand uniform which can be taken free of charge. This is available at the entrance to the school.

5. Expectations for our school community

5.1 Pupils

Pupils are expected to wear the correct uniform at all times (other than specified non-school uniform days) while:

- On the school premises
- Travelling to and from school
- At out-of-school events or on trips that are organised by the school, or where they are representing the school (if required)

Pupils are also expected to contact the Headteacher if they want to request an amendment to the uniform policy in relation to their protected characteristics.

5.2 Parents and carers

Parents and carers are expected to make sure their child has the correct uniform and PE kit, and that every item is:

- Clean
- Clearly labelled with the child's name
- In good condition

Parents are also expected to contact the Headteacher if they want to request an amendment to the uniform policy in relation to:

- Their child's protected characteristics
- The cost of the uniform

Parents are expected to lodge any complaints or objections relating to the school uniform in a timely and reasonable manner.

Disputes about the cost of the school uniform will be:

- Resolved locally
- Dealt with in accordance with our school's complaints policy

The school will work closely with parents to arrive at a mutually acceptable outcome.

5.3 Staff

Staff will closely monitor pupils to make sure they are in correct uniform. They will give any pupils and families breaching the uniform policy the opportunity to comply, but will follow up with the headteacher if the situation doesn't improve.

Ongoing breaches of our uniform policy will be dealt with by the Headteacher. In cases where it is suspected that financial hardship has resulted in a pupil not complying with this uniform policy, staff will take a mindful and considerate approach to resolving the situation.

5.4 Governors

The governing board will review this policy and make sure that it:

- Is appropriate for our school's context
- Is implemented fairly across the school
- Takes into account the views of parents and pupils
- Offers a uniform that is appropriate, practical and safe for all pupils

The board will also make sure that the school's uniform supplier arrangements give the highest priority to cost and value for money, for example by avoiding single supplier contracts and by re-tendering contracts at least every 5 years.

6. Monitoring arrangements

This policy will be reviewed every two years by the Headteacher or sooner if this is deemed necessary. At every review, it will be approved by the full governing board.
