					<p><b>Testing As part of Governments guidelines</b></p> <ul style="list-style-type: none"> <li>All students will, upon return to school, take two on-site LFD tests which will be completed three to five days apart.</li> <li>School will start testing no earlier than the 3 days prior to the start of term.</li> <li>School may consider staggering the first week of reopening to facilitate on site testing.</li> <li>Following the first week of term, staff and students will be encouraged to test twice weekly at home. This will reviewed at the end of September.</li> <li>All staff and students will have access to coronavirus tests.</li> <li>The school will provide students with home testing kits where supply is available and they will be asked to test twice per week.
