## Accessibility plan

Our mission is to ensure every student leaves Great Sankey articulate, resilient, compassionate and culturally aware. Any support required will be identified early, implemented seamlessly working collaboratively & in partnership with stakeholders to ensure every child has the opportunity to succeed & thrive at GS regardless of starting point, background or the challenges they may encounter (be they at home, school, physical, mental or academic).

At Great Sankey High School, all our policies pay due regard to the need to eliminate discrimination and advance equality of opportunity for all students. There is also an obligation to all stakeholders, including: members of staff; parents/carers; users of the premises and visitors to recognise their individual needs and provide for them as far as it practically possible. The aim of the school is to ensure that disabled people using the services of the school are not treated less favourably than able people as far as is reasonably possible

## This plan sets out the school's proposals to increase access to education for disabled students in the following three areas: -

• Increasing the extent to which all students can participate in the school's curriculum

• Improve the environment of the school to increase the extent to which pupils with disabilities can take advantage of education, benefits, facilities, and associated services provided

• Improving the availability of accessible information to Students with SEND needs.

- The parents/carers of pupils
- The headteacher and other relevant members of staff
- Governors
- External partners

Great Sankey High School was built in the 1970s, the main school is all on one level and there are two disabled toilets, one with a fully working hoist. The college is based over three floors, it has disabled toilets on the first floor which is accessible by a singular lift access.

Great Sankey High School is committed to ensuring that reasonable adjustments are made to prevent SEND students from suffering substantial disadvantage. Examples of reasonable adjustments have included but are not limited to:

- The use of overlays / enlarged text
- Visual timetables
- Issuing extra equipment e.g. iPads / Laptops / reading pens
