Georgia is a young girl from Ipswich, UK. She went shopping for new trousers at Sainsbury's. She was surprised when she tried to use the pockets on girls' trousers—they were fake!

But when Georgia looked in the boys' section, their trousers had real pockets.

#### **Girls' vs Boys' Trousers**





Girls' trousers at the shop had pockets that weren't real.
Georgia couldn't put her hands or anything else in them.

Boys' trousers had real pockets you could use. Georgia decided to buy boys' trousers instead.

Do you think it's okay for Georgia to wear boys' clothes? What makes clothes for boys or girls?




#### What Do You Think?

#### Noticed Problem

Kamryn saw her jeans for girls had fake pockets, but her brother's didn't.

#### Wrote a Letter

She wrote to the shop, Old Navy, asking for real pockets in girls' jeans.

## What is Persuasive Writing?

Persuasive writing is when you try to change someone's mind or get them to do something.

Kamryn used persuasive writing in her letter. She explained why she wanted real pockets and asked the shop to make a change.



#### Kamryn's Letter

Dear Old Navy,

I do not like that the front pockets of the girls' jeans are fake. I want front pockets because I want to put my hands in them. I also would like to put things in them. Would you consider making girls' jeans with front pockets that are not fake?
