This template can be used for multiple purposes:

- It enables schools to effectively plan their use of the Primary PE and sport premium
- It helps schools to meet the requirements (as set out in guidance) to publish information on their Primary PE and sport premium
- It will be an effective document to support Ofsted inspections enabling schools to evidence progress in Physical Education (PE) and evidence swimming attainment, which forms part of the PE National Curriculum. We would recommend schools consider the Intent, Implementation and Impact of any spend, as examined within the Education Inspection Framework.

It is important that your grant is used effectively and based on school need.

Schools must use the funding to make **additional and sustainable improvements** to the quality of the PE, School Sport and Physical Activity (PESSPA) they offer. This means that you should use the Primary PE and sport premium to:

- Build capacity and capability within the school to ensure that improvements made now will benefit pupils joining the school in future years
- Develop or add to the PESSPA activities that your school already offers.

It has also ensured that we have consistency across the school in the way that PE is taught and progress across year groups can be measured.	The Passport curriculum will continue to be purchased each for the next academic year. We have a new sports coach joining the team and this will provide them with a good knowledge of the curriculum. We will also be continuing the membership to the Havering Collective to provide ongoing CPD sessions. PE equipment will continue to be checked each term and replaced if needed. We are also looking to replace the basketball/netball hoops in the playground. Extra swimming session have proven to be beneficial in increasing the number of children that meet the expected standard in year 6. However, due to factors outside of our control, we will only be able to offer extra swimming to Year 3 next year. OPAL activity at lunchtime will continue as we have seen a massive increase on children's physical activity during this period.
