## Home School Agreement - March 2021

At Hawes Side Academy, our vision is to be a place where everyone matters, everyone succeeds.

Our Home-School Agreement sets out our collective expectations in school during this period of return to full opening.

In school we will:

- Minimise contact and mixing and promote social distancing rules in and around school by following government guidance;
- Contact you promptly if your child displays symptoms of COVID-19 whilst at school;
- Inform you if staff or children in your child's 'bubble' test positive for COVID-19 and close that bubble for isolation;
- Support your child by modelling and promoting positive behaviour as outlined in our Behaviour Policy;
- Communicate regularly with you through our app, text, newsletters and the website;
- Always put the safety and welfare of our pupils, staff and the school community at the heart of all our decision making.

## Home School Agreement - March 2021

#### As a parent/carer I understand that:

- If my child, or anyone in my household, shows symptoms of COVID-19, they cannot come to school. We will self-isolate for 10 days as a family, I will follow government guidance regarding testing and I will let the school know as soon as possible the outcome of the test;
- If my child has any COVID-19 symptoms I will not send them to school but will seek medical advice and keep school updated;
- School is operating a low threshold of sending children home when displaying COVID-19 type symptoms;
- I will be required to collect my child from school as soon as possible if notified that my child shows symptoms of COVID-19 whilst in school and will follow government guidance regarding self-isolation and testing;
- I will keep my child away from school if their bubble is closed due to a confirmed case of COVID-19 or should the bubble need to be closed for any other reason;
- When dropping off or picking up my child from school I will follow the social distancing measures in place;
- I will drop off and pick up my child during the times allocated in the designated area;
- To support the school's control measures; only one parent/carer will drop off and collect my child;
- My child must only bring items into school that have been requested;
- I need to make sure that my child washes their hands when leaving the house for school;
- I must encourage my child to follow the 'catch it, bin it, kill it' approach when coughing and sneezing;
- Should I need to attend school outside of my allocated drop off and pick up times, I will need to contact the school office in advance by telephone or email;
- I will be kept updated on any changes to school arrangements by reading the school's communications via text, app and website, etc;
- I will share any changes to my contact details with the school office as soon as possible.

#### As a pupil of Hawes Side Academy I promise to:

- Follow the bubble rules and show respect by following adult instructions in order to stay safe;
- Keep my hands clean and follow hand washing rules;
- Minimise contact with others and social distance, where possible, with the support of the adults in school;
- Stay in my bubble all day and not mix with any other children from other bubbles;
- Tell an adult if I feel unwell;
- Not bring anything in from home that school have not asked me to;
- Only use the equipment provided to me by the adults in my bubble;
- Follow the catch it-bin it-kill it approach when I sneeze or cough;
- Remember that all these instructions are to keep everyone safe, including me.

This agreement has been written in line with government guidance, advice from Public Health England and the academy risk assessment. These are subject to change.
