

# “Prevent” Action Plan

Highfield Littleport recognises that it has a duty under Section 26 of the Counter-Terrorism and Security Act, 2015, in the exercise of its functions, to have due regard to the need to prevent people from being drawn into terrorism.

<b>Working in Partnership</b>			
The school is using existing local partnership arrangements in exercising its Prevent duty. 	The Prevent Lead makes appropriate referrals to other agencies including the Multi-Agency Safeguarding Hub (MASH) and Channel Panel.	<ul style="list-style-type: none"> <li>• Records of referrals are kept using the 'My Concern' software</li> <li>• Referrals are followed up appropriately.</li> </ul>	<b>Prevent Lead</b>
<b>Staff training</b>			
Equip staff to identify children at risk of being drawn into terrorism and to challenge extremist ideas.	Assess the training needs of staff in the light of the school's assessment of the risk to pupils at the school of being drawn into terrorism.	<p><b>As a minimum the school should:</b></p> <ul style="list-style-type: none"> <li>• Ensure that the designated safeguarding lead undertakes Prevent Awareness Training. <b>Building children's resilience to radicalisation</b>			
Ensure that pupils have a "safe environment" in which to discuss "controversial issues".
