Dear Parents / Carers,

I hope my letter finds you and your family well and that you had a good summer.

As we have now had our first full week back at the academy, I wanted to write to keep you updated with some of the news from over the summer and plans for this term too.

Firstly, it was wonderful to see so many students again last week, and I have enjoyed delivering an assembly to each year group. In this assembly I shared with the students my hopes for them this year and together with the Head of Year teams we reiterated our high expectations and why it is important that we all work together to ensure we maintain the highest standards possible. Hollingworth is a world class academy, and this is something we should all be very proud of. With this I mind, I would like to thank you all for your support in ensuring your child/ren returned to the academy in the correct uniform and with all the necessary equipment. They all look amazing.

As part of the assemblies, we also mentioned the importance of having outstanding attendance.
