## Privacy Statement

This document sets out how Hollingworth Learning Trust ("the Trust") will treat information we learn about you when you visit our websites.

This document, together with our Data Protection Policy, sets out the basis on which any personal data from visitors to our website is collected.

Our website uses cookies. By using our website and agreeing to this policy, you consent to our uses of cookies in accordance with the terms of this policy. See the section "Cookies" of this documents for further information about cookies and how we use them.

Hollingworth Learning Trust is not responsible for any loss or damage which may arise from your use of any Hollingworth Learning Trust Website.

## What information do we collect or may collect in the future

Hollingworth Learning Trust may collect, store, and use the following personal information about individuals who visit and use the Trust website:

Information about your computer, including:

- IP Address
- Geographical Location
- Browser Type
- Referral Source
- Length of visit
- Number of page views
- Navigation

This information is collected anonymously and not linked to information that identifies you as an individual.

The information is stored on [Google Analytics](#) and web servers at [Schudio](#).

Information that you provide to the Trust for the purpose of contacting the Trust, including contact details and other relevant information.

## Cookies

### What are Cookies?

Cookies are small text files that are downloaded onto a user's computer (or device) when they visit a particular website. Each time the user visits that website it checks to see if the relevant file is on the user's computer and uses the information to improve the user's experience.

For example:

- it recognises that the user has been to that website before and varies the content if applicable.
- it remembers any preferences e.g., layout or colour schemes that the user set.
- it remembers any log in details that the user entered so that the user does not need to log into every page.
- it tracks which pages the user visits to try and keep content useful and interesting.

**The Hollingworth Learning Trust websites use both "session" cookies and "persistent" cookies. We use session cookies to keep track of you whilst you navigate the websites. We use persistent cookies to enable our websites to recognise you when you visit and login to view secure content.**

### **Using your Personal Information**

Personal information submitted to Hollingworth Learning Trust via the website will be used strictly in accordance with the Data Protection Act, for the purposes specified in this Privacy Policy, the Trust's Data Protection Policy or in relevant parts of the trust website, and as otherwise permitted or required by law.

In particular, by using the Hollingworth Learning Trust website and submitting your personal information to it you acknowledge and agree that we may use your personal information obtained via forms and/or cookies to:

- a) administer the Trust's websites
- b) improve your browsing experience by personalising the Trust websites and using cookies which remember your preferences
- c) enable your use of the services available on the Trust websites
- d) deal with enquiries and complaints you have made relating to the Trust websites.

### **Communication with you**

### **Disclosures**

Hollingworth Learning Trust may disclose information about you to any of our employees, or other third parties, insofar as reasonably necessary for the purposes set out in this privacy policy and the Trust's Data Protection Policy.

In addition, we may need to disclose your personal information:

- a) to the extent that we are required to do so by law
- b) in connection with any legal proceedings or prospective legal proceedings
- c) in order to establish, exercise or defend our legal rights
- d) to any person who we reasonably believe may apply to a court or other competent authority for disclosure of that personal information where, in our reasonable opinion, such court or authority would be reasonably likely to order disclosure of that personal information; and
- e) as is otherwise reasonably necessary for the operation of Hollingworth Learning Trust.

### **Security of your Personal Information**

Hollingworth Learning Trust will take reasonable technical and organisational precautions to prevent the loss, misuse, or alteration of your personal information.

The Trust will store all the personal information you provide us via the trust website on our secure servers.

### **Policy Amendments**

Hollingworth Learning Trust may update this privacy policy from time to time by posting an updated version on the website. Where appropriate, we will notify parents/carers/staff of a change via email.

### **Your Rights**

You may instruct us to provide you with any personal information we hold about you.

We may withhold such personal information to the extent permitted by law.
