

## Our Home School Agreement

<b>School</b>	<b>Parent</b>	<b>Child</b>
<p><b>The School will:</b></p> <ul style="list-style-type: none"> <li>• Provide a healthy, safe and caring learning environment which has been risk assessed in response to the COVID-19 infection;</li> <li>• Adhere to the social distancing rules as set out by the government as much as we reasonably can;</li> <li>• Establish clear and consistent expectations of teaching and learning by providing a curriculum that meets the needs of your child's well-being, mental health and individual academic needs;</li> <li>• Work to address gaps in learning that may have arisen from recent closures and support students with their anxiety which may arise over this; enabling them to reach their full potential as a learner;</li> <li>• Continue to apply our clear and consistent approach to rewards and celebrate the individual and collective successes of children</li> <li>• Continue to apply consequences as set out in the Behaviour Policy as well the expectations outlined in this agreement; there is a recognition of additional sanctions which may be used in light of COVID-19;</li> <li>• Contact parents/carers if your child displays symptoms of COVID-19</li> <li>• Provide updates of attendance, behaviour and attainment in line with our policy;</li> <li>• Inform you if staff or your child has been in close contact with anyone displaying symptoms of COVID-19 as this will mean you will all need to self-isolate for at least 14 days or until the test comes back negative</li> <li>• Communicate between home and school through notices, newsletters, emails, the school website and social media;</li> </ul>	<p><b>To help my child at school, I will:</b></p> <ul style="list-style-type: none"> <li>• Support the values and ethos of the school</li> <li>• Communicate with all staff with respect and politeness; I understand that I will not be allowed into school without a pre-arranged appointment due to COVID-19;</li> <li>• Support the school policy regarding behaviour and attendance;</li> <li>• Follow school guidelines regarding the provision of equipment and uniform presentation; it is noted these may be altered to reflect COVID-19 risk reduction;</li> <li>• Support my child and the school to help address gaps in learning that may have arisen from recent closure;</li> <li>• Communicate my concerns I may have with the school and work with the school to support my child through difficulties they may be experiencing;</li> <li>• If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school;</li> <li>• If my child, or another child in the group, shows symptoms of COVID-19 at school, I will collect my child from school immediately;</li> <li>• On my commute, and when dropping off my child and picking them up, I will adhere to current social distancing rules and specific timings that may be applied by the school;</li> <li>• My child will have their temperature taken during the day if they feel or present as being unwell;</li> <li>• Remind my child about current social distancing rules and the need to use good respiratory and hand hygiene;</li> <li>• To read all letters/messages/emails that are sent home;</li> </ul>	<p><b>I will:</b></p> <ul style="list-style-type: none"> <li>• Attend school every day, be properly prepared and presented and ready to learn;</li> <li>• Be punctual, arriving at school on time;</li> <li>• Meet the behaviour expectations of the school including specific requirements linked to the risk reduction of COVID-19;</li> <li>• Treat others with respect and politeness at all time, showing respect for others' ideas, beliefs and worries;</li> <li>• Develop my independence as a learner and work with my teacher to address my gaps in learning that may have arisen from recent closures;</li> <li>• Complete my work to the best of my ability</li> <li>• Discuss concerns I may have with my parents and/or staff at school so that together we can resolve things that may worry me;</li> <li>• Adhere to the current social distancing rules in class and around the site including following guidelines for movement for entry and exit</li> <li>• Tell an adult if I feel unwell and understand I may need to have a temperature check;</li> <li>• Travel (or walk) to and from school ensuring I respect social distancing rules;</li> <li>• Not mix with children from other bubbles in school;</li> <li>• Follow good respiratory and hand hygiene;</li> <li>• Always behave well to maintain the safety of myself and others'</li> <li>• Understand that these changes are about keeping everyone safe, including me</li> </ul>

<ul style="list-style-type: none"><li>• Regularly seek the views of children and parents to aid planning and improvement</li></ul>	<ul style="list-style-type: none"><li>• Inform the school immediately of any changes to parents/career and emergency contact details;</li><li>• Understand that if my child is deemed unsafe, he/she will be sent home and cannot return to school until they can be safe;</li></ul>
