1. Aims

This policy aims to ensure that:

- > Suitable education is arranged for pupils on roll who cannot attend school due to health needs
- > Pupils, staff and parents understand what the school is responsible for when this education is being provided by the local authority

2. Legislation and guidance

This policy reflects the requirements of the <u>Education Act 1996</u> and Lambeth LA guidance: https://www.lambeth.gov.uk/send-local-offer/education/education-for-children-with-medical-needs It also based on guidance provided by our local authority.

This policy complies with our funding agreement and articles of association.

3. The responsibilities of the school

3.1 If the school makes arrangements

Initially, the school will attempt to make arrangements to deliver suitable education for children with health needs who cannot attend school.

- These arrangements will be made and monitored by the T&L lead, SLT and Head of Academy
- > Where possible work will be sent home either by email or post. Where this cannot happen, there may be an opportunity for the pupil to be educated in the hospital they are in (see above for Lambeth's LA policy). Lambeth LA would make these arrangements.
- > Parent / carer and pupils will be contacted regularly by the T&L lead and SLT to check on progress and welfare. Where possible regular meetings, either at school or in the family home will happen to discuss next steps.
- As part of the parent / carer meetings, there will be a clear plan of action to re-integrate the pupil back in to school where this is a possible.

3.2 If the local authority makes arrangements

If the school can't make suitable arrangements, Lambeth LA will become responsible for arranging suitable education for these children. In cases where the local authority makes arrangements, KPA will:

- > Work constructively with the local authority, providers, relevant agencies and parents to ensure the best outcomes for the pupil
- > Share information with the local authority and relevant health services as required
- > Help make sure that the provision offered to the pupil is as effective as possible and that the child can be reintegrated back into school successfully
- > When reintegration is anticipated, work with the local authority to:
 - Plan for consistent provision during and after the period of education outside the school, allowing the pupil to access the same curriculum and materials that they would have used in school as far as possible
 - Enable the pupil to stay in touch with school life (e.g. through newsletters, emails, invitations to school events or internet links to lessons from their school.
 - Enable the pupil to stay in touch with school life (e.g. through newsletters, emails, invitations to school events or internet links to lessons from their school)
 - Create individually tailored reintegration plans for each child returning to school
 - Consider whether any reasonable adjustments need to be made
- > We always refer children to the Lambeth LA attendance team if they have been a CME for 10 x days –following the guidelines regarding contacting the family.

4. Monitoring arrangements

This policy will be reviewed annually by SLT. At every review, it will be approved by the full Academy Council
