Pupil Premium Grant - Detailed Allocation of Funding - 2017-2018

Allocation = £7,900

Number eligible pupils - 9 pupils out of 78 pupils 12%)

Objective 1

To continue to close the gap between disadvantaged and non-disadvantage children in Reading and Writing (attainment and progress)

Actions:

1. To continue to employ additional part-time support staff (x3) for targeted intervention/booster provision. Plus in-class support for targeted groups of children.
2. Class teachers to give more time to the modelling and scaffolding of chosen genre during each block of work. Additionally, children will be given more opportunity to draft and edit final pieces of written work following self and peer evaluation. To use the 'Talk for Writing' method of teaching writing.
3. A consistent approach across the school to the teaching of reading through guided reading sessions, independent reading, the teaching of comprehension skills, plus 1:1 reading with an adult and strategies to increase the frequency of reading at home

Success Criteria:

All pupils receive independent, 1:1 and guided reading activities each week.
 Improved quality of final pieces of written work, leading to improved attainment and increased progress being made over the course of the year.
 EYFS Quality Continuous Provision for writing and reading.
 70% of all pupils to achieve age-related expectations in reading and writing.
 Expected or better than expected progress made by all children involved in targeted intervention.
