#### **Parent Survey Results**

#### Our response to some common comments



**You said:** I would like to know more about what my child will learn during the year.

**Our response:** Our <u>full curriculum plans can be found on the school website</u> in the 'subjects' section. These were also sent to all parents at the start of the year. The curriculum plans show what children will be learning each half-term. If you would like to know more about what your child will be studying in a particular subject, please contact their subject teacher.

**You said:** Some parents raised concerns about the level of information they received in relation to their child's progress in school.

**Our response:** We provide termly updates on your child's progress in school either through an interim report, full report or parents' evening. Full details about how we assess your child's progress in school can be found on the school website <a href="here">here</a> (key stage 2) and <a href="here">here</a> (key stage 3). If you have any questions about your child's progress at any point during the school year, we ask you make contact with the subject teacher in the first instance and at that moment in time – there is no need to wait for a parents' evening.

You said: Some parents raised concerns about pupil behaviour in our school

Our response: Full details of our behaviour expectations and responses can be found in our behaviour policy on the school website. We set very high expectations for pupils in relation to behaviour and we make no apologies for this. We aim to instil a culture across the whole school where working hard is the norm and the associated success is something to be celebrated by all. The overwhelming majority of our pupils excel in this area on a daily basis. Where pupils fail to meet our high expectations, we use a variety of approaches to support pupils to modify and improve their behaviours. This will often involve a combination of restorative and educational work, a learning from our mistakes approach, as well as punitive sanctions. The pastoral and behaviour support team run programmes throughout the year to support pupils where needed — we always aim to be proactive rather than reactive. If you have any concerns regarding behaviour in any of your child's classes, please contact school so we can look in to this further. Often, the story you hear from your child may be very different to what is actually happening within school.

**You said:** Various comments were raised in relation to homework. Some parents complained there was too much, some said not enough. Some parents like the online nature of many homework tasks whereas others wanted to see more paper-based resources and opportunities for extended writing.

**Our response:** Homework is always an area which divides opinion. Many parents feel we do not set enough homework; contrary to this, many parents say we set too much homework. We recognise homework is an area which needs developing and we are currently reviewing our approaches. Like it or not, homework helps pupils develop positive study habits which they will need as they move up the school and on to high school. Regular homework also supports pupils to retain and recall knowledge which in turn can improve levels of attainment and progress.

We are looking at increasing the levels of academic rigour across our school in order to ensure the academic jump from year 8 to 9 is as seamless as possible – homework will play a key part in this. We are considering introducing year 7 and 8 exam weeks where pupils will be taught how to revise for exams and will then practise taking a large number of assessments in a short space of time. The exam weeks will be

very much seen as a learning experience and as such, all we ask is that pupils try their hardest both with their revision beforehand and also during the exam week itself.

You said: Some parents raised concerns about the school's responses to bullying.

Our response: We strive to make our school a safe and happy place for everyone. We work tirelessly to create an environment in which commonalities are identified and celebrated, difference is valued and nurtured, and bullying, harassment and violence are never tolerated. As part of the personal, social, health and economic (PSHE) curriculum, pupils learn about bullying – what is and what isn't bullying, the impact it can have on others and what they must do if they are being bullied or know somebody who is being bullied. These messages are reinforced throughout the wider curriculum and also through pastoral work in form time and assemblies. Should the school become aware of incidents of bullying, we will work closely with families to reach a swift resolution. Full details about how we respond to bullying can be found in our anti-bullying policy.

You said: I am concerned about some of the WhatsApp groups my child is part of.

Our response: We too have serious concerns about this. The age rating for WhatsApp is 16+ meaning it is not suitable for our pupils. We are dealing with more and more incidents which stem from WhatsApp or other similar group chats — many of our children are simply not mature enough to use these chats. Where online incidents cause issues in school, they will be dealt with in line with the school behaviour policy. Where incidents occur outside of school, we will provide support wherever we can however we are not always in a position to do so. If you have serious concerns about comments made to your child online, this should be referred to the police. To support us in this work, we ask that parent's routinely sit down with their child and go through the content on their phones and other devices. You pay the bill!

You said: I feel more distant from my child's schooling since they moved to middle school.

Our response: We want Kirkburton Middle School to be a true community school. As such, we very much welcome parental input. We recognise you may not have the regular face to face contact you had with staff in the first schools however we are always here should you need us. Please do not hesitate to get in touch if you have any questions or concerns – there is no such thing as a silly question. These are usually best directed to your child's form tutor in the first instance. There are many opportunities for parents to get further involved in the life of the school. These include joining our governing body, helping to start a PTA / friends of Kirkburton group (we'd love to hear from you if that's you!), becoming a reading volunteer, or offering to come and speak to the pupils about your job or career at our regular working lunch club. There are many other ways you can help support the school, please contact the school office if you could offer some support.

You said: Communication could be improved.

**Our response:** Communication is always something that is difficult to get right. What one person may see as too much communication, another person may see as too little. We try and direct our communications as much as we can however this isn't always possible. We do share a lot of general news via social media; this allows people to opt in or out on their own accord <u>Kirkburton Middle School Facebook</u>.

You said: Some parents raised concerns around staff absence and turnover

**Our response:** Staff absences occur for a variety of reasons, some planned e.g. teacher on a school trip, others unplanned e.g. illness. For short term absence, your child's lesson will normally be taken by a

member of our in-house cover team. These colleagues know you children well and are in the best position to provide a continuity of education in the short term. For longer term absences, the school will aim to secure the services of a qualified teacher from local supply agencies. Currently there is a national shortage of teachers in specific subjects and there have been occasions recently where we have struggled to recruit to vacancies. Where this occurs, we look to bring in subject specialist supply teachers. We will also sometimes rotate our own staff between classes in order to support with a continuity of education for all children.

You said: A couple of parents questioned our approaches to PE fixtures and competitions.

**Our response:** As with some other aspects of school life, this is an area where people often have quite polarised views. At Kirkburton we aim to strike a balance so our offer is fair to all. We aim to ensure sport is accessible to all and often our approach is based around principles of inclusivity. We also recognise that as pupils get older, sport becomes more competitive in nature and as such there will be some occasions where we adopt more of a 'play to win' philosophy. All decisions taken by our PE staff are in the best interests of all our children and we are passionate about ensuring all pupils have access to and enjoy a wide variety of sports and activities.

**You said:** Some parents said they didn't know who our school governors are or how to contact them.

**Our response:** Please see the governor page of the school website for further information.

**You said:** Some parents of pupils with SEND questioned the levels of provision and support for their child. There were also some questions raised in relation to communication.

**Our response:** All parents of SEND pupils receive a letter from the SENDCO in the first half term of the academic year sharing direct contact details with our SENDCO and explaining timelines of when support plans will be shared. Alongside this letter, the intervention offer for the school is also shared. The SENDCO is available at all parents' evenings for set appointments and parents are welcome to make direct contact at any time with questions or concerns. Support plans are shared in the winter term and reviewed twice, during the spring and summer terms.
