Editorial.

ROM the welter of conflicting forces, theories, and perplexities of the last ten years, emerges this visible result. The ideals of service amongst civilised peoples have become purified, ennobled and enlarged. Service has been the watchword of Christendom ever since the Founder proclaimed it by To the student of social history it is curious deed and word. to note how long it has taken the world to absorb some of the principles of Christianity, long after it has openly professed their adoption. It took eighteen centuries before humanity awoke to the inhumanity of slavery, and still longer before the nobility of service became a practical ideal for the generality of mankind. The chivalry of the Middle Ages caught a glimpse of this truth. The Black Prince carried from the battlefield of Crecy the famous motto Ich Dien, I serve, which has been borne since by every Prince of Wales and put into living form and practice by our beloved Prince. Isolated heroes in all lands and times have reflected its glory. The true nobility of our land have always shown that Noblesse Oblige are not empty words. For centuries this ideal appeared to be regarded

as the privilege of the few. Less than a hundred years ago our old public schools regained a new vision of true life by seeking to embody this principle of service as the mainspring of their corporate life. Now in our times, out of the catastrophe of humanity in four years of apparently senseless slaughter, has arisen the great revelation that we all can serve, and that in service we can find the realisation of ourselves and the true happiness of life. The war in spite of all its horrors was the enfranchisement of the common man into a nobility of service. It was proved that the average Englishman from town and mill and farm and shop and office, the product of our Elementary and Secondary and Grammar Schools, could hold his own with the best in endurance and suffering, could rise to heights of bravery and self sacrifice, could play the game, could show forth the nobility of service.


In spite of industrial strife, in spite of those who would decry their own times and generation, it is true that there is to-day a greater and more widespread sense of the beauty and nobility of true service than ever before.

This revelation is what a body such as K.G.S. can seize and exemplify and translate into action in many ways. Service is the silent watchword of our school life, service of House, service of School. Why should we seek individually to improve our mental and bodily equipment? There are many answers that could be given to this question but surely none truer than this, that we may be a better instrument of service in our time and to our generation.

Our Old Boys in a thousand different ways and places, serving in manifold spheres to add to the happiness and well-being of mankind, bind themselves into an Association, and for what purpose? If we sift down the reasons and think them out, surely the main purpose is this, that we may be of service to each other, to our old school, to society in general.

Is this ideal too high? Surely not. The Old Boys' Association has rendered great service to the old school and I believe, all unseen, it has been an instrument whereby true service has been rendered to one another. Because in days gone by we found in K.G.S. our inspiration and ennoblement we seek now to live up to it, in a word, to serve.

To all of that great brotherhood whom this may reach, we say, strength and blessing to you in carrying on the good work.

The School was inspected by the Board of Education on June 5th and 6th.

Electric light has been installed throughout the School buildings, and has been in use since November 28th.

Cricket, 1929.

The Cricket Season of 1929 cannot be called successful. On several occasions the XI. appeared to have victory within their grasp only to let their opportunities slip through their fingers. The best game of the season was that against Preston Grammar School. Preston faced a total of 160 for 8 wickets with great confidence and were within 1 run of that total when stumps were drawn.

Three games were won, those against Lancaster Royal Grammar School 2nd XI., Rev. J. Dyson's XI., and the Master's XI.

Ten games were lost and two drawn. In N. Marsland and L. Heathcote the School had two good medium paced bowlers, the former of whom had a very successful season, but there was not sufficient steadiness in the batting.

S. Bury played some good innings, particularly one of 60 against Arnold House, but even that did not suffice to win the game.

The 2nd XI. were more successful, winning 4 and losing 4 of their eight matches.

Roberts and McNicol showed promise of being good recruits for the First XI. of 1930.

The keenness shown by many very young boys in the school was remarkable and should result in some very good XI.'s in the near future.

The Senior House Competition was won by the School House, who beat Lytham House in the final round by 6 wickets, the scores being: School House 98 and 64 for 4 wickets, Lytham House 119 and 36.

The Junior House Competition resulted in another win for the School House, who defeated Kirkham House in the final by 9 wickets.

The Cricket prizes were awarded as follows:--

Rugby Football, 1929-30.

The football season 1929-30 can be considered as one of the most satisfactory we have had since adopting the Rugby Code. The most noticeable feature was the number of matches won or lost by narrow margins. The backs were perhaps rather lacking in striking power, but the defence was usually very good and the forwards at times rose to heroic heights.

Many splendid games were seen, the best perhaps being that against Hutton G.S. at the end of the season, resulting in a win for us by 6 points to 0.

Blackpool Secondary School were on the whole rather fortunate in beating us twice by 3 points to 0 and by 8 points to 3; and Manchester Grammar School scarcely deserved a draw at 3 points all.

In the match with the Old Boys the XV. were outweighted, but though defeated, put up a plucky fight.

Of eleven matches played the XV. won 4, drew 1, and lost 6, but the record of points shows them in a more favourable light: 103 for and 80 against.

The "A" XV. won all their matches.

The 2nd XV. were disappointing, losing four out of six games, drawing one (against Wigan G.S.), and defeating Hutton G.S. once.

The House Competitions were up to the usual standard, the Senior Competition being won by the School House, who defeated in turn all the other Houses and scored 168 points against 8. Kirkham House were the runners up.

Kirkham House won the Junior Competition comfortably, the Fylde House being runners up.

Sports, 1930.

The 31st Annual Sports were held on May 21st, under most favourable weather conditions. A good attendance witnessed excellent Sports, several records being set up.

This year the Committee decided to institute a Junior Championship, and this proved a great attraction to the Juniors. There was a record entry in the Junior events and the running revealed some promising talent for the future. The Junior Champion was C. R. Garlick, who won with four firsts and one third.

Prize Day, 1929.

(From the Preston Guardian, August 3rd, 1929.)

Prize Day was held on July 31st. The prizes were presented by Canon C. M. E. Hicks, an Old Boy, who was at K.G.S. 1895-99, and who was on a visit to this country from Australia.

The gathering had a distinctly colonial atmosphere, for, in addition to relatives of the Headmaster, from East Africa, the guest of honour was Canon C. M. E. Hicks, an old boy, head of the St. Andrew's Bush Brotherhood, Australia, who with his family is on holiday in this country, and among the visitors was R. H. Catterall, the South African Test cricketer, whose father was educated at the school.

Canon W. T. Mitton, Vicar of Kirkham and Rural Dean, who is chairman of the school governors, presided over a large attendance.

Canon Mitton recalled that when the present school was built they were allowed accommodation for 120 boys, but by using a wooden building from the old site they increased it to 184, so that they had 64 more boys than places allowed for. The governors were trying to be alive to the needs of extension, and had acquired a site, adjacent to the school, which would be a very great help in years to come. The Chairman, on behalf of the governors, expressed sincere thanks to Mr. and Mrs. Strange, who worked indefatigably for the success of the school.

The Headmaster, in his report expressed his belief that they had accomplished a good year's work, and said there was an improvement in the examination results. The standard of scholarship in the Upper School was high, but they meant to make it higher.

Turning to general impressions created during the school year, the headmaster said: "In my opinion the present generation of boys has, to a large extent, recovered the power to work hard. But the characteristics of this age are speed and noise, and they are having a dangerous effect on the rising generation. Gone are the leisured walk and the quiet home. People rush from one task or pleasure to another before they have had time to consider the enjoyment of the pleasure or the effect of the completed task. Gramophone and wireless with syncopated squeals kill any quiet moments. Few people find time for calm thought. And this is taking a very heavy toll of individual nerve power."

"Every life needs quiet moments; there is a time to sit still and think. It may be a dream of mine which is very far away from realisation, but I do look forward to the time when we shall have a school-chapel, a place where one can find a holy hush. I believe that before long the strain and rush and noise of modern life will make something of the kind an absolute necessity in every school. In the meantime I am trying to get my boys to realise the value of quiet moments and thoughtful solitude."

After distributing the prizes, Canon Hicks recalled that 30 years ago, almost to the very day, he was receiving prizes as head boy at that school. He was really sorry to learn that scholarships to the Universities that were available from Kirkham in his days were not now in force. He thought that was a great pity, because he ascribed his success to the fact that he was able to pass from Kirkham to Oxford.

Addressing the boys, the Canon urged them to look out for friends. The capacity to make friends was one of the most wonderful and amazing things of human life. The only reason, he supposed, why they did not get nowadays, as they used to in the classics and the Bible, so many classic examples of friendship was that a man tended to make a real friend and pal of his wife.

Canon Hicks entertained the assembly with an account of his experiences in the bush where, he declared, life was full of romance and interest.

Annual Meeting and Dinner, 1929.

The Tenth Annual Meeting of the Association was held at the School on November 20th. The President paid a tribute to the memory of H. Rothwell, J. C. Humber, W. Munro, R. Midgley, and T. R. Jolly. The members present stood in silence.

The minutes of the previous meeting and the Balance Sheet, showing a balance in hand of $£58/4/5\frac{1}{2}$, were read and approved.

The Secretary stated that the membership of the Association was 230, and included 98 life members. A hearty vote of thanks was accorded to Mr. J. H. Rigby for his valuable services as Hon. Sec. and Treas. of the Association, and he was unanimously re-elected.

The Committee for the ensuing year was constitued as follows:—The President, the Hon. Sec. and Treas., Messrs. H. Parkinson, R. S. Crozier, H. F. Tomlinson, F. A. Mullineaux, R. W. Parker, A. Bamford, J. Threlfall, F. H. Jolly, H. Coupe, J. P. Coleman, with H. Greenway as the representative of the present school.

The President reported the success that had attended the efforts to raise funds to build a Cricket Pavilion, and reported

progress with regard to the Coat of Arms. The Letters Patent granting the Arms were on view.

An interesting discussion was raised on the subject of an Old Boys' Rugby Football Club. Opinion was divided and it was decided to explore the possibilities of such an undertaking.

After the meeting a representative company of members numbering 97 sat down to dinner in the School Assembly Hall. The customary toasts were duly honoured. Mr. Fred Walmsley proved a most clever and popular entertainer, and a very happy and convivial evening was spent.

In the afternoon the annual football match, Past v. Present, was played. The Old Boys, who had the advantage in weight, won a hard game by 19 points to 0.





We wish to render most grateful thanks to all who so splendidly helped us; to the Kirkham Women's Institute for the great work they did in staging the Dickens Pageant, which was voted a great success and stirred interest far afield; to the ladies who achieved such magnificent results with the Stalls and Refreshments; to all the School, Past and Present, Masters and Boys; to the many parents and friends who in so many ways rendered invaluable assistance. It is worthy of placing on record that the boys of the school sold 3,115 tickets. The event though marred by unfavourable weather was a wonderful witness to the strength of the interest and affection that so many have for K.G.S.

The receipts totalled £344/4/10. Expenses £96/0/9. Balance £248/4/1.

The Pavilion.

The Joint Committee of the Old Boys' Association and the School Sports Committee have given very careful consideration to the further steps to be taken to complete the Pavilion scheme.

It was decided that it was not advisable to attempt another large effort to raise funds this year, but at the same time that it was desirable to prevent interest in the project from declining. In consequence an effort should be made to start building without delay.

A very pleasing design was adopted, thanks to the assistance of J. A. Miller, H. Cartmell, and F. H. Jolly. The two latter also gave the greatest assistance by drawing up schedules of quantities for the work. Tenders were then advertised for and 20 were received. It was decided to accept the lowest tender, that of Messrs. H. Joyce of St. Annes-on-Sea, for £571/6/2.

The amount in hand, mainly the result of the Fête held last August, amounts to £285. The Midland Bank are prepared to advance £300 under guarantee.

The following Old Boys have consented to join with the President of the Association in guaranteeing the sum:—E. Lomax, A. N. Shaw, J. H. S. Matthews, H. F. Tomlinson, H. C. Turner, A. Entwisle, R. Murray, J. Threlfall, M. Blacklidge, R. E. Gregson, R. L. Langley, W. A. Gorst. It is desirable that this number should be increased and made as large as possible. It is hoped that there are many who, on reading the Chronicle, will write to the President expressing their wish to be associated with this work.

The Committee propose to organise another big effort next Summer to clear the debt. Assistance is earnestly asked in arranging this. At the same time it is hoped that the task may be lightened by direct giving, and the Pavilion Fund is open to receive subscriptions which will be gratefully acknowledged.
