We venture to hope that the darkest hour is passed. Cricket, 1930.

The XI. whilst somewhat lacking in experience and steadiness was one of the most interesting we have had for many years past.

The bowling was well varied. Roberts, a genuine slow left-hander, combined a deceptive flight and spin with a steady length, and proved an admirable foil to Jones (medium pace, off break) or one of the fast bowlers McNicol or Heathcote.

The batting was uneven. Penney and McNicoll were a sound opening pair; Jones and Greenway played a few stylish innings; Farrow, though stylish, did not fulfil our hopes of last year; of the rest Wilson was reliable though crude in style and Crewdson showed promise for 1931.

The list of fixtures which follows shows that an excellent start was not maintained throughout the season.

Time robbed us of two probable victories over Preston Grammar School.

Our match with King George V. School, Southport, proved most exciting, our opponents failing by one run to reach our score.

The Old Boys match also produced a good struggle in which the School saved the game after extra time had been played.

Lancaster R.G.S. 2nd XI. were easily defeated twice and Hutton and Wigan Grammar Schools once each. Blackpool Secondary School again proved too strong for us and we collapsed badly on a difficult wicket at Arnold House.

Full colours were reawarded to Greenway and Penney, and given to Jones and McNicol.

XX. Caps were reawarded to Heathcote, Pollard and Farrow, and awarded for the first time to Wilson, Roberts, Crewdson, Raby, R. M. Rigby, J. G. Stansfield, Strong, Roscoe and Walker.

The 2nd XI. proved less successful having only one win and one draw to their credit against six losses.

The Senior House Competition was won by the School House, who defeated Blackpool House in the final by an innings and 24 runs, the scores being: Blackpool, 29 and 41, School House, 94.

The Junior House Cricket Cup was also won by the School House, who defeated Kirkham House in the final.

Prize bats kindly given by Mr. J. H. S. Matthews, and Mr. G. Taylor, were presented to McNicol and Penney, who tied for first place in the batting average with figures of 14 runs per innings each.

A silver mounted ball, presented by Mr. L. Orr, was given to A. H. Jones, the most successful bowler, who took 42 wickets at an average of 7.9 per wicket.

Swimming, 1930.

The number of boys who can swim continues to increase. By the end of the season 132 boys qualified for swimming Certificates; this represents 75% of the total strength of the school.

Rugby Football, 1930-31.

The 1st XV. are to be congratulated on having a splendid season.

They excelled in all departments of the game and in addition showed indomitable courage time after time. Every member of the XV. was a fearless tackler and the pack of forwards splendidly led by Gorton, rose at times to heroic heights. Farrow was a clever hooker, Jones worked the blind side of the scrum cleverly—and perhaps rather too often—Heathcote usually outshone his opposite number at full back, and the three quarters, though not outstanding as individuals, were speedy and sound.

The XV. showed its best form in the victories over Hutton Grammar School at Kirkham, 6—0, and over Arnold School at Blackpool, 24—0. Other fine games were the

victory over Giggleswick 2nd XV. (8-3); the two even struggles with Blackpool Secondary School; the overwhelming victory over Lancaster R.G.S. 2nd XV. at Lancaster (45-3), and the Old Boys match.

Though defeated by Rossall School 3rd XV. by 14 points to 3, our XV. gave a good account of themselves and left a good impression.

Of 16 matches played by the 1st XV. nine were won, six lost and one drawn, 186 points were scored against our opponents 90. The XV. was, moreover, the heaviest we have had, the average weight being over 10 stone.

The 2nd XV. were usually outweighted and suffered two heavy defeats by Blackpool Secondary School. As against this they scored two victories over Arnold School and a draw at Hutton Grammar School. The latter however defeated them at Kirkham.

The School House were victorious in both the Senior and Junior House Competitions, the runners up in the Senior Competition being Lytham House, and in the Junior Competition, Fylde House.

Prize Day was held on July 30th. The prizes were presented by the Right Honourable the Earl of Crawford and Balcarres, K.T.

The Rev. Canon W. T. Mitton, Vicar of Kirkham and Chairman of the School Governors presided over a large attendance. After the Headmaster had given his report, showing a very healthy state in all departments of the school life, The Earl of Crawford and Balcarres, who rose amidst

applause, said that the prizes he saw around him were evidence, he hoped, of good, honest, hard work and triumph. He offered his congratulations to those who had won them, and his condolences to those who had not won them. He thought those who had not won were often worthy of mention.

Some of the boys were going out into the wonderful world around them, and whilst congratulations were always welcome to people, they would see many unhappy things, and condolences were often the more valuable thing of the two. Their education at that school was, as the Headmaster had indicated, being given to them as a foundation upon which they would try to base a sense of citizenship.

He went on to say that education was no longer looked upon as something which a boy or girl had got to go through for his or her personal advantage. They were not there simply to be educated themselves, but to learn whatever a school career could give them, not only for their own personal advantage, but that they might be made good citizens, and that they might learn the message of citizenship and be worthy members of the State.

The speaker referred to the grave crisis, perhaps unprecedented, through which the country was passing. He thought that other countries, lacking the stability of Britain, would have crumpled up under the strain.

He re-echoed the words of the Headmaster that every boy would feel that he was not working merely to bring honour to himself or his family, but for higher things, the traditions of their school and the traditions of their country.

The knowledge that they had such traditions on which to build was an invaluable advantage to them all their lives.

A vote of thanks to the Earl was proposed by Mr. P. L. Birley, J.P., and seconded by the Rev. R. W. M. Holme.

The assembly room, where the ceremony was held, was crowded.

Annual Meeting and Dinner, 1930.

The Eleventh Annual Meeting of the Association was held at the School on November 19th. The President referred to the loss of C. E. Thornley, and the members stood in silence.

The minutes of the previous meeting and the Balance Sheet showing a balance in hand of £57/11/11 were read and approved.

The Secretary stated that the membership of the Association was 242, and included 115 life members. The President paid a tribute to the work of the Hon. Sec. and Treasurer and appealed to members to lighten his labours. A very hearty vote of thanks was accorded to Mr. J. H. Rigby, and he was unanimously re-elected.

The Committee for the ensuing year was constituted as follows:—The President, the Hon. Sec. and Treas., Messrs. H. Parkinson, R. S. Crozier, H. F. Tomlinson, F. A. Mullineaux, R. W. Parker, A. Bamford, J. Threlfall, F. H. Jolly, H. Coupe, J. P. Coleman, with R. Swan as the representative of the present school.

The President reported on the progress made with the Pavilion and the proposals to have a School Concert and an Old Boys' Dance in aid of the Pavilion Fund. Designs for the Old Boys' Blazer Badge were submitted and that of the Grand Clothing Hall, Preston, was unanimously accepted. It was decided that the Old Boys' Blazer could be purchased from any tailor or outfitter to suit the convenience of members, provided it was correct in colour, but that the badge could only be obtained from the Grand Clothing Hall, Preston.

After the meeting a representative company of members numbering 102 sat down to dinner in the School Assembly Hall. The customary toasts were duly honoured. Mr. Albert Hodgson proved an excellent entertainer, and a very festive and congenial evening was spent.

In the afternoon the annual football match, Past v. Present, was played. The Old Boys won a very hardly contested game by 8 points to 6.

In Memoriam Benjamin Stuttard.


A link with the past has been broken by the death at the age of 90 of Mr. Benjamin Stuttard. He was a master at K. G. S. from 1866 to 1885 and those who remember him in this capacity will bear witness to the kindness of his personality. To the end he retained his interest in the old school and every year gave his prizes for English. In 1924 he was elected an Honorary Life Member of K.G.S. Old Boys Association.

In Memoriam T. V. Barker.

Many will remember the great pleasure given by the visit of Dr. T. V. Barker and Mrs. Barker in July 1928, when Dr. Barker presented the prizes at his old school.

It was a grievous shock to hear of his early death on April 15th, 1931, the result of an operation involving the amputation of his leg.

We are indebted to the Rev. C. M. E. Hicks for the following appreciation. T. V. Barker and C. M. E. Hicks were schoolfellows at K.G.S. and undergraduates together at Oxford, and the latter had the sad privilege of assisting at the funeral of his distinguished friend.

"T. V. Barker's career was a distinguished one. included a Senior Demyship at Magdalen in 1905, followed by a Research Fellowship at Brasenose in 1913. He had also developed a great grasp of business methods and principles, and these had some scope when in 1921 he was appointed Secretary to the Delegates of the University Museum and when in 1926 many of the arrangements for the visit of the British Association to Oxford fell upon him. In 1928, he was asked to become Secretary to the Curators of the University Chest, in charge that is of the business of the University. He had already made a name for himself in the world of Science. In 1904 he gained 2nd Class Honours in the Final School of Natural Science with distinction in Mineralogy and Crystallography. He was led increasingly to research in crystallography and ultimately in 1908 went to Petrograd-to continue research work under Professor E. S. Fedorov. Incidentally he had had to learn the Russian language but to good purpose, because when he was taken from us he had started on a work that would have been of the greatest value and importance to crystallographers. He found that Professor Fedorov had evolved a system for the classification of crystals, but that it was too complicated to be of practical or general use. Eventually Dr. Barker (he took his Doctorate in Science in 1924), during fifteen years worked out a fresh and simpler but comprehensive system and published the principles of the classification. Last year he put out "The Study of Crystals" and "Systematic Crystallography" (Murby & Co.) and he was to have been engaged during the next five years in the completion of a large Dictionary of the angles of all crystal substances measured. His system was becoming known, as witness the fact that quite recently a Dutch scientist came to Oxford purposely to learn the system from him: and ultimately it would have been generally adopted. His activities were very varied, as shown by the positions he held in addition to those already mentioned. Amongst other offices held he was a Curator of the Bodleian Library, a Member of the Committee of Management of the Lewis Evans Collection, one of the Board of Electors to the Professorship of Geology, a Co-opted member of the Faculty of Physical Science, and a member of the Council of Somerville College for Women, Oxford. But I doubt if even in these matters, important and varied as they are—lay his chief talent. For outstanding in his character was a genuine love of his fellows, that found its continual satisfaction in his kindly and genial treatment of all who came in contact with him. He was fundamentally large-minded and his capacity for interest in, and work for, his friends seemed steadily to grow.

His body was laid to rest on a beautiful spring Saturday afternoon at Wolvercote Cemetery, just outside Oxford. The showers of April were kind to us, and the whole setting seemed to me just right. Oxford on a Saturday afternoon in Vacation represented the shared claims of the University and the outside world in his life; the Spring reminded me of the vigour of his still expanding powers, now transferred, as we Christians can confidently believe, to a sphere of enlarged usefulness; and Nature in storm-cloud, sunshine and opening bud, told me of that glorious field of adventure and discovery, in which his mind so steadily worked."

A tablet bearing the following inscription is to be placed in the pavilion, "The Clock is to the memory of Alfred Vincent Catterall, who was at K.G.S. 1891-7, and a Governor of the School from 1921 until his death July 29th, 1925.—given by his family."

We render most sincere thanks to Mrs. Catterall and the family for this benefaction. It commemorates most fittingly one who as man and boy was a lover of K.G.S. and a great sportsman.

The Gala.

It remains to raise some £200 to clear the debt on the Pavilion. We are hoping to do this on August 1st, when a Grand Gala is to be held on the School Playing Field. In addition to all the usual attractions there will be a wonderful parade of local Rose Queens, and a competition for children under 16 for the best cotton dress. The Kirkham Women's Institute are giving a series of excellent dramatic performances in the School Assembly Hall. There will be a most attractive array of side-shows and competitions. The boys of the School have sold more than 2,000 tickets. We hope for fine weather and we ask all Old Boys to make a special point of turning up with their friends.
