Editorial.

EBSTER'S dictionary thus defines the meaning of the word school,—"a place for instruction in any branch or branches of knowledge, an establishment for imparting education"; also, "the institution or collective body of teachers and learners in such a place." We at K.G.S. fulfil all this-ay, and much more. This definition falls far short of adequate description. It takes not into account the Old Boys, and Old Boys are a very real and important part of a school. At such times as Old Boys of K.G.S. gather in any numbers one feels intensely the greatness of this school. It is not the mere meeting with some son of K.G.S. who has achieved success or won fame, but rather the knowledge that year after year, there steadily flows out of this school into many places far and near, to fulfil many and various parts, a stream of youth, bearing the spirit of K.G.S.—the spirit of courage and endeavour, faith and comradeship, high honour and resolve—men likely to play the game of life with gallant hearts and clean hands, and in a manner that belongs to the realm of the unseen, the spirit of this place inspires them and binds them together and the returning hither renews and revives old joys, old hopes—the memory of forgotten things and battles long ago. School life here is big-we are not

merely a place for instruction in branches of knowledge. K.G.S. demands a sovereign place in the whole life of her sons—body, mind, and spirit—while they are here, and when they fare forth into the world her spirit follows them, and she in turn is not forgotten. Freely she gave to you of all the riches of her power and spirit, freely you gave to her of your endeavour and your loyalty, your effort in classroom and in field—for School, for House, you lived and loved. The sacred bond thus formed is not easily broken. No ties pull at the heart strings of the free-born Briton more tensely than those of Country, Home, and School.

Some there may be who never feel this—some there may be with us but not of us,—but they are few. Some there be who in their days at school showed that the spirit of K.G.S. lived and shone in them and yet they have not kept up any active association with their old school. We would welcome them home. Many there are—and K.G.S. rejoices in them—whose affection and interest binds them with cords that cannot be broken. Proud of their membership of a great school and glorying in a brotherhood that links them with the noble past and identifies them with all the hopes of a yet more noble future, they keep the old school in their hearts and are glad, when they can revisit a place to memory dear. To such this spirit of K.G.S. is a powerful influence in life—something that cannot be put into words, something that is sanctified in our hearts.

The rolling years often, alas, deal hardly with our ideals, and the happy illusions of youth grind on the hard rocks of experience, but happy is the man who never loses the sweet remembrance of boyhood's days, who keeps with him in all the vicissitudes of life the comradeship, the spirit, the call of his old school.

Mr. S. Middleton joined the staff in January, 1928. He is a B.A. of the University of Durham and has represented his County at Rugby Football.

The Lancashire Education Committee, which for many years has made grants in aid, assumed full financial responsibility for the School from the 1st April, 1928.

Doctor and Mrs. Matthews, of Freckleton, have endowed a prize in memory of their son, James L. Matthews, to be awarded annually, not necessarily to the best scholar but to the boy who shows the best spirit of endeavour in the Agricultural Form.

A row of thirty trees has been planted on the east side of the field. Each tree is the gift of a boy in memory of his days at K.G.S.

An interesting gift has been received from the Weights and Measures Department of the Lancashire County Council. This consists of obsolete weights and measures, including a standard yard and a set of measures of capacity from 1 bushel to $\frac{1}{4}$ gill and weights from 1 lb. to 56 lbs.

A most interesting gift has been made to the School by the Kirkham Women's Institute. This is a needlework picture, the work of the members of the Institute, depicting a scene in the early days of the school, thus described in an old manuscript, "The 30 men of the parish being assembled at the Church, Isabell Birley, with 30 l. in her aporon, came to them telling them she had brought that money to give it towards the erecting of a free schole for pore children, wishing them to take it and consider it."

Mr. H. C. Turner (1916-23) has given an honours board to record the Captains of the Lytham House.

Cricket, 1927.

This year's XI., while technically the most proficient we have had in recent years, were so liable to collapse if the first wicket or two fell cheaply, that a season in which we hoped to win all our matches had a result of five wins and five losses.

Their most formidable opponents were the Arnold House XI.—an exceptionally good school side. In the first match our XI. showed their worst form and were routed; the tables were turned however in the return fixture.

Matches were won against Arnold House (1), Hutton Grammar School (1), Lancaster Grammar School 2nd XI. (1), The Master's XI. (1), and the Old Boys (1).

Matches were lost against Arnold House (1), Blackpool Secondary School (2), Hutton Grammar School (1), and Preston Grammar School (1).

White was a most able captain and one of the best allround cricketers we have ever had. Park, on form, was a very good fast bowler, but one who was apt to lose his length if hit. His performance against Arnold House—seven wickets for nine runs, shows how good his best could be. Harrison was a most plucky cricketer who put his whole heart into whatever he did—whether batting, bowling, or fielding. Rawstron, apart from two good innings, had rather a disappointing season.

The Second XI. was in every way the best Second XI. we have had. Livsey was a very able captain and gave his team a splendid example in the field. Their record was four wins and three losses.

The House matches were up to the usual standard. In the Senior competition the bowling of White and Park (Blackpool House) proved too much for any of the rival Houses. The final was contested between the Blackpool House and the School House and resulted in an easy win for Blackpool.

The final of the Junior House competition resulted in a tie, the scores being: Kirkham House 36 and 54 and Lytham House 25 and 65.

Swimming, 1927.

Rugby Football, 1927-28.

The season is one on which we can look back with great satisfaction.

We were fortunate in having in the side several of the previous year's XV., and especially fortunate in that White—at stand off half—was again the Captain, and an admirable Captain too.

The XV. proved sound in all departments of the game and undoubtedly touched the high watermark of K.G.S. Rugby Football.

Hutton G.S. 1st XV. and Lancaster R.G.S. 2nd XV. were beaten twice each—the latter very decisively, and Wigan G.S. were beaten at Kirkham but had their revenge at Wigan.

Blackpool Secondary School 1st XV. proved our masters in four encounters, two of which were very closely contested games.

There was only one Club fixture v. Thornton R. F. C. who narrowly beat us twice.

The Old Boys' match was splendid, resulting in a win for the School by 8 points to nil.

A new and valued fixture was that against Giggleswick School 2nd XV., played at Giggleswick in appalling weather conditions. The game itself was a heroic struggle in which we were just beaten by 9 points to 8.

Next year we shall welcome them at Kirkham when we hope to reverse this result.

A total result of 6 matches won and 8 lost does not reflect the true merit of the XV. as much as the aggregate number of points—138 "for" and 108 "against."

The "A" XV. had four overwhelming victories over Thornton 2nd XV.

The 2nd XV. defeated Blackpool S.S. 2nd XV. in each of their three encounters, a fine performance which augurs well for the future.

Sports, 1928.

The 29th Annual Sports Meeting was held on Wednesday, May 23rd.

The weather was rather cool and somewhat wet.

The keenness shown in the past in the most important events was equalled, if not excelled. This was due probably to the evenness of several Houses. So close was the contest for the House Trophy that the last event decided the winners. The School House were the victors with 84 points, Kirkham and Blackpool were close up with 74 and 68 respectively.

F. White was a popular winner of the Victor Ludorum Cup with 36 points, Hudson being second with 24 points.

White secured four firsts: 100 yds., Hurdles, 220 yds., and $\frac{1}{4}$ mile.

The Cross Country was run off in the Spring Term. G. A. Salthouse was first Home in the Senior event and L. F. Heathcote in the Junior.

The Kirkham House won both events with Lytham the runners-up.

Putting the Weight was introduced as a new event, displacing Throwing the Cricket Ball.

A K.G.S. record was established in the Long Jump, Marsland reaching 18 ft. $11\frac{1}{2}$ inches.

H. Taylor won the Old Boys' Race, R. S. Crozier being second.

PRINCIPAL EVENTS.

Prize Day, 1927.

Prize Day was held on July 27th. The prizes were presented by T. V. Barker, Esq., Doctor of Science and Fellow of Brasenose College, Oxford, an Old Boy, who had been at K.G.S. 1893-98.

The Chairman of the Governors (the Rev. W. T. Mitton), who presided, referred to the dangers that came in the train of civilisation. It was important in every advance of progress that simplicity and not luxury should be the aim.

The Headmaster (the Rev. C. Strange) in his eighth annual report, after referring in detail to the fine record of successes gained during the past year, drew attention to the fact that the year had called for unusual effort to maintain the high level. He considered this was due to the fact that the generation now passing through the school was composed of

children whose early years had been lived under the abnormal stress and conditions of war. The result was that a great many young people to-day were utterly casual, nice, pleasant, no trouble—do all that they are told to do, up to a point—but untroubled by success or failure, unenthusiastic, fatalistic, without drive, without ambition, content to be passable, satisfied to get through and have a moderately good time. A generation with most wonderful opportunities of knowledge, of understanding, of entering into realms of truth and beauty and righteousness, with unparalleled calls to fit itself for service, a generation which is on the threshold of a new and glorious world, was in danger of drifting into a state of conceited idleness and indifference, too lazy, too feeble, too bored to enter into the promised land.

It was their aim and endeavour at K.G.S. to lead the opening mind and soul to clear thinking and straight dealing, to give them a glimpse of the vast field of possibility that lies before the human intellect and soul, to train them to a sense of responsibility, to inculcate lessons of endurance and perseverance. The times were difficult, alike for parents and for The old patriarchal days were gone. Obedience and discipline to be of any use must be enforced by more than They did not regret that it was so. physical force. matter for rejoicing that home and school were more human than they used to be. But greater responsibility was laid upon teacher and parent. In place of unreasoning force that imposes its will upon the weaker was needed a new strength of example, the appeal to that which is of true worth, that which in itself is good and beautiful. This was a hard thing. dom was in some respects harder than servitude. But licence was not freedom. He appealed to his boys "Because you are free do not be slack. Because you are not driven therefore go faster than if you were. Because to you much is given, therefore of you shall much be required." He appealed to parents "Because the times are out of joint, because old ways have gone, do not let your children go their own way. Without

severity you can show that laziness and slackness are ignoble, that manners matter, that right is very different from wrong." He was no pessimist. He had the utmost faith in the rising generation. But he believed the dangers of the present age were most serious and he desired to see more signs in the youth of to-day that they were made of sterner stuff.

Mr. Strange then referred to the active part played in the school life by the Old Boys and enumerated a list of honours they had won. He spoke with regret of the loss by death of an old boy, Mr. J. S. Charlton, the son of a former master of the school. After alluding to various useful improvements in the school premises, the Headmaster paid a tribute of gratitude to the great help in the working of the school which he received from Mrs. Strange, the Governors, his colleagues, and the parents.

In concluding he emphasised the great heritage the school possessed in its traditions and history extending over nearly 400 years. He claimed that a foundation so ancient and honourable was one that deserved to have the dignity of a Coat of Arms. He had approached the College of Heralds and been informed that K.G.S. was a body to whom a Coat of Arms could be issued. The cost would amount to £129. He would be happy to contribute £10 for this purpose and believed that there were many others to whom this idea would appeal, and who would assist him in carrying it into effect.

Dr. Barker in a very happy speech delighted his hearers by his reminiscences of his days at K.G.S. It was delightful to realise the pleasure it gave him to revisit his old school—a pleasure which he communicated to all who were present.

Annual Meeting and Dinner, 1927.

Whist Drive.


On January 18th, 1928, the annual Whist Drive was held and proved as usual a very happy gathering. Members and their guests numbered 62. The prize winners were as follows:
