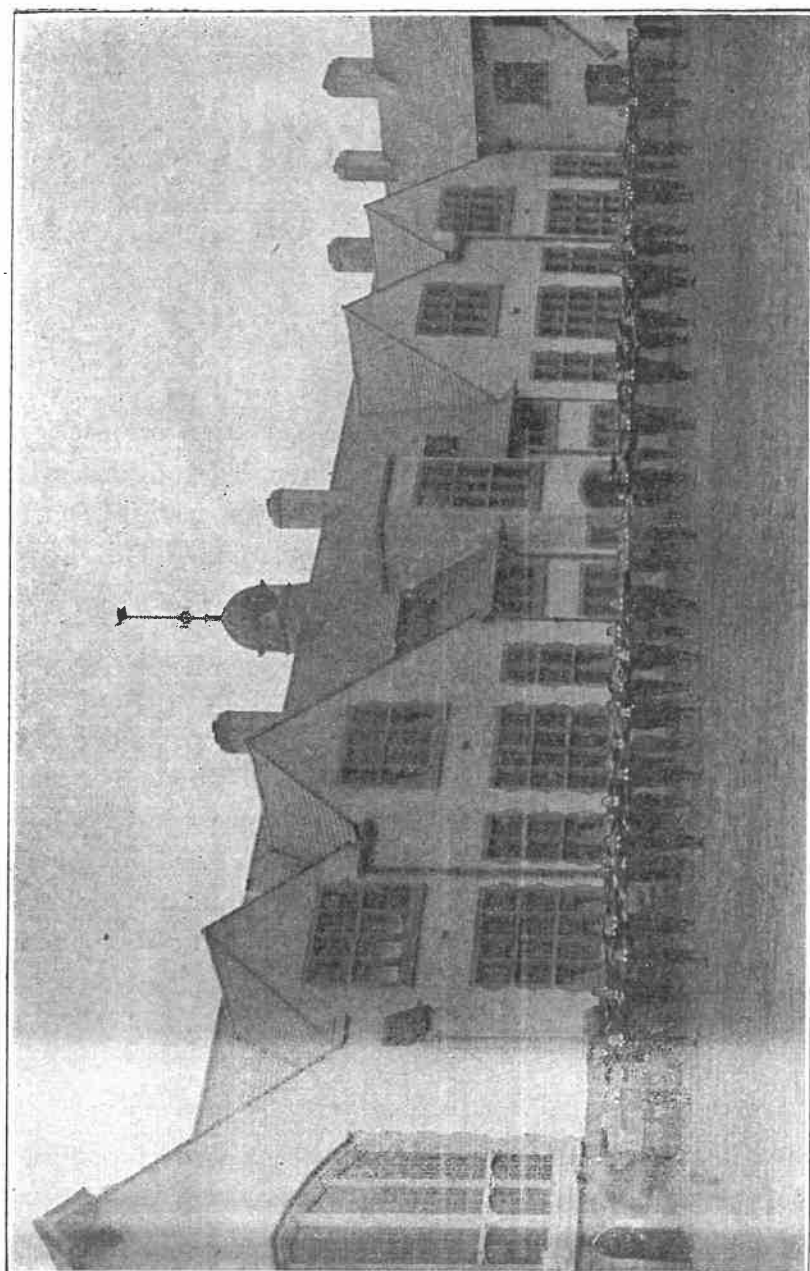

The War Memorial.

School Notes.

THE number of boys in attendance (January, 1921), is 176.

In the Senior Cambridge Local Examination (July, 1920) eight certificates were gained—H. Tomlinson (2nd class honours), J. Dandy, G. E. Wylie, J. Glover, L. Daniels, E. Ainsworth, E. B. Duckworth and C. E. Eccles.

A new form, parallel with IV. A., to enable boys to study Agriculture, was opened in September, 1920.

Miss F. G. Stephens, one of the ladies who rendered such valuable service to K.G.S. during the war, has returned in Miss Budden's place.

Mr. G. T. R. Harding, who was trained at the Harper Adams Agricultural College, has joined the staff, and has charge of the Agricultural Form.

The Rev. G. S. Smith left at Easter and his place has been taken by Mr. G. Hughes, B.A., of the University of Wales. Mr. Hughes served with distinction in the War and was awarded the Military Cross for gallantry in the field.

Prize Day will be July 27—the Vice-Chancellor of Liverpool University has promised to present the prizes.

The Sports, 1920.

THE only thing lacking in order to make the Sports on May 19th a complete success was kindly weather. The rain poured down all the morning, and though at 3 o'clock the weather cleared and made it possible to run off many events, yet the state of the ground spoiled the pleasure of many onlookers.

The cross-country race was won by the Lytham House, with Crozier first man home. Crozier won the 100 yards, the Quarter, the Half-mile, High Jump, Hurdles, and Mile, and was second in the Long Jump. He secured the Championship with 59 points. The Lytham House won the Championship Cup with 81 points, the Fylde being runners-up with 71.

The Old Boys' Race (Quarter Mile Handicap) was won by G. C. Wilson, after a hard race with J. L. Tomlinson.

The most notable performance was Crozier's High Jump of 5ft.

The Cricket Season, 1920.

THE Cricket Season proved on the whole a satisfactory one. Mr. Budden's coaching has been most valuable. Dewhirst is a batsman of decided promise, Tomlinson a most refreshing hitter, and Bamford a most correct and painstaking player, if somewhat lacking in enterprise. An accident to Clothier at the beginning of the season robbed the bowling of a most valuable player, but Wylie and Crozier did a lot of useful work.

Victories were gained over Arnold House (twice), Hutton Grammar School, and Wrea Green II., and losses recorded to Preston Grammar School (twice), the Masters, the Old Boys, and Mr. A. Ward's XI.

The Cricket Shield was won by the School House by decisive victories in succession over the Blackpool, Fylde, and Lytham Houses.

Swimming.

Full use was made of the opportunities afforded last summer. By the end of the season 36 boys could swim at least one length of the bath, while 16 more could swim a breadth. The House Cup was decided by a system of points, awarded partly on the number who could swim and partly on the result of a team race.

Football, 1920-21.

The First XI. was only moderate in character : good in defence ; with a brilliant goalkeeper in Crozier, but generally weak in attack.

Three School matches were won and nine lost, Arnold House being beaten twice and Hutton once, whilst the defeats were from Preston (4) Blackpool Secondary (2) Arnold House (2) and Hutton (1).

Apart from Inter-School matches closely contested games were played with Mr. J. Winchester's XI. from Freckleton.

The annual match against the Old Boys resulted in a win for the latter by 7 goals to 2.

The House Shield was won by the Blackpool House, who also carried off the Junior Football Cup.

Prize Day, 1920.

IN spite of uncertain weather, a large gathering assembled at the School on July 28th, on the occasion of the annual prize day. The Rev. W. T. Mitton, Chairman of the Governors presided, and called upon parents to show an active interest and co-operation in their sons' education.

The HEADMASTER, in presenting his report, claimed that the past year had shown marked progress, and the future was bright with promise. The School had increased in numbers from 130 to 152. Steps had been taken to provide an additional class room, so that the School would accommodate 180 boys. The most valuable feature of the past year had been consolidation of the great work of the past. They were also preparing to advance. His aim was to make the school a centre of secondary education, before all else and above all others, valuable to the Fylde. Among the chief glories of the Fylde were its up-to-date and scientifically managed farms, and the future farmers of the country would need all the assistance that science and knowledge could give. Agriculture was fast establishing itself as a learned profession. His aim was that the School, in addition to teaching general culture, should also provide an opportunity for agricultural education. They hoped to open in September a class corresponding to the present Upper Fourth, which would provide especially for boys destined for agricultural pursuits.

The HEADMASTER then detailed the successes of the past year and spoke of the loyal support he had received from the staff, and concluded with a tribute to the fine spirit of the School, a glorious heritage from the past, which they held dear and clung to as their most treasured possession.

Mr. G. H. GATER, Director of Education for the County, spoke of the immense value of the fine old tradition possessed by Kirkham Grammar School. They had a magnificent

heritage and one they should never forget. The Governors were to be congratulated on the way they had overcome the difficulties of the past few years. It was a fine ideal to realise that the School could be the School for the whole Fylde, and nothing would do more to win the confidence of the farmers than to show that they had the agricultural interests at heart. He hoped that the proposed extension of an agricultural class would result in farmers sending their sons to the School and keeping them there long enough to get the full value of the course. Mr. Gater made a strong appeal to parents to keep their boys for at least five years at a secondary school.

Mr. Gater then presented the prizes.

It was good to see a number of Old Boys present at the gathering.



Some Early Historical Notes on F.G.S.

NO papers have so far been discovered throwing any light upon the origin of the Free Grammar School and the earliest intimation of its existence is in 1551, when Thomas Clifton, of Westby, bequeathed "towards the grammar schole xxs." Thirty-four years later it was arranged amongst the "Thirty Men" that 40s. taken out of the Clerk's wages should be paid to the schoolmaster, and that four of the "Thirty Men," in the name of the rest, should take possession of the school-house in right of the whole parish to be kept in repair by it, and used as a school-house; also that, "Richard Wilkins, now schoolmaster," should be retained in his office for a year or longer.

The history of the school then dates from the period 1621 to 1663. In an old manuscript it is recorded how one Isabell Birley, being moved with a natural compassion to poor children she saw in the town, in the year 1621 came to the Thirty Men of the Parish, then assembled in the church, with £30 in her apron towards the erection of a free school for poor children, to be taught gratis. She also urged them to move their several townships to contribute every one something towards the accomplishment of so charitable a work. The gift was thankfully accepted, and the result of their several endeavours, especially one Mr. John Parker, of Bredkirk, was the collection of £170 14s. 0d. towards the erection of a school.

The first schoolmaster selected by the Thirty Men was a Mr. Thomas Armested, and on his resignation in 1628 he was succeeded by a Mr. Sokell.

During the struggles between King and Parliament, the school was closed for several years, and re-opened with fresh governors or feoffees. At that epoch the inhabitants were in a state of constant excitement and alarm by visits from either the Royal or Parliamentary forces, but fortunately no collision ever took place in the neighbourhood.

By the will, dated 1655, of Henry Colborne, of London, a native of Kirkham, his trustees were requested to purchase the lease of the rectory of Kirkham, and invest the profits, with the exception of £100 per annum for sixteen years, in lands for the benefit of schools, the purchases to be settled on the Drapers' Company, of London. In 1673, £69 10s. 0d. was obtained for the school, being the rent of lands bought in the Metropolis by the Colborne trustees, £45 of which sum had to be paid to the Headmaster, who was required to be "a University man, and obliged to preach once a month at least in the Parish Church or in some of the chapels;" £16 16s. of the remainder was apportioned to the second master, and £8 to provide an usher.

In 1673 it was decreed by the Court of Chancery that the expense and duty of preserving the school-house in proper repair should devolve upon the township of Kirkham, whilst the election of masters should rest exclusively with the Drapers' Company. In the same year also lands, etc., at Nether Methop, in Westmorland, to the value of £550 were purchased, according to the directions of the will of the Rev. Jas. Barker, rector of Thrandeston, Suffolk, which required his executors to buy lands sufficient to yield an annual rent of £30, to be paid partly to the schoolmaster and partly as an exhibition or allowance to such poor scholar of the town as shall be admitted to the University.

In 1725 £400 was bequeathed to the trustees of the school by William Grimbaldson, M.D. In addition he left £50 to be invested and the income to be spent in buying classical books for the school.

At the Annual Meeting the President reported the progress made during the first year of the Association's existence.

The Committee for the ensuing year were elected, viz :— The President, the Hon. Secretary, and Messrs. A. V. Catterall, W. J. Plant, T. V. Goodier, Jas. Rigby, and H. Parkinson, senr. A hearty vote of thanks was passed to Mr. J. H. Rigby for his indefatigable work as hon. secretary and treasurer, and he was unanimously re-elected.

A design for an oak chair as a memorial from the Old Boys to the late Headmaster was submitted to the meeting and approved. Mr. T. V. Goodier expressed the view that there were still old boys desirous of associating themselves with this memorial, and asked that the subscription list should be kept open a little longer.

Subsequently some 70 members attended the dinner. A very enjoyable evening was spent. The toasts of "The King," "The School," "The Governors," "The Association," "The Masters Past and Present" were duly honoured.

Whist Drive.

On January 5th, a Whist Drive was held at the school. Members welcomed this opportunity to entertain their lady friends. Play took place in the Assembly Hall, and refreshments were served in the Dining Hall. A most enjoyable evening was spent, and the arrangements reflected great credit on the indefatigable Hon. Sec.
