

Judged by the results of matches, the Football XI was most disappointing, but this was mainly due to the inability of the forwards to score goals. The school is extraordinarily lacking in forwards. With a very sound defence it was most disappointing to be able to produce no powers of attack. At centre half Bamford often won admiration. Only two school matches were won, two were drawn and seven lost. Hutton Grammar School and Arnold House were beaten, drawn games played with Hutton Grammar School and Arnold House, whilst defeats were inflicted by Preston Grammar School (3), Blackpool Secondary School (2), and Arnold House (2). Only 14 goals were scored against 40.

The Old Boys' Match on Nov. 23rd resulted in a drawn game of 4 goals each.

Walter Yates, M.C. writes from Benoni, Transvaal, where he has been for the last 18 months engaged as the Senior Assistant at Benoni Central School, which has an enrolment of 1,100 Children, and a Staff of 28 Teachers. Ten years ago there were only three schools in the whole of the East Rand, with enrolment of 250, now there are 6 in Benoni alone. Benoni is only about 14 years old and is known as "The Hub of the Golden East," with a population of 27,000 whites, and about 75,000 natives, is the 11th largest in the Union, and the 5th as regards revenue.

Prize Day, 1921.

[From the Preston Guardian, July 30th, 1921.]

The Annual Distribution of Prizes in connection with Kirkham Grammar School took place on July 27th, in the Assembly Hall of the School, in the presence of a large gathering, over which the Chairman of the Governors (Rev. Welbury T. Mitton) presided. Supporting him on the platform were the Rev. C. Fullerton Smith, Rev. R. W. M. Holme, the Headmaster (Rev. Cresswell Strange), and Dr. Adami, Vice-Chancellor of Liverpool University, who distributed the prizes.

The Chairman said that that was the 18th occasion he had occupied that position. They, as governors, had every reason to congratulate themselves on the success of the school.

The Headmaster, in his annual report, said that during the past year they had reached the high water mark—183—which represented the full capacity of their accommodation, and from the many applications received he had no fear they would lack their full complement. The figure was remarkable when they reflected that when the school entered those new buildings ten years ago there were 64 boys in the school. At the same time he could claim that they had more than maintained their standard of work. Twelve months ago he mentioned their hope of opening a special agricultural class. That had become an accomplished fact, and deserved special mention. The specialised work that that class had done had proved a success.

Boys had learned something which would be useful in their future careers, and educationally it had proved most valuable in bringing out the development of some boys who showed themselves very unresponsive to the ordinary secondary school teaching. But the number of boys destined for agricultural pursuits was limited, and the majority of the pupils of the schools were bent on other callings. The scheme had the interest and support of the Lancashire Education Committee.

As to the School as a whole, he felt they had worked well, played well, and maintained the high reputation and public spirit that they had inherited from the past. He did not think there was a school in the land wherein happier relations existed between boys and masters. The demand made for boarding accommodation was very great. He had 20 names of boys waiting for vacancies. The tendency to withdraw boys from school before they have fulfilled a complete course was still noticeable. It was not

fair to send a boy to a school like the Kirkham Grammar School unless there was a reasonable expectation of keeping him there until he reached at least the age of 16 years.

The Old Boys' Association continued to flourish, and was a source of strength to the school. During the coming year the Old Boys hoped to complete two memorials which they have in hand to the memory of their late headmaster, and to their comrades who fell in the war. In the field of games and sports the school had again done well. An event, which he must place on record, and which would live in the history of their School, was the visit of the Prince of Wales. In conclusion, Mr. Strange said he had in the Governors a body of gentlemen who gave him their full confidence and full support, and he could not speak too highly of his colleagues' ability, loyalty, and co-operation.

Dr. Adami said that after some 25 years' life in Canada one thing that impressed him was the marked development of secondary education in Lancashire, and of the enthusiasm of the teaching staffs attached to them. There was far better training in their small grammar schools and city secondary schools than in some of their old public schools. He agreed with the headmaster that it was a mistake to take boys away from school before they reached their 16th or 17th year. It was about the 14th year when a boy began to think and take in things, and to take the boy away at that age was to take him away just as he was about to digest what he had learned during his earlier years. It was not essential for business that a person be a walking dictionary. It was not facts that told but the power to apply those facts that was required.

Votes of thanks were accorded the Chairman and Dr. Adami.

Unnual Meeting and Dinner, 1921.

The Annual Meeting and Dinner were held at the School on November 23rd.

In the afternoon a good game between the School and the Association resulted in a draw of 4 goals each. The following represented the Old Boys: A. V. Catterall, J. Humber, L. P. Salisbury, J. At the Annual Meeting: -

The Minutes of the previous meeting and the Balance Sheet for the year were read and approved.

The Committee for the ensuing year were elected, viz.: The President, the Hon. Secretary, and Messrs. A. V. Catterall, W. J. Plant, T. V. Goodier, H. Parkinson (senr.), and R. S. Crozier.

A hearty vote of thanks was passed to Mr. J. H. Rigby for his valuable services as the Hon. Secretary and Treasurer, and he was unanimously re-elected.

A vote was passed expressing the deep regret and sense of loss that the Association had sustained by the death of Mr. Hutton Birley and Mr. James Rigby.

It was decided that steps should be taken to have hat bands and cricket blazers manufactured in the Association Colours.

Subsequently a representative gathering sat down to dinner in the school dining hall. The customary toasts were duly honoured, and an excellent musical programme completed an enjoyable evening.



The Memorials.

[From the Preston Guardian, March 25th, 1922.]

In the Assembly Hall of the Kirkham Grammar School, on March 23rd, a war memorial to the students who fell in the war, and an oak chair, the gift of Old Boys in memory of the late Headmaster (Rev. T. C. Walton, M.A.), were unveiled and dedicated in the presence of a large gathering of governors, relatives of those who fell, old boys, and boys of the school. The memorial to the fallen is a cast bronze tablet on which is inscribed the names of those who made the supreme sacrifice. The oak chair, of beautiful carved design, bears the following inscription:—"The gift of the Old Boys of K.G.S. in grateful memory of the Rev. T. C. Walton, M.A., Headmaster 1905-1919."

The names inscribed on the tablet are: —W. P. Allen, W. Bateson, C. C. Bolton, A. Boulton, A. R. H. Bowdler, D. H. Davies, W. C. Duckworth, R. Haworth, T. Hayhurst, J. K. Jackson, M. Jones, G. C. Lancaster, A. E. Milner, W. Muirhead, J. Murray, G. E. Sprake, G. Tomlinson, G. L. Uniacke, J. S. Walker, H. Wane, B. Ward.

The proceedings were presided over by the Headmaster (Rev. Cresswell Strange, M.A.), and opened with the singing of "O God, our help in ages past."

The Headmaster, addressing the assembly, said they were met to dedicate two memorials to the lasting honour and memory of members of the school who had laid down their lives in service. The bronze tablet recorded the names of those who died in the Great War, and was the gift of past and present members of the school, to the memory of their old comrades. The committee decided that only the names of those who served overseas and died there, or subsequently as a result of their service, should be recorded. It had been a difficult matter to ensure that no names be omitted. In spite

of every effort, however, he had during the past week heard of two names which ought to have been included and were not: S. Davies and H. Howard, both of them old boys who fell in battle. The second memorial was a carved oak chair given by the old boys in memory of the late Headmaster (the Rev. T. C. Walton). In connection with both memorials he desired to mention with gratitude the work of Mr. J. H. Rigby, the Hon. Secretary of the Old Boys' Association, Mr. S. Greenhalgh, and Mr. T. V. Goodier, who were appointed secretaries of the memorial to Mr. Walton before the Old Boys' Association had come into existence.

It was a great list: great in the weight of sacrifice, great in the magnificence of spirit of those who hazarded their lives unto the death, great in its power of inspiration. Of the hundreds from the school who went and fought and suffered, those 24 were taken. Those were the men who paid the full price. To many of them they were well-known, appreciated, and loved. He could recall many of them in their boyhood days at school—young and beautiful lives, filled with the joy and promise of youth. They were tried as gold was tried, in the fire, and they were not found wanting. "In silent reverence, with bowed heads and hushed lips, we stand in their honour, for no words can express the pride and honour that we feel for them."

Speaking to parents and relatives, he said he believed they were proud that day, but it must be a renewing of their grief. To them they said, "This school, which cherished once your loved one, shares with you your grief and your pride. Each one of them was ours as well as yours. Yours is the grief too sacred for any man to intrude upon with words, but we would have you know that in this school they shall be held in lasting remembrance. They have not died in vain. Like the Divine Master, they died that we might have life, and that we might have it more abundantly."

And was it not fitting and seemly that at the same time when they honoured the memory of those gallant soldiers they should honour the memory of one who was an inspiring force in the lives of many of them? What he had said of them he said of him; their lives were laid down upon the field of battle, his in the field of peace; but, alike, both his and theirs, upon the field of devoted service. That great and good man, who for 14 years was headmaster of the school, was one of life's true warriors, and it was fitting that that day they linked his remembrance with that of the brave boys that he had trained in the true purpose of life. school was his enduring memorial—there he lived, and long would his spirit inspire them there, and many a life that had gone forth from there to fields afar. His old boys made grateful tribute to his memory that day, and linked most closely therewith true sympathy with Mrs. Walton and their son and daughter.

The tablet was then unveiled by Captain W. J. Plant, L.N.L., an old boy, and the Chairman, in introducing him, said that Captain Plant was one of four brothers who had attended that school. Every one of them had a fine school record, and a fine record on the field of battle. It was therefore very appropriate that an old boy, a real soldier, should unveil the memorial that day.

After the unveiling, a bugler from the L.N.L. sounded the "Last Post."

The Chairman of Governors (Rev. W. Mitton, R.D., Rector of Kirkham), on behalf of the school, accepted the tablet, and dedicated it "to the glory of God, and in memory of the old boys and masters who gave their lives in the war." He said he knew most of the boys, many of them personally. Men, such as they were met to honour, were men who had helped to make the country great, and it was a true saying that the greatness of a country depended upon the people of the country. There was no greater country than England, as history showed.

Mr. S. Greenhalgh unveiled the oak chair, and Mr. Mitton, in accepting it, on behalf of the Governors, said that when he first met Mr. Walton he was full of enthusiasm, and it was that enthusiasm which enkindled enthusiasm in others. He was always bringing up new ideas and theories, and every one of them added greatly to the present prosperity of the school. He was very proud to have been associated with the work of Mr. Walton, who was willing and able, and a man of great ability in every way.

A presentation took place just before the close of the proceedings, Mr. T. V. Goodier, an old boy, presenting Mrs. Walton with a silver rose bowl, as a token of appreciation by the old boys for the able assistance Mrs. Walton rendered the headmaster.

Mrs. Walton, who was greatly touched, in accepting the gift, said: "I can only thank you very much, for I appreciate it very much indeed."

The proceedings closed with prayer and the singing of of the National Anthem.

Note.—Another name omitted from the War Memorial was received later, that of T. B. Frankland. It is gratifying to learn that this and the two previously referred to can be quite satisfactorily added to the tablet. The work is being put in hand at once.


