




Prize Day.—July 25th. The Bishop of Manchester has promised to present the Prizes.

The Sports, 1922.

Delightful weather favoured the Sports on May 24th, and the gathering was a record one. The entries were larger than in previous years, and the competition was keen, and the running good.

The Cross Country Race was won by the Lytham House, with Kirkham House as runners-up. Tomlinson was the first man home, the time being 25 mins.

The Victor Ludorum Cup was won by H. Tomlinson, who won the Long Jump, taking second place in the 100 yds. the Quarter Mile, the Half Mile, the Mile, and third place in the High Jump, totalling 44 points: Maxwell, who won the

Mile, Half-Mile, the Quarter-Mile, and the 100 yards was second, with 41 points.

The Fylde won the House Cup with 93 points, the Kirkham House being second with 72 points.

The Old Boys' Race (220 yds.) was won by R. S. Crozier.

The Cricket Season, 1922.

The Cricket XI showed a decided advance on that of previous years in batting. Bamford's innings of 46 not out, against Hutton, and 33 against Arnold House, were really first rate. The bowling was not perhaps so consistently good as in 1921, but the fielding showed improvement, Bamford in particular excelling at point.

Victories were gained over Blackpool Secondary School and Hutton Grammar School, and losses recorded against Arnold House, Wrea Green, and the Old Boys. The return match with Hutton was abandoned owing to rain, with the Kirkham score standing at 60 for 8 wickets, and the matches against Preston Grammar School had, most unfortunately, to be cancelled.

Swimming, 1922.

Very excellent use was made of the opportunities for Swimming. By the end of the Season 69 boys could swim at least one length of the Bath, while 21 more could swim a breadth.

In awarding the House Cup, 3 points are given for each boy who can swim a length, and one point for each boy who can swim a breadth; in addition there is a team race, the winners taking 30 points.

The result was as follows:—School House, 95 points; Lytham, 72; Kirkham, 53; Blackpool, 51; Fylde, 32.

Shooting, 1922.

Much more practice resulted in a marked improvement in the Shooting. The Competition was decided at 25 yards range. The members of the House teams averaged as follows, out of a possible 100.

football, 1922=23.

The Football XI lacked a player of the class of Bamford or Crozier, and the results were disappointing. However, if the defence was not always sound, the forwards showed far more thrustfulness in attack than was seen in the elevens of 1920 and 1921. They scored 30 goals in School matches as compared with 14 in 1921-22.

The victories were against Hutton Grammar School, and The Old Boys.

Two matches were drawn—Blackpool Secondary School and Baines Grammar School—whilst defeats were inflicted by Arnold House (4), Blackpool Secondary School (3), Baines Grammar School (1), Preston Grammar School (2), and Hutton Grammar School (1). 34 goals were scored against 75. The eleven were unfortunate in being without their captain and goalkeeper (Robson) through knee injury throughout the greater part of the season.

The House Shield was won by the Fylde House, and the Junior Football Cup was retained by the Kirkham House.

Prize Day, 1922.

The Annual Prize Day took place on July 26th, in the Assembly Hall of the School. The weather was not kindly but the Hall was filled with a representative gathering. The Chairman of the Governors (the Rev. W. T. Mitton) presided, and supporting him on the platform, were the Rev. C. Fullerton Smith, the Rev. R. W. M. Holme. the Headmaster, and Lord Stanley, who distributed the prizes.

The Chairman expressed his pleasure in the fact that Lord Stanley was with them to present the prizes.

The Headmaster, in his annual report on the working and progress of the School, said that he felt he could speak with even more confidence than usual, because the work of the School had undergone a thorough inspection by the Board of Education. The previous occasion of an Inspection was in 1911, when H.M. Inspectors found a school of 64 Boys: this time they had found 178. The result of the Report received from the Board of Education was such as to justify and increase the pride they felt in their School. Things had been done which had never been done before—for the first

time a boy had gained the Higher Certificate, and for the first time a boy in the fifth form had passed the Senior Cambridge Local—in fact 9 passed. These things pointed to success in raising the standard of attainment. The sixth form were doing distinctly advanced work, beyond the standard of University matriculation.

The Headmaster went on to emphasise the necessity of boys staying at school until they were 16 if sound results were to be obtained from Secondary Education. He alluded to the good work being done by the Agricultural Class, and expressed his regret that Mr. Harding was leaving the School after the good work he had done with that Class, and the way he had identified himself with all the school interests. His place would be taken by Mr. B. Stevenson, of the Harper Adams Agricultural College, who held the National Diploma of Agriculture, and possessed practical knowledge of farming.

Examination successes of the year comprised one Higher Certificate, two Matriculation, nine Cambridge Senior Local, one Open Scholarship in Science to Manchester University, one Public School Scholarship, and two boys had passed the Public Schools entrance examination. In the field of Sport—Cricket, Football, Swimming, Shooting, and Athletic Sports,—a fair measure of success had been achieved. They recognised the importance of these things in training the sound Englishman, and their sports were marked by good sportsmanship and the spirit which plays for the side and not for self.

He referred to the two Memorials which had been completed and dedicated during the year,—to the late Headmaster, and to the Old Boys of the School who had given their lives in the War.

After alluding to the growth and value of the Old Boys' Association, the Headmaster mentioned some of the

successes achieved recently by Old Boys, and referred to the loss the school was about to suffer by the departure of tried leaders—H. Tomlinson, T. Maxwell, and A. Bamford. In conclusion Mr. Strange paid a tribute to the immense share that was contributed to the welfare and success of the school by Mrs. Strange, The Governors, and his colleagues.

Lord Stanley presented the prizes, and remarked on the value of education, especially as enabling British citizens to understand intelligently the greatness of their inheritance. Lord Stanley also expressed his desire to present a Silver Challenge Cup for competition amongst the Houses at Cricket.

Annual Meeting and Dinner, 1922.

The Annual Meeting and Dinner were held at the School on November 22nd.

The Minutes of the previous meeting and the Balance Sheet for the year were read and approved.

The Accounts of the War Memorial Fund were read, approved, and closed.

The Committee for the ensuing year was elected, viz.:—The President, the Hon. Secretary and Treasurer, Messrs. A. V. Catterall, T. V. Goodier, H. Parkinson, and R. S. Crozier.

A hearty vote of thanks and appreciation was recorded to Mr. J. H. Rigby, for his valuable services as Hon. Secretary and Treasurer, and he was unanimously re-elected.

An interesting discussion took place on the subject of the amount of the subscription for life membership, and on the proposal of Mr. A. V. Catterall, seconded by Mr. C. A. Plant, it was resolved that the subscription to secure life membership of the Association be $\pounds 4$.

Subsequently a representative gathering of 60 members sat down to dinner in the school dining hall. After the loyal toast had been honoured, the toasts of the School, the Old Boys' Association, the Governors, Masters (Past and Present), and Absent Friends, were given and responded to. Many letters and messages from members who were unable to be present, were read. The Entertainment provided by Messrs. J. Kirkham, and R. Grant, of Preston, was much enjoyed, as were also Mr. Budden's Violin Solos, and a Recitation by Mr. J. H. Crook.

Whist Drive.

On January 3rd, a successful Whist Drive was held in the School Assembly Hall. The guests numbered 48, and a

Correspondence.

To the Editor of the K.G.S. Chronicle,

DEAR SIR,—I take the opportunity afforded me in your columns, of suggesting that it would be beneficial to the School to take up Rugby Football instead of Association. I should like to state briefly my reasons for this change.

- (1) Rugby is a game better fitted than Association for developing the spirit of true sportsmanship and that team spirit for which our English schools are so justly famed.
- (2) A boy when leaving has a better opportunity of continuing his Football if he has played Rugger at school, inasmuch as there are in the near district three well-known Rugger Clubs open to receive young players, viz.:—Preston "Grasshoppers," The Fylde, and Blackburn. Similar Clubs to these are lacking in Association Football.
- (3) As a Rugby game requires fifteen a side, less space would be needed in proportion to the number of players, which would be a great help in arranging the school games.

These are only three of my reasons which (were space available) I could advance for the advisability of the change from Soccer to Rugger, which change, I am sure, would receive whole-hearted support from all quarters.

The innovation could be brought about in one of the football terms, and though at first, through inexperience, the School would have to submit to some defeats, I feel sure that in the second season they would be most successful.

From what I have seen of the boys, they are well up to the average in height and weight, and there should be no fears on this point.

Though it may seem irrevelant, I should like to mention that I took up "Rugger" after leaving the School (where of course I played "Soccer") and such is the fascination it has exercised on me, that in future it is the ONLY game for me!

In closing I beg to point out that while a great number of "Soccer" players take up "Rugger," there are few, if any, cases of "Rugger" players turning to "Soccer."


