Dear Parent/ Neighbour/ Student,

Consultation regarding the proposed expansion to Little Ilford School

The London Borough of Newham (LBN) has experienced rapid population growth over the last ten years. Regular reviews of pupil numbers have ensured that the Council has been able to meet its statutory duty to provide sufficient school places. Demand for secondary school places within Newham is forecasted to increase over the coming years.

A number of Newham Secondary Schools have been assessed for expansion feasibility. Little Ilford has been identified as having the capacity and infrastructure to support the new accommodation which would be required for a two-form entry expansion (300 pupils).

We are an award-winning RIBA Chartered Architectural Practice who are working on behalf of the Council to develop the expansion scheme.

As you may already be aware, we have recently secured planning approval for a new entrance pavilion on Rectory Road and a small special educational needs hub to the north of the site.

We are now consulting on a new classroom block on the south west corner of the school site. The building will contain new teaching rooms for humanities and languages. The design has been developed to maximise offsite modular construction to reduce on-site time and the potential for disruption.

We would like to hear your views on the proposals.
