- I am aware that I have only one chance to resubmit work, if I am given permission.

- I am aware that the assignments and tasks provide the evidence for me to be awarded the appropriate BTEC grade.
- I am aware that the BTEC staff will use A.F.L Assessment for Learning. My work will be crossed marked by staff and also sampled and seen by a Lead Internal Verifier and Internal Verifier.
- I will always cooperate with my BTEC teachers and my BTEC peers.
- I am aware that my work is graded and moderated fairly by all Longdendale practitioners. My work could be selected and sent away

for scrutiny to an SV who will check my work to ensure it is given the correct grade and procedures at school are correct for each BTEC course.

 me about my progress.

- I accept my BTEC teachers will provide me with instructions, advice and the necessary guidance to help me successfully pass the BTEC course.
