

Dear Parent/Carer

RE: Access to digital devices at home

The government has requested that we have plans in place for the possibility of further local restrictions as a result of a potential increase in Covid-19 infection rates. These plans will ensure the continuity of education for your child, with the key aim being to retain as much face-to-face education as possible.

We have been advised by the Department for Education that that these plans will only be adopted where it is necessary and safe to do so, and is primarily a means of reducing risks for the wider community even further by limiting contacts and breaking transmission chains in secondary schools. The decision to implement these plans will be made by Government and not school.

In the event we receive the instruction from the government to restrict numbers of learners in school, we will operate a two week rota system. Full-time on-site provision will remain available for all vulnerable children and for the children of critical workers who require this.

A rota system will limit the number of learners on-site at any one time. We are planning to operate a rota system that means learners spend two weeks on-site followed by two weeks at home. There will be remote learning expectations for learners who are on the home learning phase of the rota system. This time at home will then allow for the onset of symptoms to be detected before returning to school.

If during the home phase of the two week rota you would like school to provide your child will a packed lunch, please could you indicate your preference using the form attached, or if you'd prefer, using the digital form by clicking on the link provided.


