Year Ended 31st August 2022

The trustees present their annual report together with the financial statements and auditor's report of the charitable company for the period from the 1st September 2021 to the 31st August 2022. The annual report serves the purposes of both a trustees' report, and a directors' report including a strategic report under company law.

The trust operates an academy for students aged 11 to 16 serving a general priority area mainly in the South Ribble District Council of Lancashire.

Structure, Governance and Management

1.1 Constitution

The Academy Trust is a company limited by guarantee and an exempt charity. The charitable company's Memorandum and Articles of Association are the primary governing documents of the Academy Trust. The trustees of Lostock Hall Academy Trust are also the directors of the charitable company for the purposes of company law. The charitable company is known as Lostock Hall Academy Trust.

Details of the trustees who served throughout the year except as noted are included in the Reference and Administrative Details on page 2.

1.2 Members' Liability

Each Member of the charitable company undertakes to contribute to the assets of the charitable company in the event of it being wound up while they are a Member, or within one year after they cease to be a Member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they ceased to be a Member.

1.3 Trustees' Indemnities

The Academy has purchased indemnity insurance to protect governors and officers from claims arising in connection with Academy business. The insurance provides cover of up to £10,000,000 on any one claim (note 10).

1.4 Method of Recruitment and Appointment or Election of Trustees

The trustees are appointed by the following:

No more than one third of the trustees may be employees of the Academy.

1.5 Policies and Procedures Adopted for the Induction and Training of Trustees.

Induction and ongoing training are provided by Lancashire County Council Governor Training and Development Service. The trustees also have access to online training provided by the NGA Learning Link.

1.6 Organisational Structure

The Academy is governed by its Trust Board, whose members are directors of the charitable company for the purposes of the Companies Act 2006 and trustees for the purposes of charity legislation. The organisational structure of the Academy consists of 4 levels: The Trust Members, the Trust Board, the Principal, and the Senior Leadership Team (SLT).

Objectives and Activities

2.1 Objects and Aims

Lostock Hall Academy Trust was set up on the 1st August 2011. Its principal objective is the operation of Lostock Hall Academy (LHA) which is a non-selective community school, providing education for 11-16 year olds of different abilities, mainly in the South Ribble District Council area of Lancashire. Students are drawn from the general priority area, in accordance with the Academy's admissions criteria. Prior to conversion LHA was a Specialist Arts, Maths and Computing College.

The principal objectives of LHA are: -

- To conduct its business to the highest possible standards, integrity, and openness.
- To comply with all statutory legislation and curriculum requirements.
- To ensure that every student, regardless of age, gender, ethnicity, disability, or social background, achieves the best possible outcomes.
- To improve its overall effectiveness by continuous self-evaluation and improvement.
- To provide value for money.
- To maintain and build on the close links with the local community and business.
- LHA aims to provide an outstanding education for all its students in a caring, supporting environment. We aim to achieve this by providing: -
- Well-planned learning opportunities for all students, in order that they achieve in line with or exceed expectations in Key Stages 3 and 4.
- A broad, balanced, and personalised curriculum that is fully inclusive and meets the social and academic needs of all our students.
- Our students with the knowledge, tolerance, and skills necessary for them to succeed in and contribute to life in modern Britain, equipping them for life beyond Lostock Hall Academy, to the next phase of their education or training.
- An extensive programme of extra-curricular activities to enhance the taught curriculum provided.
- Professional development opportunities for all staff, including succession planning, targeted support, and annual appraisals, in order that high standards are maintained.
- Activities available to all students to enhance and improve their leadership and support of others.
- Appropriate cross-phase (primary and tertiary) transition learning and activities.

3. Achievements and Performance

3.1 Post Pandemic Return

The ongoing pandemic resulted in the key focus, like the previous year, being on the safe and secure return for all staff and students in September 2021. Ahead of the return to school, the Senior Leadership Team (SLT) updated the whole school risk assessment and maintained COVID specific protocols for staff and students to follow in order to make the site as secure as possible. This included the continuation of a one-way system throughout the school, external queuing points for each classroom/teaching area, staggered break and lunchtime entry to the canteen area, staggered end of day finish times.

The wearing of masks during transition times and in lessons once again became mandatory (for all staff and students other than those who were exempt) until the Government guidance removed this (April 2022). Alongside this the school continued to develop the provision for high quality online learning with the aim of this being to support students who were absent from school at any point and to have a system in place in case there were any periods of school closure during the 2021/22 academic year. While there were no periods of school closure, the levels of student and staff absence was the highest recorded since becoming an Academy.

To support the return to school a testing site was once again set up and operated in the gymnasium area. All students who provided consent (95%+), tested twice over the first six days back onsite. All results were uploaded to the NHS Government website. Following this period, a smaller onsite testing facility was maintained which was used to test students who were displaying COVID symptoms. Home testing kits were also distributed to staff and students at regular intervals until the Government announced the gradual removal of measures put in place during the pandemic (January-April 2022). This included no longer recommending regular testing for students and staff without symptoms and removing the legal requirement for people to isolate following a positive test (including students and all staff in mainstream education).

The focus then moved to liaising/coordinating with the NHS to come onsite and offer vaccinations to students (this also entailed the issue/collection of permissions for students to receive the vaccine). An NHS vaccination team came onsite on two separate days to administer first and second vaccinations. Budgeting continued to be a priority area subject to ongoing review as the Academy strives to improve further, taking into account increased expenditure linked to ongoing COVID protocols, including enhanced cleaning and staff cover cost over the last two and a half years.

During the periods of national Public Health concerns the academy continued to keep in contact with its academy and wider community sharing good news stories and supporting the communication of important Public Health England messages through the academy newsletter and social media updates.

3.2 Key Performance Indicators

The Academy monitors its performance on the examination results and Ofsted reports it receives. The Academy operates in line with the requirements of its Funding Agreement with the Education Skills Funding Agency (ESFA) and manages its reserves in line with the policies set out below.

GCSE Results 2022

2022 has proved to be another very successful year for the students of Lostock Hall Academy. This year's round of GCSE results have proven that Lostock Hall Academy is above national in almost all aspects, despite national and local challenges.

The core subjects of English and Maths are considerably above national with over 89% of Lostock Hall Academy students achieving a grade 4 and above in English and 82% achieving a grade 4 and above in Maths.

Key Headline Data 2022

Given the uneven impact of the pandemic on school and college performance data, the government has said there should be no direct comparisons between the performance data for one school or college and another, or to data from previous years.

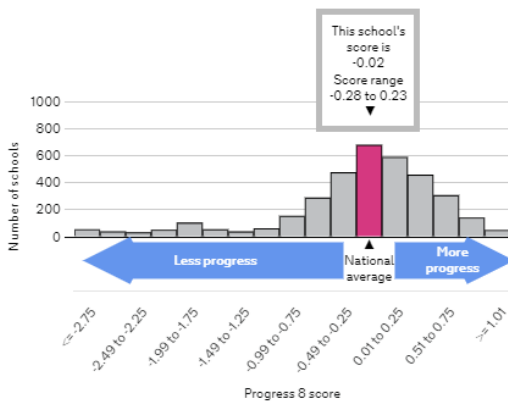

Headline Trends

The average score for all state-funded schools in England is -0.03

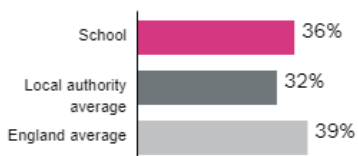
Attainment 8 = 52.31 (better than National and LA)

A pupil is considered to have entered for the English Baccalaureate if they entered for qualifications in English, maths, sciences, a language and either history or geography.



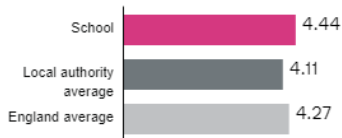

3.3 Review of external provision for our *most able* students

Over the course of the 2021-22 academic year offsite visits for more able students were gradually reintroduced (no visits were able to take place during the previous academic year due to the pandemic). Year 10 students attended two separate events at Runshaw College (Business Studies 'Ethics Challenge' and the 'Full English' event) as part of their 'Horizons' programme. Ten students from Year 9 also attended an 'Oxbridge' event at Runshaw, completing activities aimed to develop ways of '*academic discourse*'. It starts the process of helping students to be well prepared for the rules of thinking, valuing and discussion which are essential skills to do well in the interviews at prestigious universities. Thirty students from Year 10 visited the Young Scientist centre at UCLAN, taking part in 'Waves' based experiments. It is hoped that this is a partnership that can be further developed in the 2022-23 academic year in order to continue to raise the aspirations for students at the Academy to study STEM subjects at College level and beyond.

The Academy continues to be the nominated lead school for the Endeavour Learning Trust '*Able and Ambitious*' working group (SS chair)/group meets once a half-term with minutes/resources submitted/shared with the Endeavour Learning Trust CPD group. This group is designed to review provision for *more able* students and share resources/new approaches to teaching and learning for *more able* students. Ten students from Year 9 were also given the opportunity to attend a 'Mini-Masters' event at Ormskirk School, engaging in a wide range of sessions designed to challenge and inspire.

3.4 Student Leadership and Wellbeing at Lostock Hall Academy

There was increased focus on supporting the wellbeing of all students over the 2021-22 academic year as the impact of the pandemic continued. Funding was secured from the Department of Education (DfE) to provide training for the senior mental health lead (member of the SLT) at the Academy which aimed to provide the knowledge and skills to develop an effective whole school approach to well-being. Staff (teaching and support) across the Academy work together to identify and support students who display signs of stress/duress, often working with external agencies to provide specialist input. The Relationships, Health and Sex Education (RHSE) curriculum, along with the Life Studies/Personal Development curriculum has been further developed to include dedicated mental wellbeing modules. Dedicated mental first training has also been scheduled in for staff at the Academy (2022-23 academic year) along with a 'wellbeing ambassador' programme (peer led early intervention programme) for students.

The development of leadership skills through PE lessons continued to be a focus with the pandemic providing additional challenges to practical subjects. Students took a more active role in terms of helping to set up lessons and taking a more active role within. Working alongside the South Ribble 'Active Health' team, students also completed internal leadership training and then helped to organise a number of primary school events which took place onsite at the Academy. Events were scheduled at different points of the academic year and included (a) football and netball central venue leagues, (b) indoor athletics district events and finals, (c) inclusion events, (d) dodgeball competitions and (e) an outdoor athletics competition. Students from Year 8 and 9 were present at every event helping to organise and officiate.

3.5 Extra-curricular sports provision

The 2021-22 academic year brought the return of inter-school sport with fixtures and competitions between school recommencing. While a small number of events had to be rescheduled due to outbreaks of COVID, the majority of events ran successfully (PE staff at the Academy are responsible for organising a number of these events within the District/SS is chairman of the South Ribble schools PE association). The Academy also provided access to the facilities (football pitches) to the South Ribble District football teams which gave them more opportunity to fulfil evening/weekend fixtures. The PE Department/Academy also achieved the School Games 'Gold' standard, based on the excellent level of provision for PE and School Sport offered across each term.

3.6 Type B Visits (LCC approved)

Thankfully this year following the worse of the pandemic it was possible to deliver a school visits programme this year. The academy and visits leaders worked cautiously to ensure any trips undertaken were done so in accordance with risk assessments considering student and staff safety and financial liability.

After such an impactful 2 years on the lives of our young people it was wonderful to be able once again to provide opportunities for students to visit museums, art galleries, theatres, field trips, outdoor adventure visits, visits to Further Education institutions as well as 2 overseas visits. The wide variety of visits allowed all year groups to access and all students had the opportunity to attend a rewards visit to Blackpool Pleasure Beach at the end of the academic year.

3.7 ICT Strategy

Building on the experiences from home learning the academy reviewed and focussed on ICT development, and as a result has seen a number of significant developments regarding student and staff use of ICT. These are detailed below:

- Year 7 students are now equipped with laptops in lessons as part of our device scheme
- Students have received initial training on how to use the Microsoft software on their devices
- There has been an audit of staff training need regarding incorporating technology in the classroom to enhance learning
- A staff member has been appointed to support the delivery of 'broad brushstroke' training for staff
- Bespoke training for subject teams was undertaken
- Protocol has been established for staff wanting to adopt new online programmes.

3.8 SEND Update

In the wake of the government's national review of SEND (Green Paper: Right support, right place, right time), the Academy has continued to strengthen its provision for SEND students. SEND provision and student progress will continue to be a strategic priority for the Academy 2022/23, to ensure that we meet the new national intent for SEND students. The intent for secondary schools regarding SEND can be summarised as follows.

- Early, robust identification of need
- A standardised and digitalised Education and Health Care Plan process (EHCP)
- High-quality teaching and learning
- Prompt access to targeted support
- Improved teacher training and development
- Use of a 'what works' evidence programme
- Sharing of best practice amongst schools
- Improved transition into further education through a shared digital system
- Accountability at every level
- Better use of data within SEND systems
- Greater access to alternative provision

The success criteria above will form the framework for next year's SEND development plan.

3.9 Queen's Jubilee

This year marked 70 years' reign for Queen Elizabeth and the academy marked it with a 'street party' style celebration lunch for all students. The students of the academy planted trees to support the Queen's Green Canopy project and the students made and decorated clay tiles with themes from the Commonwealth; history, environment, wildlife, famous landmarks and British identity. The tiles will form part of our Jubilee Garden of Hope that is planned for construction next year to provide a quieter wellbeing space for both students and staff.

4. Financial Review

4.1 Operating and Financial Review

The School's total incoming resources during the year were £4,625,000.

Most of the School's income derives from central government funding via the Education Skills Funding Agency (ESFA), in the form of current grants. Total funding received for the School's educational operations from the ESFA/DfE, in the year was £3,859,000 and further details are provided in note 3 to the accounts.

Total outgoing resources for the year were £4,137,000 the majority of which related to the direct provision of educational operations.

At the year end the Academy's total reserves were £8,073,000 including unrestricted funds of £257,000 and restricted funds of £7,816,000. Restricted funds include fixed assets of £7,362,000, less the LGPS scheme deficit of £183,000. The remaining balance on restricted funds of £637,000 relates to funding received in the year which is due to be spent in 2021/22 in accordance with the terms of funding. Further detail is provided in note 16.

Total restricted general funds and unrestricted funds amounted to £894,000 at 31st August 2022.

At the 31st August 2022 all assets shown in the accounts were used exclusively for providing education and associated support services to students of the Academy.

4.2 Reserves Policy

Restricted GAG reserves - The Trustees have considered the level of GAG reserves which they believe will provide sufficient working capital to cover delays between the spending and receipt of grants and unexpected or planned future revenue and capital costs. The Trustees believe that, under normal circumstances, the appropriate level of GAG reserve should be between 2% and 10% of GAG income and aim to keep the reserve within these parameters.

At the 31st August 2022, the school held GAG reserves of £620,000.

Unrestricted reserves - In addition to the GAG reserve, which can only be utilised for the restricted purposes set out in the Funding Agreement, the school holds unrestricted free reserves, which provide additional working capital and are not committed or designated. It is the Trustees' policy to aim to hold approximately 3 months' expenditure in unrestricted reserves, to provide an additional cushion over and above the restricted GAG reserve.

At the 31st August 2022, the level of unrestricted reserves held was £257,000.

4.3 Investment Policy

All investments are agreed by the Trust Board, which has regard to the Charity Commission guidance in relation to charity investment policy. The school does not currently hold any investments other than cash, which is held for its normal operations. The Trust Board has adopted a low-risk strategy to its cash holdings. Surplus cash is held in an instant access deposit account to ensure that there is always access to sufficient cash to meet short and medium term requirements.

4.4 Principal Risks and Uncertainties

The trustees have considered the principal risks and uncertainties that the Academy may be exposed to. A risk register has been completed and appropriate procedures put in place to mitigate the risks. A critical incident plan is also in place.

The trustees have assessed the major risks to which the Academy is exposed, those relating to teaching, public profile, health and safety, school educational visits, child protection, finances, staffing issues, and trustees. These risks are reviewed on an annual basis by the board of trustees and the Senior Leadership Team.

The internal financial systems are based on the Academies Handbook and are documented in the financial procedures. The systems are based on a framework of segregation of duties and schemes of delegation which include authorisation and approval. Financial management information is provided to the Trustees monthly and is reviewed on a termly basis or more.

7.1 Scope of Responsibility

As trustees, we acknowledge we have overall responsibility for ensuring that Lostock Hall Academy Trust has an effective and appropriate system of control, financial and otherwise. However such a system is designed to manage rather than eliminate the risk of failure to achieve business objectives, and can provide only reasonable and not absolute assurance against material misstatement or loss.

As trustees, we have reviewed and taken account of the guidance in DfE's Governance Handbook and competency framework for governance.

The Board of Trustees has delegated the day-to-day responsibility to the Principal, as Accounting Officer, for ensuring financial controls conform with the requirements of both propriety and good financial management and in accordance with the requirements and responsibilities assigned to it in the funding agreement between Lostock Hall Academy Trust and the Secretary of State for Education. They are also responsible for reporting to the Board of Trustees any material weaknesses or breakdowns in internal control.

7.2 Governance

The information on governance included here supplements that described in the Trustees' Report and in the Statement of Trustees' Responsibilities. The Trust Board has formally met 9 times during the year. An emergency structure of governor meetings was implemented during the national lockdown. This allowed the Chairs Group to represent all governors at virtual on-line meetings. Allocated time for questions from all governors based on information provided before the meeting was put in place.

The Finance, Risk and Staff Welfare Committee is a sub-committee of the main Board of Trustees. Its purpose is to monitor the finances of the school and manage resources and risk.

The Academic Achievement & Student Welfare Committee is a sub-committee of the main governing body. Its purpose is to review and update the curriculum and monitor progress and achievement.

7.3 Review of Value for Money

As Accounting Officer the Principal has responsibility for ensuring that the Academy Trust delivers good value in the use of public resources. The Accounting Officer understands that value for money refers to the educational and wider societal outcomes achieved in return for the taxpayer resources received.

The Accounting Officer considers how the Academy Trust's use of its resources has provided good value for money during each academic year, and reports to the Board of Trustees where value for money can be improved, including the use of benchmarking data where available. The Accounting Officer for the Academy Trust has delivered improved value for money during the year by:

Improving educational results:

Improving educational results for our students remains our key purpose and focus. We have ensured that resources are directed where they are most needed and most effective in improving outcomes for all our students. Our success in doing this is reflected in three consecutive years of improved attainment and progress.

- We regularly review our staffing structure to ensure that staff are deployed efficiently. Staff are appropriately qualified and experienced specialists in their curriculum area.
- The school's appraisal system and the monitoring of teaching and learning identify weaknesses in teaching. These weaknesses are swiftly dealt with through the school's capability procedures.
- Our curriculum model is reviewed each year to ensure that it meets the needs of all students. The size and number of teaching groups is adapted to reflect the size of the school population.
- Judicious use of pupil premium funding has led to improved learning for individual students. Gaps in performance between disadvantaged students and their peers have narrowed.
- The needs of students with Special Educational Needs are met by careful management of SEN funding and effective deployment of teaching assistants to curriculum areas.
- The school has invested in packages to support children with literacy difficulties including Reading Plus. These are bringing about rapid improvements in reading for these children.
- We bring in additional teaching staff in English and Maths to deliver 1to1 tuition to students working below Level 4 on entry from KS2. There is a clear impact showing improvement in outcomes for these students.
- We have effective and robust tracking systems in place to record all aspects of pupil progress and to ensure that intervention is specifically targeted at those students in most need.
- The School Development Plan and associated Faculty Development Plans identify priorities for improvement which are directly related to improving outcomes for students. Each action in these plans is carefully budgeted for and departmental capitation reflects these priorities.

Financial governance and oversight:

The Board of Trustees approve the annual budget following confirmation of the levels of income from the ESFA. The Chairs' Committee members receive monthly financial reports prepared by the Director of Business and Finance and questions raised thereon are dealt with at the termly meetings as recorded in the minutes. The Trustees are informed of all actions at the full Trust Board meetings.

Better purchasing:

Examples of steps taken to ensure value for money when purchasing include:

Economies of scale / fitness for purpose and benchmarking all included in examples below:

- Membership of the Crescent Purchasing Consortium enabling access to discounts on many goods and services as well as access to assistance re tendering processes for e.g., Academy insurance.
- Membership of the Crown Commercial Service supported by the Department for Education.
- Information gathered from other academy colleagues regarding suppliers and services contracted by them.
- Energy costs secured through a broker at discounted rates for educational establishments.

All efforts are made to ensure that all goods and services are secured in the most economic, efficient, and effective way.

Better income generation:

- The academy has taken responsibility for the lettings in-house using academy staff during this fluctuating period but continue to look for alternative solutions. All income generated therefrom is continually monitored to ensure all costs associated with this operation are met from the income generated. New ways to increase the income stream are also considered on an on-going basis. The academy are also intending to upgrade its dilapidated external sports facilities in the next academic year. It is anticipated that as well as providing better facilities for the academy to deliver the curriculum to students it will provide opportunity for the local community

to access sports facilities close to home, which also supports the local district council agenda to improve activity and access to facilities for local people.

Reviewing controls and managing risks:

- The academy uses the HCSS budgeting and accounting system to process all its financial activities. This system has built in checks, set by the Director of Business & Finance to ensure capitation spend does not exceed that set within the budget and different levels of authorisation of documentation are set.
- Each departmental head is issued with monthly financial reports to ensure they are aware of spending within their departments.
- The Internal Financial regulations describe the procedures in place for the separation of duties on the finance front.
- The academy has taken out full and comprehensive insurance cover through Zurich Insurance.
- A risk register has been developed and is updated on an annual basis.
- HR services are purchased through an educational HR legal company.

Future Objectives:

We recognise the need to annually review the curriculum and staffing levels considering varying roll numbers and associated increases in staffing and other operational costs.

7.4 The Purpose of the System of Internal Control

The system of internal control is designed to manage risk to a reasonable level rather than to eliminate all risk of failure to achieve policies, aims and objectives. It can, therefore, only provide reasonable and not absolute assurance of effectiveness. The system of internal control is based on an ongoing process designed to identify and prioritise the risks to the achievement of the Academy Trust's policies, aims and objectives, to evaluate the likelihood of those risks being realised and the impact should they be realised, and to manage them efficiently, effectively and economically. The system of internal control has been in place in Lostock Hall Academy Trust for the year ended 31st August 2022 and up to the date of approval of the annual report and financial statements.

7.5 Capacity to Handle Risk

The Board of Trustees has reviewed the key risks to which the Academy Trust is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks. The Board of Trustees is of the view that there is a formal on-going process for identifying, evaluating and managing the Academy Trust's significant risks that has been in place for the year ended 31st August 2022 and up to the date of approval of the annual report and financial statements. This process is regularly reviewed by the Board of Trustees.

The Board of Trustees have considered the impact of COVID-19 on the financial statement. Ongoing costs for the coming year associated with additional staffing cover and necessary equipment to support learners who may be required to isolate from home are being closely monitored and additional provision has been made in the 2022/23 budget. However, the magnitude of the cost of impact is indeterminate and the Board of Trustees will continue to assess the risk to the academy and likely impact on the academy trust's level of reserves. The Board of Trustees have also identified that the academy's ability to generate income through lettings will be more viable since the lifting of participation restrictions.

7.6 The Risk and Control Framework

The Academy Trust's system of internal control is based on a framework of regular management information and administrative procedures including the segregation of duties and a system of delegation and accountability. In particular, it includes:

- comprehensive budgeting and monitoring systems with an annual budget and periodic financial reports which are reviewed and agreed by the Board of Trustees
- regular reviews by the Finance, Risk and Staff Welfare Committee of reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programmes

- setting targets to measure financial and other performance
- clearly defined purchasing (asset purchase or capital investment) guidelines
- identification and management of risks.

The Board of Trustees have considered the need for a specific internal audit function in accordance with the Academies Handbook and have appointed an internal auditor, SBM Services to perform additional checks for a second year.

The reviewer's role includes giving advice on financial matters and performing a range of checks on the academy's financial systems. The checks carried out in the current period include:

- Income and debtors
- Cash and Bank
- VAT

CWR Chartered Accountants reported to the Board twice during the year on the operation of systems of control. No material control issues were identified because of this work.

7.7 Review of Effectiveness

Ofsted carried out a full section 8 inspection January 2018 and Lostock Hall Academy was judged as "good" overall. Ofsted says that "determined leadership has ensured that the academy has successfully tackled under-performance." Governors were identified as "key partners" in the improvement of the academy with clear systems in place to hold all to account for outcomes. Policy is now consistently followed, and Governance greatly improved.

During an unprecedented year where students returned to school for the first full year of teaching following the disruption of the pandemic Pupil Premium students have underperformed in comparison to other students but have improved generally in comparison to previous years. The school has used resources effectively to enhance the progress of disadvantaged students, and the Trust are pleased to report that the gap has narrowed, demonstrating effective use of resources and the focus given to the Covid Catch Up Strategy and School Led Tutoring initiatives.

As Accounting Officer, the Principal has responsibility for reviewing the effectiveness of the system of internal control. During the year in question the review has been informed by:

- the Board;
- the Responsible Officer
- external audit;
- the work of the Chairs Committee within the academy trust who have responsibility for the development and maintenance of the internal control framework

The Accounting Officer has been advised of the implications of the result of their review of the system of internal control by the Finance, Risk and Staff Welfare Committee and a plan to address weaknesses and ensure continuous improvement of the system is in place.

1 Accounting policies

General information and basis of preparation

Lostock Hall Academy Trust is a company limited by guarantee incorporated in England. The address of the registered office is given in the Reference and Administrative Details given on page 2 of these financial statements and the principal place of business is Todd Lane North, Lostock Hall, Preston, PR5 5UR. The nature of the Academy Trusts operations and principal activities are set out in the Trustees' Report on page 4.

The financial statements of the Academy Trust, which is a public benefit entity under FRS 102, have been prepared under the historical cost convention in accordance with the Financial Reporting Standard Applicable in the UK and Republic of Ireland (FRS 102), the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102) 2019), the Academies Accounts Direction 2021 to 2022 issued by ESFA, the Charities Act 2011 and the Companies Act 2006.

A summary of the principal accounting policies adopted (which have been applied consistently, except where noted), judgements and key sources of estimation uncertainty, is set out below.

Going concern

The trustees assess whether the use of going concern is appropriate i.e. whether there are any material uncertainties related to events or conditions that may cast significant doubt on the ability of the Academy Trust to continue as a going concern. The trustees make this assessment in respect of a period of one year from the date of authorisation for issue of the financial statements and have concluded that the Academy Trust has adequate resources to continue in operational existence for the foreseeable future and there are no material uncertainties about the Academy Trust's ability to continue as a going concern, thus they continue to adopt the going concern basis of accounting in preparing the financial statements.

Income

All incoming resources are recognised when the Academy Trust has entitlement to the funds, the receipt is probable and the amount can be measured reliably.

- **Grants receivable**

Grants are included in the Statement of Financial Activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the balance sheet. Where income is received in advance of meeting any performance-related conditions there is not unconditional entitlement to the income and its recognition is deferred and included in creditors as deferred income until the performance-related conditions are met. Where entitlement occurs before income is received, the income is accrued.

General Annual Grant is recognised in full in the Statement of Financial Activities in the period for which it is receivable and any abatement in respect of the period is deducted from income and recognised as a liability.

Capital grants are recognised when there is an unconditional entitlement to the grant. Unspent amounts of capital grant are reflected in the balance in the restricted fixed asset fund. Capital grants are recognised when there is entitlement and are not deferred over the life of the asset on which they are expended.

Income (continued)

- **Donations**

Donations are recognised on a receivable basis (where there are no performance-related conditions) where the receipt is probable and the amount can be reliably measured.

- **Other income**

Other income, including the hire of facilities, is recognised in the period it is receivable and to the extent the Academy Trust has provided goods or services.

- **Donated goods, facilities and services**

Goods donated for resale are included at fair value, being the expected proceeds from sale less the expected costs of sale. If it is practical to assess the fair value at receipt, it is recognised in stock and "Income from other trading activities". Upon sale, the value of the stock is charged against "Income from other trading activities" and the proceeds are recognised as "Income from other trading activities". Where it is impractical to fair value the items due to the volume of low value items they are not recognised in the financial statements until they are sold. This income is recognised within "Income from other trading activities".

Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources.

Expenditure (continued)

- **Expenditure on raising funds**

This includes all expenditure incurred by the Academy Trust to raise funds for its charitable purposes and includes costs of all fundraising activities events and non-charitable trading.

- **Charitable activities**

These are costs incurred on the Academy Trust's educational operations, including support costs and costs relating to the governance of the Academy Trust apportioned to charitable activities.

All resources expended are inclusive of irrecoverable VAT.

Tangible fixed assets

Assets costing £3,000 or more are capitalised as tangible fixed assets and are carried at cost, net of depreciation and any provision for impairment.

Where tangible fixed assets have been acquired with the aid of specific grants, either from the government or from the private sector, they are included in the Balance Sheet at cost and depreciated over their expected useful economic life. Where there are specific restrictions attached to the funding requiring the continued use of the asset, the related grants are credited to a restricted fixed asset fund in the Statement of Financial Activities and carried forward in the Balance Sheet. Depreciation on the relevant assets is charged directly to the restricted fixed asset fund in the Statement of Financial Activities. Where tangible fixed assets have been acquired with unrestricted funds, depreciation on such assets is charged to the unrestricted fund.

Depreciation is provided on all tangible fixed assets other than freehold land and assets under construction, at rates calculated to write off the cost of each asset on a straight line basis over its expected useful life, as follows:

Leasehold buildings	2% straight line
Fixtures, fittings and equipment	10-25% straight line
Computer equipment	25% straight line
Motor vehicles	20% straight line

Assets in the course of construction are included at cost. Depreciation on these assets is not charged until they are brought into use and reclassified to freehold or leasehold land and buildings.

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Statement of Financial Activities.

Assets on conversion represent the transfer of leasehold assets, initially valued at £4,599,000 per the 2011 ESFA valuation, into the Academy on conversion to academy status in 2011 depreciated over a 50 year period.

Liabilities

Liabilities are recognised when there is an obligation at the balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the Academy Trust anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

Provisions

Provisions are recognised when the Academy Trust has an obligation at the reporting date as a result of a past event which it is probable will result in the transfer of economic benefits and the obligation can be estimated reliably.

Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised within interest payable and similar charges.

Leased assets

Rentals under operating leases are charged on a straight line basis over the lease term.

Financial instruments

The Academy Trust only holds basic financial instruments as defined in FRS 102. The financial assets and financial liabilities of the Academy Trust and their measurement basis are as follows:

Financial assets – trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost as detailed in note 11. Prepayments are not financial instruments.

Financial instruments (continued)

Cash at bank – is classified as a basic financial instrument and is measured at face value.

Financial liabilities – trade creditors, accruals and other creditors are financial instruments, and are measured at amortised cost as detailed in notes 12 and 13. Taxation and social security are not included in the financial instruments disclosure definition. Deferred income is not deemed to be a financial liability, as the cash settlement has already taken place and there is an obligation to deliver services rather than cash or another financial instrument.

Taxation

The Academy Trust is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the Academy Trust is potentially exempt from taxation in respect of income or capital gains received within categories covered by Part 11, Chapter 3 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

Pensions Benefits

Retirement benefits to employees of the Academy Trust are provided by the Teachers' Pension Scheme ('TPS') and the Local Government Pension Scheme ('LGPS'). These are defined benefit schemes.

The TPS is an unfunded scheme and contributions are calculated to spread the cost of pensions over employees' working lives with the Academy Trust in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary based on quadrennial valuations using a prospective unit credit method. TPS is an unfunded multi-employer scheme with no underlying assets to assign between employers. Consequently the TPS is treated as a defined contribution scheme for accounting purposes and the contributions recognised in the period to which they relate.

The LGPS is a funded multi-employer scheme and the assets are held separately from those of the Academy Trust in separate trustee administered funds. Pension scheme assets are measured at fair value and liabilities are measured on an actuarial basis using the projected unit credit method and discounted at a rate equivalent to the current rate of return on a high quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each balance sheet date. The amounts charged to net operating income/(expenditure) are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred. Net interest on the net defined benefit liability is also recognised in the Statement of Financial Activities and comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in other recognised gains and losses.

Actuarial gains and losses are recognised immediately in other recognised gains and losses.

Fund Accounting

Unrestricted income funds represent those resources which may be used towards meeting any of the charitable objects of the Academy Trust at the discretion of the trustees.

Restricted fixed asset funds are resources which are to be applied to specific capital purposes imposed by funders where the asset acquired or created is held for a specific purpose.

Restricted general funds comprise all other restricted funds received with restrictions imposed by the funder/donor and include grants from the Department for Education Group.

Critical accounting estimates and areas of judgement

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Critical accounting estimates and assumptions

The Academy Trust makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

The present value of the Local Government Pension Scheme defined benefit liability depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost (income) for pensions include the discount rate. Any changes in these assumptions, which are disclosed in note 25, will impact the carrying amount of the pension liability. Furthermore, a roll forward approach which projects results from the latest full actuarial valuation performed at 31st March 2016 has been used by the actuary in valuing the pensions liability at 31st August 2022. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension liability.

Local Authority grants represent amounts payable to the Academy predominantly from Lancashire County Council. At the year end the carried forward on these funds was £9,000.

Other restricted funds include monies from educational visits & non-public funds, catering and donations. The donations received are for restricted purposes and as at the year-end £8,000 of the income received in this fund remained unspent.

The pension reserve represents the value of the School's share of the deficit in the Local Government Pension Scheme. The value of the deficit had decreased to £183,000 at the 31st August 2022.

DfE/ESFA capital grants represent capital monies received during the period from the ESFA. The funds received are restricted for specific capital projects and as at the year end £451,000 remained unspent.

Capitalised assets post conversion represents the value of assets purchased since conversion to academy status. These will be depreciated in line with the accounting policies set out in note 1.

Assets on conversion represent the transfer of leasehold assets, initially valued at £4,599,000 per the 2011 ESFA valuation into the Academy on conversion to academy status in 2011 depreciated over a 50 year period.

25 Pension and similar obligations

The Academy Trust's employees belong to two principal pension schemes: the Teachers' Pension Scheme England and Wales (TPS) for academic and related staff, and the Local Government Pension Scheme (LGPS) for non-teaching staff, which is managed by Lancashire County Pension Fund. Both are multi-employer defined-benefit schemes.

The latest actuarial valuation of the TPS was 31st March 2016 and of the LGPS 31st March 2019.

Contributions amounting to £13,376 (2021: £12,156) were payable to the schemes at 31st August 2022 and are included within creditors.

Teachers' Pension Scheme

Introduction

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pension Scheme Regulations 2014. Membership is automatic for full-time teachers in academies and, from 1st January 2007, automatic for teachers in part-time employment following appointment or a change of contract, although they are able to opt out.

The TPS is an unfunded scheme and members contribute on a 'pay as you go' basis – these contributions along with those made by employers are credited to the Exchequer. Retirement and other pension benefits are paid by public funds provided by Parliament.

Valuation of the Teachers' Pension Scheme

The Government Actuary, using normal actuarial principles, conducts a formal actuarial review of the TPS in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 published by HM Treasury every 4 years. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors. The latest actuarial valuation of the TPS was carried out as at 31st March 2016. The valuation report was published by the Department for Education on 5th March 2019. The key elements of the valuation and subsequent consultation are:

- employer contribution rates set at 23.68% of pensionable pay (including a 0.08% administration levy)
- total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £218,100 million and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £196,100 million, giving a notional past service deficit of £22,000 million
- the SCAPE rate, set by HMT, is used to determine the notional investment return. The current SCAPE rate is 2.4% above the rate of CPI. assumed real rate of return is 2.4% in excess of prices and 2% in excess of earnings. The rate of real earnings growth is assumed to be 2.2%. The assumed nominal rate of return including earnings growth is 4.45%.

The next valuation result is due to be implemented from 1st April 2023.

The pension costs paid to TPS in the period amounted to £540,000 (2021: £484,000).

Under the definitions set out in FRS 102, the TPS is an unfunded multi-employer pension scheme. The Academy Trust has accounted for its contributions to the scheme as if it were a defined contribution scheme. The Academy Trust has set out above the information available on the scheme.

Local Government Pension Scheme

The LGPS is a funded defined-benefit scheme, with the assets held in separate trustee-administered funds. The total contribution made for the year ended 31st August 2022 was £168,000 (2021: £153,000), of which employer's contributions totalled £135,000 (2021: £125,000), and employees' contributions totalled £32,000 (2021: £29,000). The agreed contribution rates for future years are 19.10% for employers and the rate for employees remains dependant on the earnings of the employee.

Parliament has agreed, at the request of the Secretary of State for Education, to a guarantee that, in the event of an Academy Trust closure, outstanding Local Government Pension Scheme liabilities would be met by the Department for Education. The guarantee came into force on 18th July 2013.

As described in note 1 the LGPS obligation relates to the employees of the Academy Trust, who were the employees transferred as part of the conversion from the maintained school and new employees who were eligible to, and did, join the Scheme in the period. The obligation in respect of employees who transferred on conversion represents their cumulative service at both the predecessor school and the Academy Trust at the balance sheet date.
