Provider Access Policy Statement

Updated: September 2025

Introduction

This document outlines the arrangements for managing access to students by education and training providers who wish to inform students about their offer. It is in accordance with the school's legal obligations under **Section 42B of the Education Act 1997** and supports the implementation of the **Baker Clause**, ensuring that all students are aware of the full range of post-14, post-16, and post-18 education and training options.

Student Entitlement

All students in **Years 8 to 13** are entitled to:

- Receive information about **technical education qualifications** and **apprenticeship opportunities** as part of the school's careers programme.
- Understand the **full range of education and training options** available at each transition point.
- Be supported in making applications for academic and technical courses, including guidance on where to access further support.

Access Opportunities

The school provides multiple opportunities for providers to engage with students through a structured careers programme. These include:

- **Key Stage 3 (Years 8–9):**
Students have at least two meaningful encounters with Further Education (FE) and technical education providers. Events include careers fairs, assemblies, drop-in sessions, and taster activities. Year 9 students also engage with providers during options and careers events, including parent evenings.
- **Key Stage 4 (Years 10–11):**
Students meet FE colleges and technical providers on at least two occasions. All Year 10 students visit a local FE college or technical provider during the summer term. Providers also contribute to our **Excellence Programme** throughout Year 10.
Year 11 begins with assemblies and follow-up events from local FE and technical providers, as well as workshops from **Amazing Apprenticeships**, including CV writing sessions.
